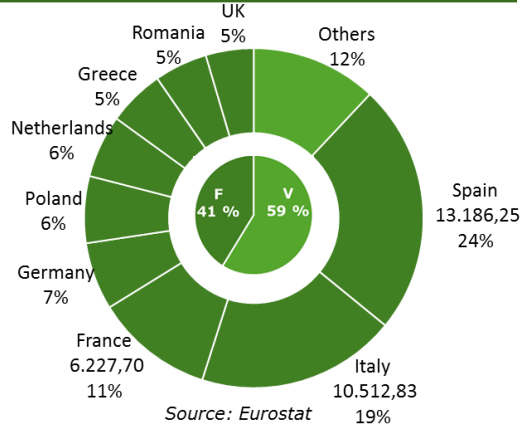

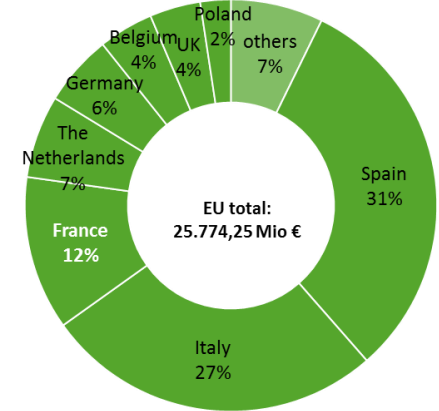

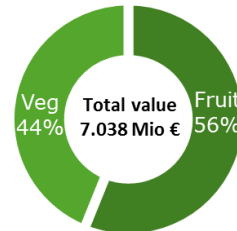
**EU production of F&V in 2016 (55.213 Mio€)
Member States' share**



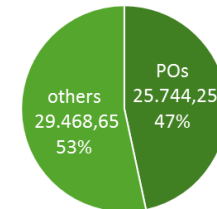
Value of production marketed by the POs in 2016

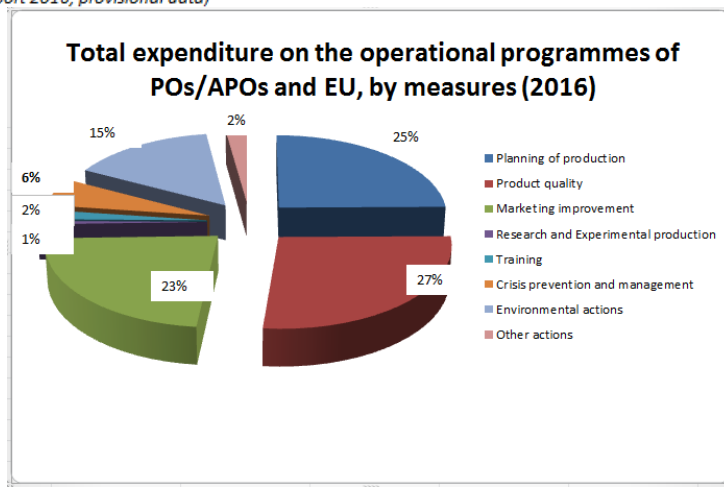

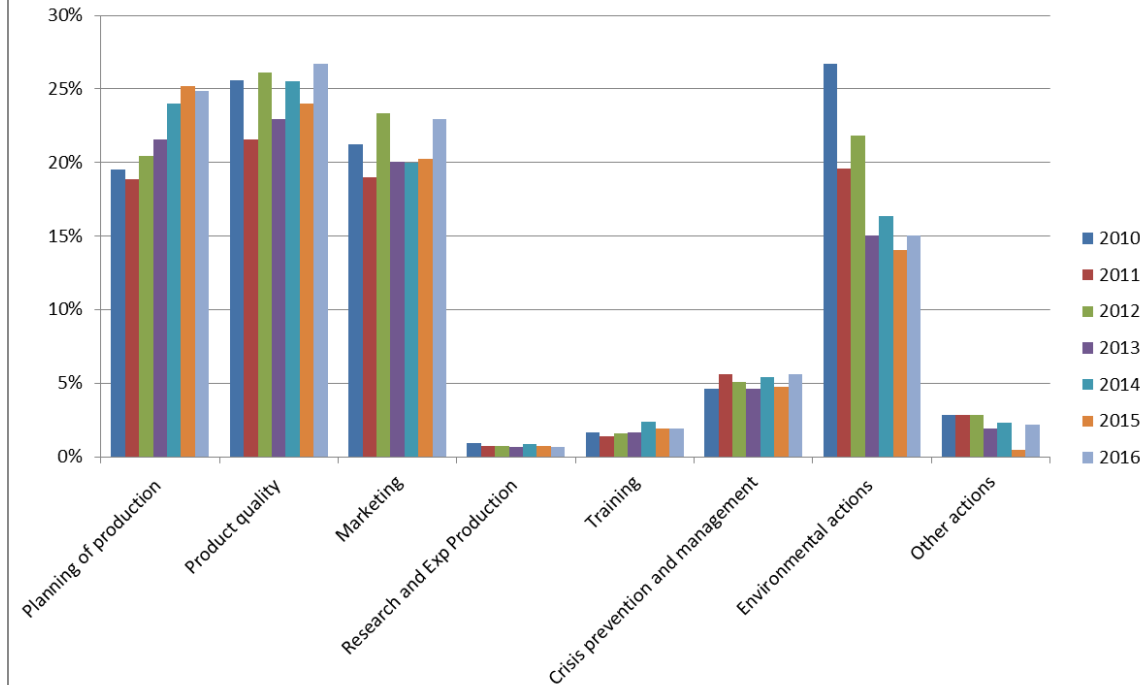

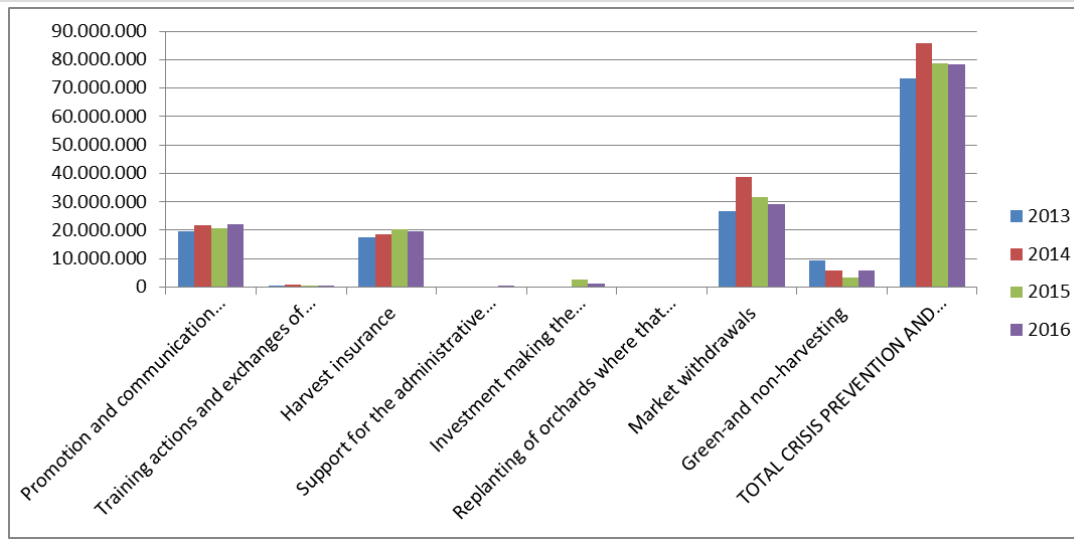
Expenditure on operational programmes of POs and APOs, by measures (Euro)
