WHY UPDATE THE CMO COMMISSION REGULATIONS?

Issue

More than 230 Implementing COM Regulations,
– of which 44 already declared obsolete. 8 more to be declared obsolete in 2015. But

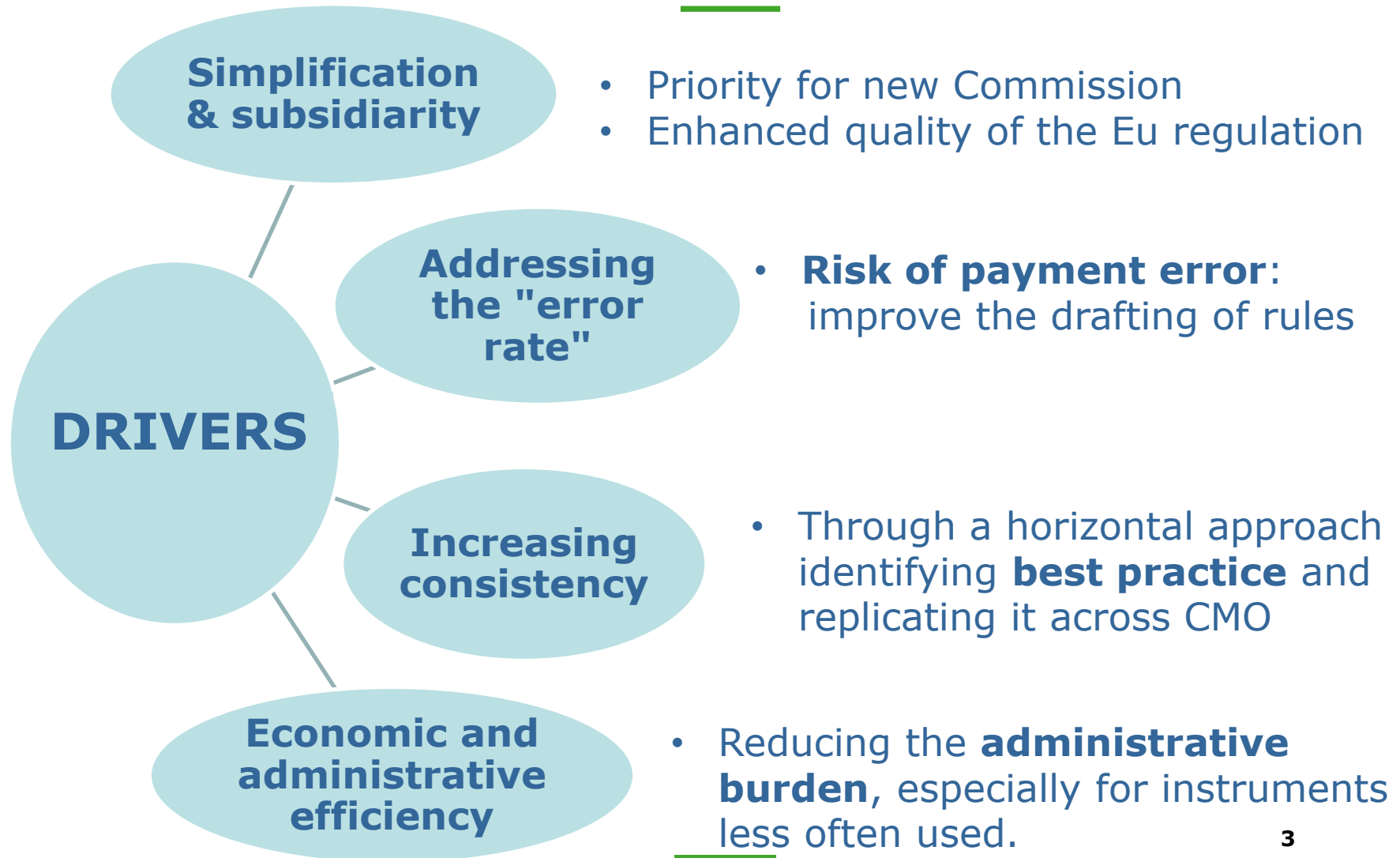
=> **200 x 2 = 400 regulations (!!!)**

- Establishment of CMO Task Force
- Design of an open working method

By the end of 2016 all DA/IA should have been adopted !

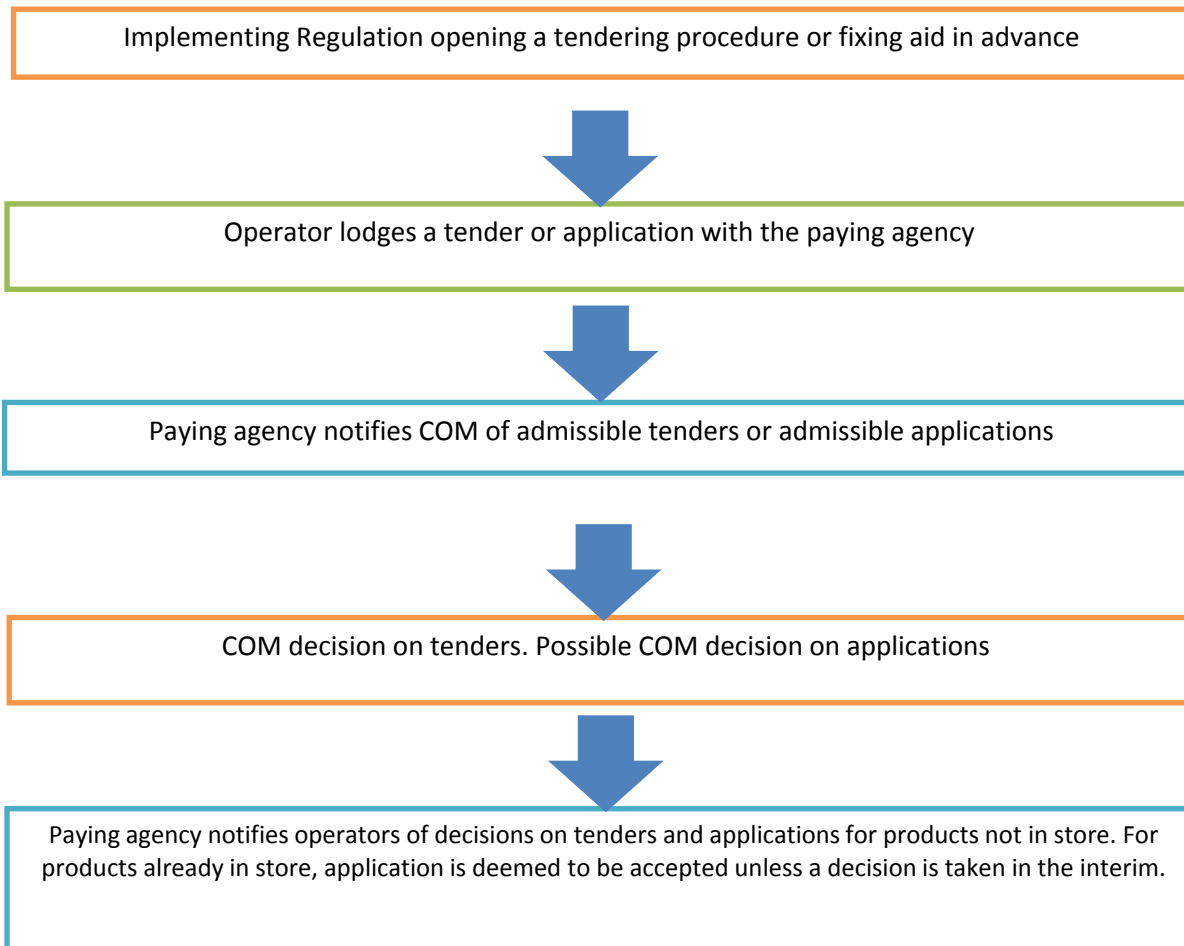
Public intervention: some examples of simplification

- Simplified system for take-over of products
- Quicker delivery of products to store
- Speeding up of payments
- Simplified structure of adjustments to buying-in prices for quality purposes
- Radically simplified transport costs structure for cereals and rice
- Reduction in information required when making an offer/tender
- Removal of requirement for 'nil' returns, reduction and reduced frequency of notifications required, harmonisation of dates of notifications

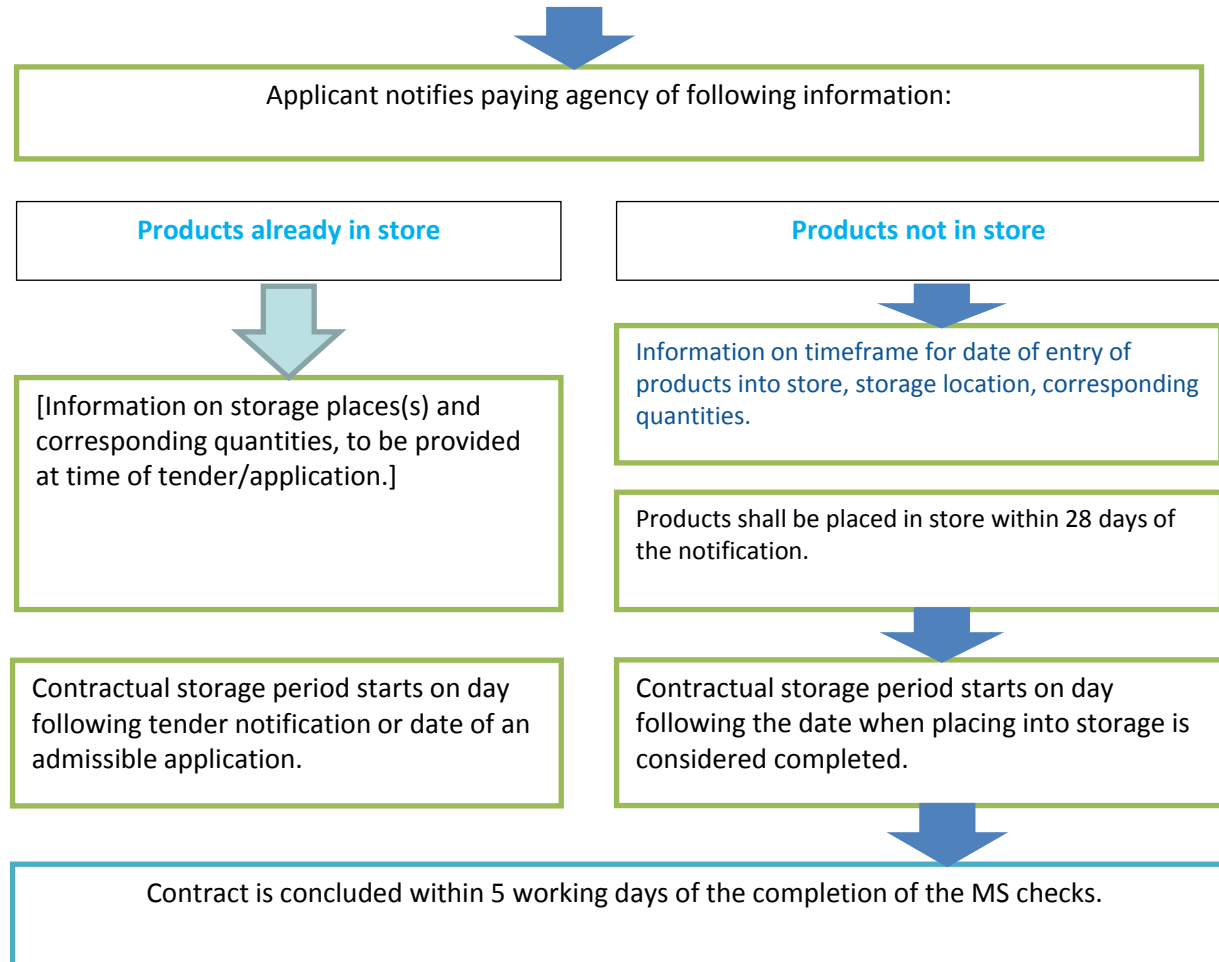
PSA: some examples of simplification

- Simplified system for conclusion of contracts
- Simplified rules on contractual quantity
- Introduction of clearer rules relating to the removal of products from storage
- Simplified eligibility requirements for operators;
- Providing a solution to the storage of sugar in bulk silos;
- Notifications – removal of requirement for 'nil' returns.

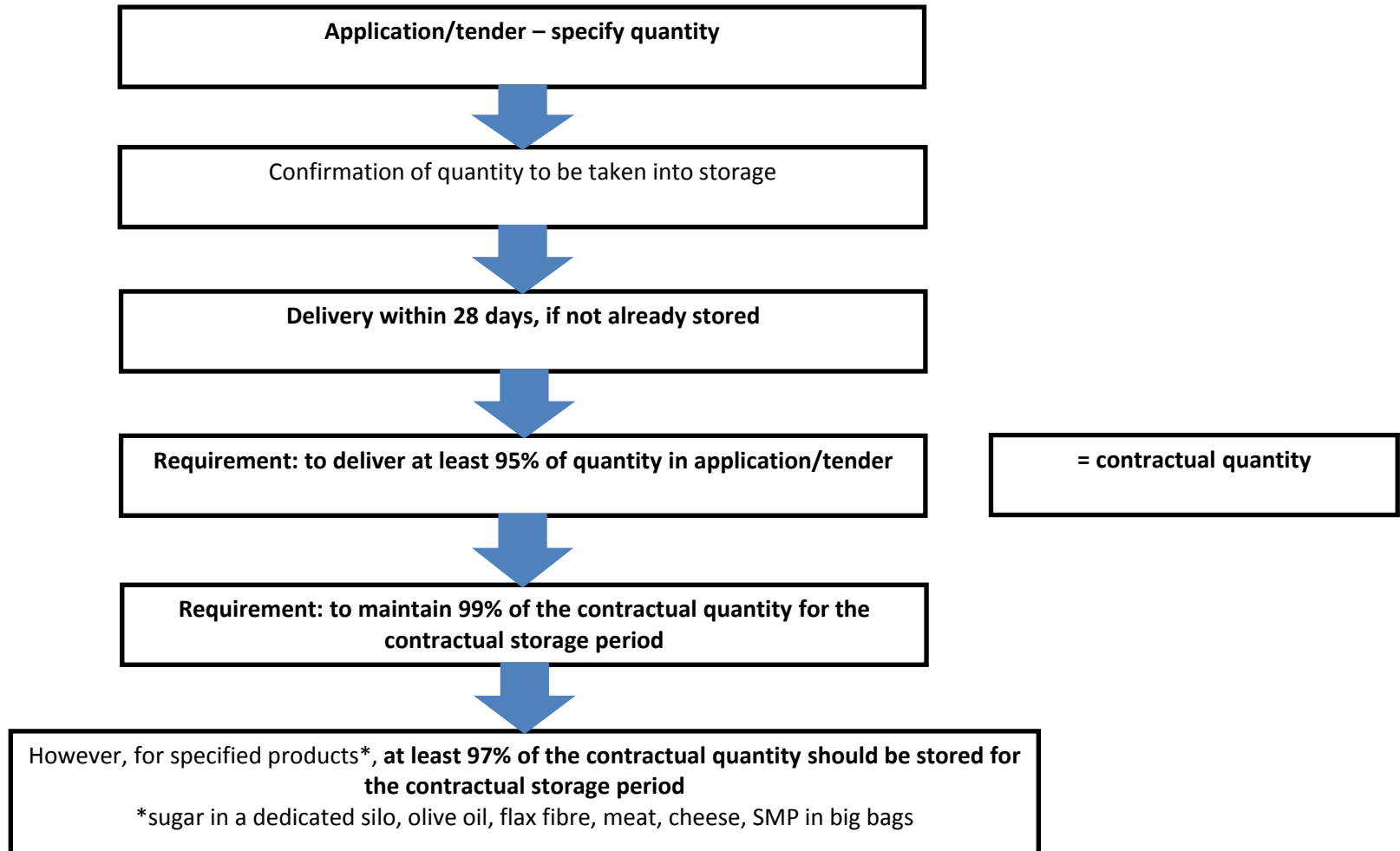
Review of PSA – new scheme for the conclusion of contracts
