Foreword

Dear Participant,

It is my pleasure to welcome you to the third annual EU Agricultural Outlook Conference. Last year, we had the great honour to welcome the President of the Commission and Commissioners Arias Cañete and Vella. This year Commissioner Oettinger will join our annual rendez-vous to discuss with us about policy performance and budget focussed on results.

This year's edition comes just weeks after the European Commission adopted a Communication on the Future of Food and Farming. It is a blueprint for the future development of the European agricultural sector and places EU agricultural policy at the heart of the delivery of the Juncker priorities.

It is a great pleasure for me today to share with you my vision for the future of EU agriculture. Agriculture is about the food we eat every day, it is an integral part of our daily life. The recent public consultation 'CAP have your say', with more than 320.000 participants, confirms that citizens have a high interest in our policy.

This conference looks forward with optimism to a dynamic and vibrant agricultural sector, with a focus on the adaptation of the sector to consumers' expectation, particularly in terms of environmental care and climate action, but also in such areas as food safety, food quality, health and animal welfare standards. We will discuss the essential role of innovation and research in developing new ways of sustainable farming, having regard to the CAP as an economic, environmental and social policy. We will learn about concrete projects involving farmers, advisers and researchers.

Over the last decades, the CAP has evolved towards greater market orientation. Thanks to various policy reforms, the EU agricultural sector has been able to grasp global market opportunities turning the EU into the globe's top agri-food exporter, with a large and growing trade surplus. However, EU farmers are also more exposed to price volatility and we need to explore all possible ways to address risk and increase farmers' resilience. This conference is an opportunity to bring forward promising initiatives involving various actors of the supply chain.

The CAP represents a large share of the EU Budget and citizens expect that it brings real EU added value. It is thus a great honour for me to welcome Commissioner Oettinger to join us and to address this issue during the first day of the Conference. But performance is a much broader topic than making sure that public money is spent accurately. It is also our role to enhance the performance of farming by promoting the role of



advisers and the use of new technologies.

In 2017, once more agriculture was hit by several extreme weather events in many parts of Europe. This is why climate will be again at the heart of our discussions when presenting the market outlook during the second day of the conference.

In this agricultural market outlook, we are not interested only in how much the EU will produce by 2030 but also what is produced and how, as well as who will produce our food tomorrow. We need to make sure that farming is attractive to new generations, because millions of jobs in the food industry but also in upstream and downstream industries depend on a viable agricultural sector.

During the second day, the medium-term prospects for EU agricultural markets and income will be presented. This market outlook is not intended to constitute a forecast of what the future holds; instead it paints a picture of what may happen under a plausible set of assumptions and circumstances. For over two decades, the Directorate-General for Agriculture and Rural Development, in collaboration with the European Commission's Joint Research Centre, has published medium-term prospects for EU agricultural markets and farmers' income. In recent years, we have invested in additional analysis to identify the main sources of uncertainty and to quantify their possible impact on agricultural markets. To assure the quality and robustness of such analysis, an annual Workshop in October gathers modelling and market experts from the EU. the United States and International Organisations such as the World Bank, the FAO and the OECD.

I am confident that these two exciting days will be inspiring and will generate new ideas on the future of food production and farming. I am delighted that you have joined us and I look forward to your input in the discussions on the future of EU agriculture.
