Note to the reader

The latest available consolidated trade data at EU level cover market developments in February 2023. Monthly figures can be compared with the previous month. Year-to-year change compares the cumulative trade since the beginning of the year with the same period in the previous year.

The trade figures are expressed in values, except when specifically mentioned. The unit value is the average price of products traded in the period concerned (trade value at the border divided by quantity registered).

HIGHLIGHTS: Month-to-month rebound of EU exports in February 2023. Imports still declining.

In February 2023, EU agri-food trade surplus increased by 33% month-to-month to reach EUR 5.4 billion. This was due to a rebound in exports, while imports declined for the third month in a row.

EU exports in February 2023 reached EUR 18.6 billion, a 3% increase compared to January 2023 (and 10% higher than February 2022). Cumulative exports (January and February 2023 combined) reached EUR 36.7 billion, a 13% increase compared to the cumulative exports in 2022. Dynamic exports for cereal preparations, preparation of fruit and nuts and dairy products led the increase for the start of the year.

Conversely, EU imports reached EUR 13.3 billion, a 5% decrease month-to-month (still higher by EUR 1.5 billion compared to February 2022). Cumulative imports for 2023 are still 12% higher compared to 2022, primarily due to higher imports of cereals and oilseeds and protein crops.







EU AGRI-FOOD EXPORTS

STRONG EXPORT VALUES AT THE START OF THE YEAR 2023

In February 2023 **EU agri-food exports** increased compared to January and reached a value of **EUR 18.6 billion** (+EUR 1.7 billion compared to February 2022, +10%). While EU exports are still dynamic in the start of the year 2023 compared to last year, the trend of recent months shows that values are coming back to pre-war levels.

EU exports to **the UK** amounted to EUR 3.9 billion., stable compared to January 2023. This is still 9% increase year-to-year. Cumulative (January and February combined) export values of cereal preparations and preparations of fruit, nuts and vegetables to the UK were both 29% higher year-to-year. Wine and wine-based products exports to the UK were down by 4% (driven by a decline in quantities, -11%).


EU exports to **the US** totalled EUR 2.1 billion in February 2023. It is a slight rebound from January, and from the downward trend since July 2023. Regarding the beverages sector, wine, spirits and liqueurs as well as beer, cider and other beverages had a slow start of the year. In quantity terms, they declined by 3%, 29% and 10%, respectively. Still, unit value increased compared to last year, but this compensated the decline in quantity only for wine and wine-based products.

EU exports to **sub-Saharan Africa and North Africa** in February 2023 reached EUR 2.0 billion. It is a 15% increase year-to-year (+EUR 271 million). The EU increased cereal exports in the first two months of 2023 to reach 3.9 million t (+768 thousand t compared to the same period in 2022). Exports of dairy products as well as sheep and goat also increased both in value and quantity terms. Exports of beef and veal, wine and wine-based products as well as fruit and nuts declined both in value and quantity terms.

EU CEREAL EXPORTS CONTINUE TO BE DYNAMIC IN YEAR 2023

All agri-food categories, except three, have had a dynamic start of the year in value terms (January and February combined) compared to last year. This was mainly driven by a price increase, as quantities exported have mostly declined. A notable exception has been for **cereals** exports, which have increased +11% in quantity terms, and for vegetable oils (+42%).

The three agri-food products that showed a decline in 2023 were: **spirits and liqueurs** (-2% in value terms, -10% in quantities, especially to US and the UK), **horticulture** (-1% in value, -4% in volumes mainly to the UK) and **sugar and isoglucose** (-12% in value, -42% in quantities, chiefly to the UK and to Israel).



EU AGRI-FOOD IMPORTS

IMPORTS STILL HIGH DESPITE DECLINE FROM SEVERAL PARTNERS

In **February 2023**, EU agri-food imports reached **EUR 13.3 billion** (+EUR 1.5 billion year-to-year, +13%). EU import values have been declining since November last year, mainly due to price reduction. While imports from the UK and Us have remained relatively stable, imports from Ukraine and Brazil continued to decline in February 2023.

EU agri-food imports from **Brazil** reached EUR 1.2 billion in February 2023. This confirms the downward trend of EU imports from Brazil, in value terms. In February, Brazil was the fourth most significant source for EU imports. This has been due to the decline trend in oilseeds and coffee imports.

In February 2023, Ukraine remains the top source of EU imports. EU imports from **Ukraine** were still up 45% year-to-year, and reached EUR 1.3 billion. EU imports in value terms have been declining since November 2022, from both a quantity and price effect. Indeed, EU vegetable oil imports from Ukraine are 37% below the level in February 2022 in value (-29% in volumes). Fruit and nuts imports also decreased (-45% in value, -14% in quantity) as well as preparations of fruit and nuts (-13% in value, -39% in volumes).

EU IMPORTS DECLINED IN FEBRUARY BUT STILL HIGH IN VALUE TERMS

EU imports of all agri-food categories, except three, have had a dynamic start in 2023 (January and February combined). This was the case for EU **cereals** imports (+55% in value, +42% in quantity) as well as **oilseeds and protein crops** (+25% in value, +10% in quantity). EU imports of cereals reached 7.5 million t (compared to 5.3 million t in the same period in 2022) and 7.4 million t of oilseeds and protein crops (6.8 million t in same period of 2022). **Fruit and nuts** imports also increased compared to the same period in 2022 (+4% in value terms) and this was only due to quantity increase.

The three agri-food categories for which imports in 2023 were below 2022 levels were: **vegetable oils** (-15% in value terms), **mixed food preparations** (-6%), and **horticulture** (-3%). This was largely due to a quantity effect, with fewer imports into the EU. This was the case for EU imports of vegetable oils from Ukraine that declined compared to the first two months of 2022 combined. Imports of mixed food preparations declined substantially from the three main EU source namely UK, China and Thailand.


