



- Forecast 2020/21 is for EU only:
 - 27 MS and for 12 months from Oct. 20 to Sep. 21 (UK is also considered as extra EU between Oct. 20 and Dec. 20)
 - rounded figures to estimate UK sugar stocks by end of September 20 (0.2 million tonnes) and UK sugar consumption in 2019/20 (1.8 million tonnes)




- Impact of Brexit:
 - Duty and quota free trade for agricultural products
 - 'Rules of Origin': products exported from the UK that benefit from duty free access to the EU must be produced in the UK
 - White sugar refined from imported raw sugar does not comply to the rules
 - Application of the 'Rules of Origins' are likely to impact the flow of traded sugar from UK to EU more than in the other direction.



- Forecast 2020/21 for EU based on:
 - Current EU sugar production forecast around 14.65 million tonnes (Jan. 21)
 - EU sugar consumption/disappearance very similar to previous MY
 - EU sugar trade with third countries other than UK similar to previous MY
 - However, EU sugar trade with the UK will be impacted by
 - Non-originating sugar that will no more be exported,
 - EU and UK sugar production forecast from sugar beets very low in 2020/21,
 - Possible impact from additional administrative/logistic burden ...



EU Sugar trade (EU + UK from 1/2/2020 to 30/9/20)





Sugar exports (EU without UK)




• EU without UK total sugar exports to third countries in 1 000 tonnes

EU Sugar trade with the UK




- Forecast 2020/21:
- No more EU/UK trade of raw sugar
- EU sugar exports to the UK estimated to 0.2 million tonnes
- EU sugar imports from the UK estimated to 0.05 million tonnes
- EU raw sugar imports from other Third Countries estimated to 0.15 million tonnes



- Trade of sugar as such with the UK:
 - EU sugar imports from the UK estimated to 0.05 million tonnes of white sugar mainly to Ireland (0.15 – 0.20 million tonnes of raw sugar usually imported from the UK will be replaced by direct EU imports from third countries)
 - EU sugar exports to the UK estimated to 0.20 million tonnes of white sugar (compared to 0.27 million tonnes in 2019/20 and 0.5 million tonnes before)
- Trade of sugar in processed products with the UK could also be slightly reduced




Sugar in processed products Trade between the EU 27 MS and Third countries (UK excluded)

- Nearly 70% of EU exports to the UK are covered by 5 MS (DE BE NL IE FR)
- Nearly 50% of EU imports from the UK are going to Ireland

- Rounded UK stocks deducted (- 0.2 million tonnes)
- EU 27 MS sugar production forecast (14.5 million tonnes)
- Imports as such EU 1.4 million tonnes + 0.05 million tonnes from UK + 0.15 million tonnes raws from third countries
- Imports in processed products EU 0.5 million tonnes + 0.2 million tonnes from UK (-25% compared to long-term average)

- EU 27 MS consumption stable (1.8 million tonnes for UK consumption deducted)
- Stable industrial use Reduced bioethanol production (EU production -0.1 million tonne and deduction of -0.075 million tonnes for UK)
- Exports as such EU 0.7 million tonnes + 0.2 million tonnes to UK (compared to 0.27 million tonnes in 2019/20 and 0.5 million tonnes before)
- Exports in processed products EU 1.5 million tonnes + 0.6 million tonnes to UK (-25% compared to long-term average)


