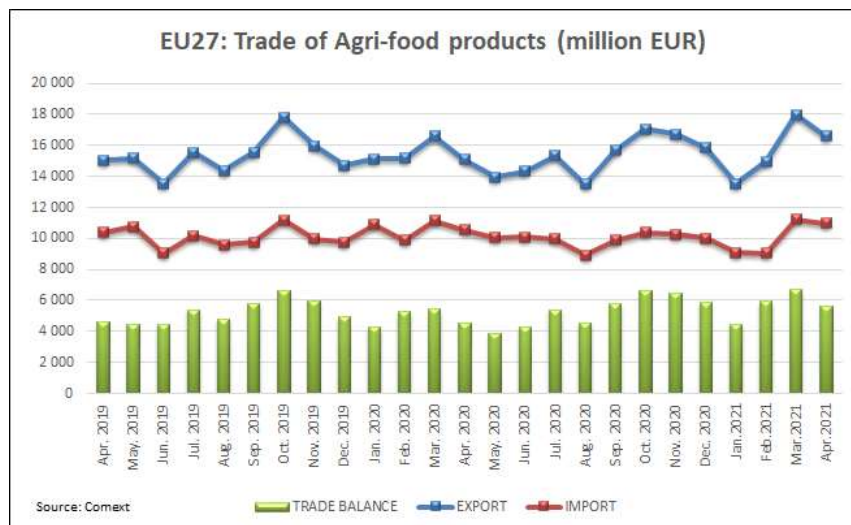

JANUARY - APRIL 2021: VALUE OF EU27 AGRI-FOOD EXPORTS SURPASSES THE VALUE IN JANUARY-APRIL 2020

During the period from January to April 2021, EU27 agri-food trade (exports plus imports) reached a value of **€103.4 billion**; i.e. 1.1% less than in January-April 2020. EU27 exports increased by 1.7% compared to the same period in 2020, reaching **€63 billion**. EU27 imports attained **€40.3 billion**, 5.1% less than in the first four months of 2020. Looking at monthly performances, the value for EU27 exports in April 2021 were 7.7% lower than March 2021, but also 9.8% higher than April 2020. EU imports in value also were 2.5% lower in April 2021 compared to March 2021, but 3.7% higher than the value observed in April 2020.

EU27 EXPORTS: INCREASING EXPORTS TO CHINA AND US, DOWNWARD TREND IN EXPORTS TO UK

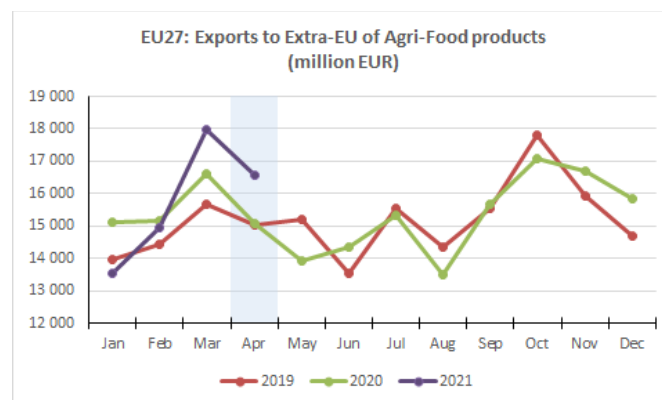
On a year over year basis, for the period January-April 2021, EU27 export values fell most to the **United Kingdom** (-€806 m, -6%), when compared with the same period in 2020. However, EU27 exports in value to the UK in April 2021 were 8.5% higher than in April 2020. Significant decreases in EU27 exports value for the first four months of the year mainly affected cigars and cigarettes (-€126 m), pig meat (-€121 m), and preparations of vegetables, fruits or nuts (-€106 m). However, significant increase in EU27 export values were observed for bulbs, roots and live plants (+€164 m), wines (+139 m), cut flowers and plants (+€126 m).

Other destinations, for which the value of EU27 agri-food exports fell most since January 2021 compared to the first four months of 2020, included **Saudi Arabia** (-€189 m, -13%, primarily driven by lower exports of wheat and malt-based products), **South Africa** (-€137 m, -22%, wheat), Japan (-€129 m, -5.4%, pig meat and to a lesser extent, wine) and Egypt (-€95 m, -13%, wheat and maize).

For the period January-April 2021, the highest increases in the EU27 export values were recorded for **China** (+€912 m, +16%). This continued to be primarily driven by an increase in the EU exports in value of pig meat (+€337 m), coarse grains (+€217 m) and rapeseed and sunflower oils (+€157 m).

For the same period, the EU27 export values to the **United States** have increased by 7.1% (+€488 m) compared to the same period in 2020. Increases in values for exports compared to the first four months of 2020 include spirits (+€185 m), wine (+€136 m) but also olive oil (+€45 m) and chocolate and confectionery (+€41 m). Decreases are however observable for water and soft drinks (-€84 m) and beer (-€53 m).

Comparing EU exports in value from January to April 2021 to the same period in 2020, **Switzerland** came third with EU exports in value (+€297 m, +9.7%, mainly due to exports of wine). Other destinations, for which the value of EU agri-food exports increased most in the same four months, included **Norway** (+€238 m, +15.5%) and Chile (+€118 m, +53%).



The main EU27 export destinations in the first four months of 2021 were the United Kingdom, the United States, China, Switzerland and the Russian Federation. 51% of EU agri-food exports went to these five countries.

EU27 EXPORTS: DECREASING EXPORTS VALUE OF WHEAT AND INFANT FOOD

Looking at product categories, the biggest decline in value observed in the first four months of 2021 compared to the same period in the year before concerned exports of products such as **wheat** (-€1 024 m, -32%), **infant food** (-€432 m, -14%), butter (-€118 m, -22%), fresh and chilled vegetables (-€114 m, -5.2%) and poultry (-€113 m, -13%).

On the other hand, the highest increases in export values in January-April 2021 compared to the same months in 2020 included **wine** (+€741 m, +18%), **spirits and liqueurs** (+€379 m, +19%), **pig meat** (+€353 m, +10.5%), rapeseed and sunflower oils (+€307 m, +29%) bulbs, roots and live plants (+€261 m, +27%).

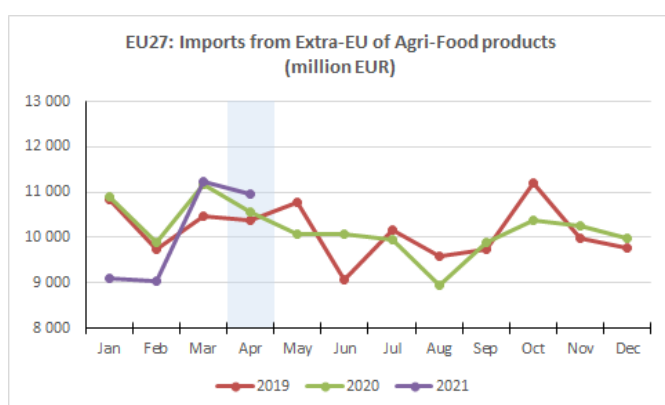
The top EU agri-food export products in the period January-April 2021 included wine, pig meat, pasta and bakery products, chocolate and confectionary, and food preparations. These products accounted for more than 26% of EU27 total agri-food exports.

EU27 IMPORTS: EU IMPORTS FROM THE UNITED KINGDOM PLUMMETING

During the period January-April 2021, the value of EU27 agri-food imports has decreased by 5.1% compared to the first four months of 2020. This has been driven by a significant fall in the value of EU imports from the **United Kingdom** (-€1 844 m, -37%). While generally all agri-food product categories reported decreasing imports from the UK, those with the most significant import reductions in value include tropical fruits, nuts and spices (-€97 m), pet food (-€90 m), wine, vermouth, cider and vinegar (-€80 m) and live animals (-€78 m). Monthly imports from UK in April 2021 measured in value were 13% lower than March 2021, but also 18% lower than the value observed in April 2020.

Other destinations, for which the value of EU27 agri-food imports fell most since January 2021 compared to the first four months of 2020, included **Ukraine** (-€452 m, -19%, important reductions of EU imports of corn and sunflower seed oil), **Indonesia** (-€238 m, -14%, driven by reduced value of palm oil purchases) and Viet Nam (-€145 m, -19%, coffee).

A further decrease was also observed in the EU imports from the **United States** (-€387 m, -10%). Reduced imports affected the majority of agri-food products, with tropical fruits, nuts and spices leading (-€369 m). On the other hand, a notable increase in value of EU imports was reported for US soybeans (+€326 m).



On the other hand, countries for which the EU27 import values increased the most over the first four months of 2021 include **India** (+€175 m, +20%-soybean oilcakes), **Brazil** (+€154 m, +4%, soybeans and soybean oilcakes), **Serbia** (+€146 m, +35%, mainly corn), Australia (+€139 m, +25%), and Argentina (+€109 m, +8%).

The top origins for EU agri-food imports in the first four months of 2021 included Brazil, United States, United Kingdom, Ukraine and China. These countries accounted for 34% of EU27 agri-food imports in value terms.

EU27 IMPORTS: FALLING IMPORTS OF TROPICAL FRUIT, PALM OIL, UNROASTED COFFEE AND TEA IN VALUE TERMS

Looking at product categories over the first four months of 2021, the highest decreases in import values continued to be reported for **tropical fruit, nuts and spices** (-€557 m, -12%), **palm and palm kernel oil** (-€237 m, -12%), unroasted coffee and tea (-€217 m, -10%), coarse grains (-€207 m, -17%) and bovine meat (-€180 m, -29%).

On the other hand, the EU27 imports value increased most for **oilcakes** (+€630 m, +32%), **soya beans** (+€476 m, +27%) cut flowers and plants (+€70 m, +17%).

The top EU agri-food import products in the first four months of 2021 included fruit (tropical and other than citrus), oilcakes, soybeans, unroasted coffee and tea. These products accounted for nearly 33% of EU27 agri-food imports.

EXPANDING SURPLUS IN EU27 AGRIFOOD TRADE

During the period January-April 2021, the agri-food trade surplus' value stood at **€22.7 billion**, an increase of 17% compared to the corresponding period in 2020. This net trade balance remained to be driven by high exports of wine, pig meat, infant food, chocolate and confectionary, pasta and pastry.
