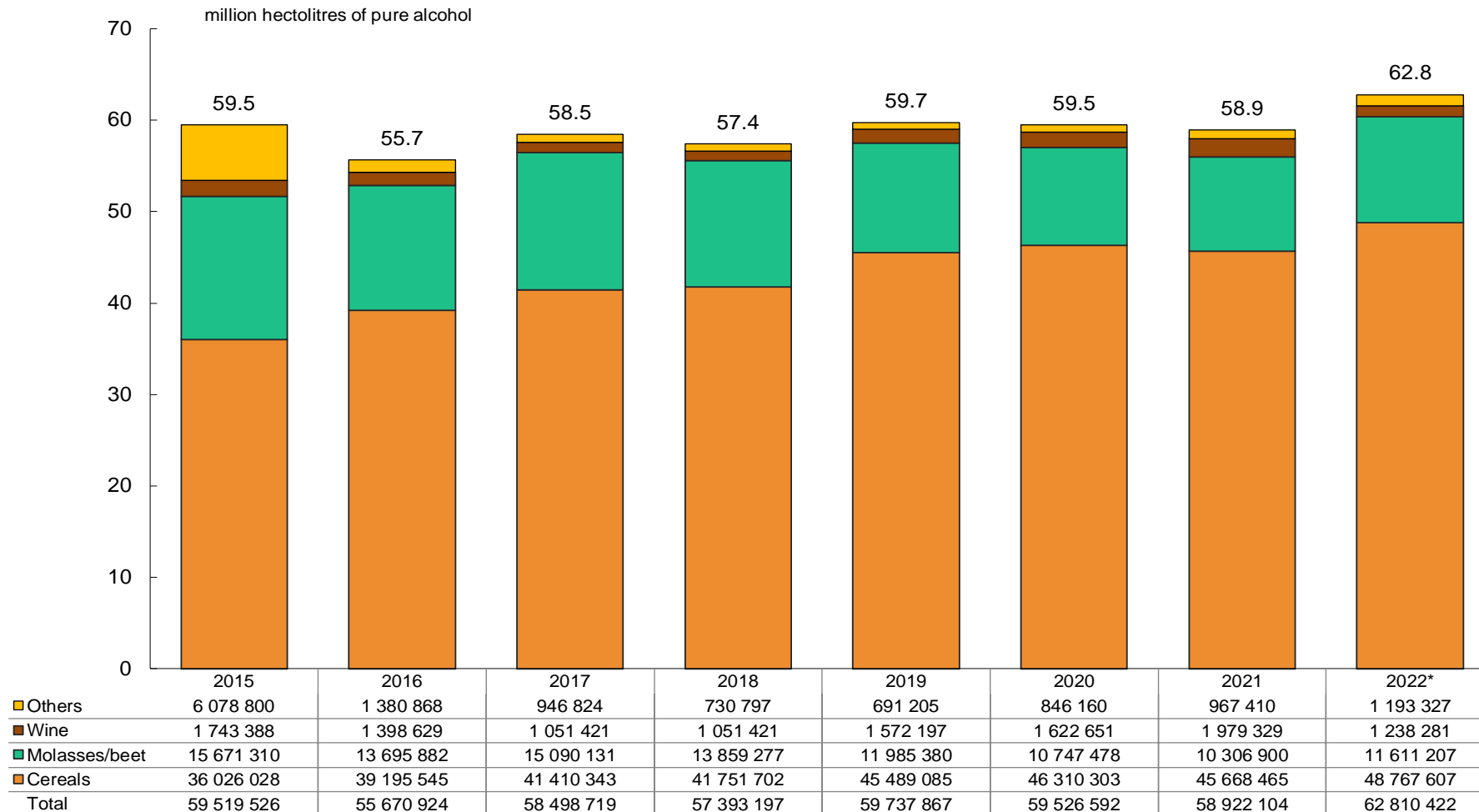


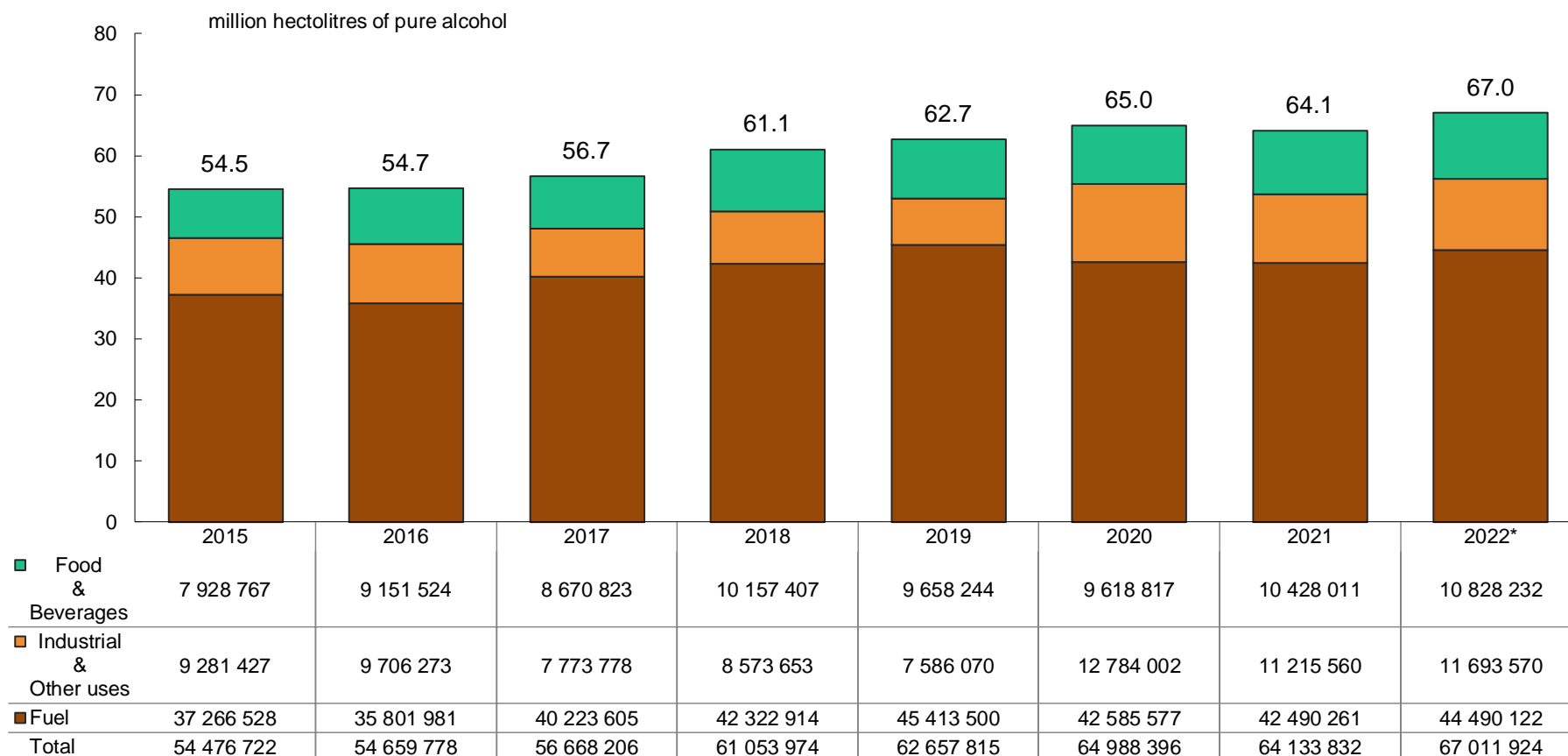

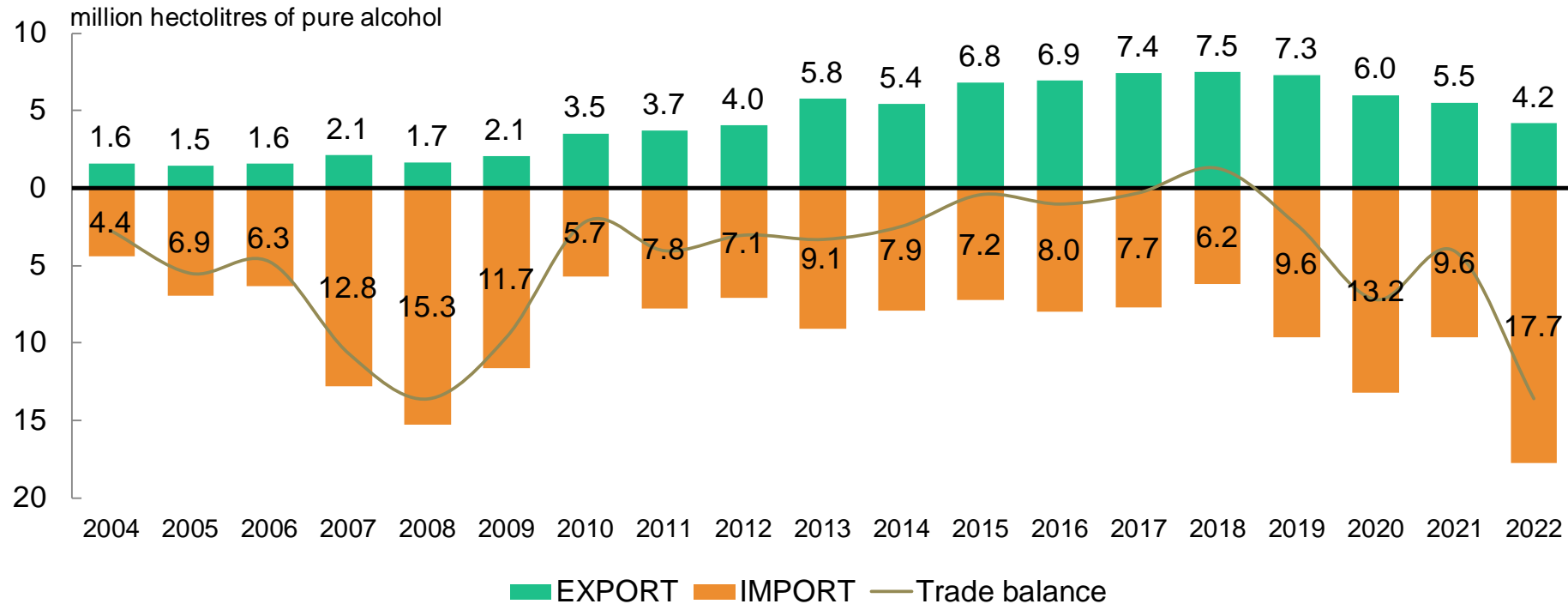
## Disposal by sector of destination

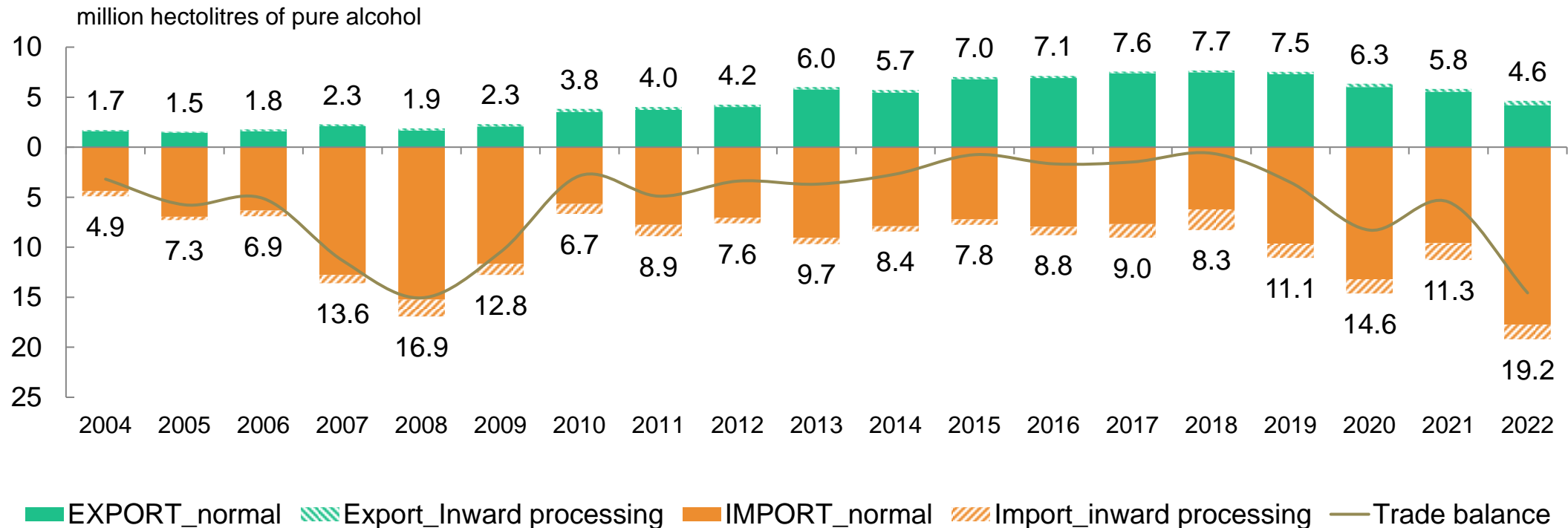
