


Monitoring EU Agri-Food Trade: Development until August 2016



August 2016 – EU agri-food exports to Asian countries expanding further

The monthly value of EU agri-food exports in August 2016 reached EUR 10.6 billion and, thus, exceeded the export values in August of previous years, normally characterised by a reduction in export values compared to July.

Highest increases in monthly export values (August 2016 compared to August 2015) were recorded for the **USA** (EUR +221 million) and **China** (EUR +106 million). Also, agri-food exports to other **Asian countries** increased by EUR 50 million or more each (Vietnam, Japan, South Korea).

Most important reductions were in export values to Egypt, Jordan and Turkey.

The highest increases in monthly export values compared to the previous year were achieved for **infant formula** (EUR +113 million) and **pork** (EUR +101 million), followed by olive oil and wheat.

On the other hand, monthly export values in August 2016 compared to August 2015 went down in particular for other cereals, milk powders and raw hides and skins.

In August 2016 agri-food **imports** to the EU slightly increased to a value of EUR 8.9 billion from EUR 8.6 billion in August 2015. The highest increase in monthly import values was from Brazil and the USA.

12-month period: Most dynamic development in pig meat exports

For the 12-months period September 2015 to August 2016, EU agri-food exports reached a value of EUR 129.5 billion, corresponding to an increase by 1.3% in value terms compared to the same period one year ago.

Major gains were achieved in values of agri-food exports to the **USA** (EUR + 1.8 billion; +10%) and **China** (EUR +1.5 billion; +16%), although exports to Hong Kong went down significantly. Increases were also recorded in agri-food exports to **Saudi Arabia** (EUR +0.4 billion). Vietnam, Japan, Israel, Switzerland, Norway and Australia, each increased by more than EUR 200 million in the twelve-months period. Exports to **Russia** further went down, from EUR 6.0 billion (Sept 2014 to Aug 2015) to EUR 5.4 billion (Sept 2015 to Aug 2016), i.e. a reduction in values by 10%. The value of exports to Algeria and Egypt also went down by around EUR 500 million each.

Analysing the EU export performance over the last twelve months per product category, export values increased in particular for **pig meat** (EUR +1.2 billion; +31% compared to export values in the 12-months period one year ago), **fresh vegetables** (EUR +439 million; +16%), live animals (EUR +382 million; +17%) and meat offal, other meat and fat (EUR +370 million; +16), and olive oil (EUR +318 million; +14%). In relative terms, high increases in export values were also seen for butter (+28%).

Similar to the development recorded for previous periods, **raw hides and skins** (EUR -1.3 billion; -42%) **wheat** (EUR -837 million; -12.5%), **milk powders** (EUR -708 million; -16%) and **other cereals** (EUR -676 million; -23%) lost most in export values over the last 12 months.

EU trade surplus in agri-food at EUR 17 billion over 12 months

Agri-food imports from third countries in the 12-months period September 2015 to August 2016 came into the EU at a value of EUR 112 billion, i.e. an increase by 1.5% compared to the same period one year ago. The export surplus for the 12-months period stands at more than EUR 17 billion.

Despite a reduction in the month of August 2016, imports from the **Ukraine** showed the highest increase in values (EUR +748 million; +21%) over the 12-months period. Over the last 12 months, EU import values for agri-food products went up for **Ivory Coast** by EUR +613 million (+21%), Argentina (EUR +406 million; +7%), Peru (EUR +251 million; +14%) and Australia (EUR +220 million; +12%). Switzerland and several Latin American countries improved in agri-food exports to the EU, such as Uruguay, Chile and Colombia.

On the other hand, the value of agri-food imports from **Brazil** decreased by EUR 1.2 billion (-9%) and imports from other important suppliers, Indonesia, Tunisia and the USA went down compared to the previous 12 months period.

Looking at imports per product category, the highest increase in values over the last 12 months was for **cocoa beans** (EUR +812 million; +14%). Imports also increased in particular for tropical fruit (EUR +737 million; +6%), cereals other than wheat (EUR +648 million; +33%) oilseeds other than soya beans (EUR +556 million; +20%) and vegetable oils other than palm and olive oil (EUR +450 million; 25%).

On the other hand, import values decreased in particular for commodities such as unroasted **coffee** and tea in bulk (EUR -1.0 billion; -13%), **oilcakes** (EUR -1.0 billion; -11%), palm oil, palm kernel and coconut oil (EUR -387 million; -7%), as well as for olive oil (EUR -290 million; -45%), and for wheat (EUR -208 million; -13%).

Focus on: EU agri-food trade with SADC EPA countries*


The Economic Partnership Agreement (EPA) between five southern African countries (Botswana, Lesotho, Namibia, South Africa and Swaziland) and the EU entered into effect on 10 October 2016. The sixth SADC EPA country, Mozambique, is in the process of ratifying the agreement.

The EU is a net importer of agri-food products from the six SADC EPA countries. The net-surplus of exports from these countries to the EU has been around EUR 1 billion annually for the last years.

The 2015 value of EU agri-food imports from the SADC EPA countries reached a total of almost EUR 3 billion, with main focus on different kind of fruit, wine, sugar and raw tobacco. The annual value of EU imports from this group of African countries has been increasing quite steadily over the past years.

Within the group, the most important country for EU agri-food imports is South Africa (EUR 2.4 billion in 2015; mainly fruit incl. citrus and wine), followed by Mozambique (EUR 257 million; mainly raw tobacco and sugar), Swaziland (EUR 127 million; mainly sugar) and

EU imports from SADC EPA countries, 2015




Namibia (EUR 113 million; mainly bovine meat and fruit).

EU exports to SADC EPA countries represent a mix of several agri-food categories, worth EUR 1.8 billion in 2015.

The most important EU export products are spirits and liqueurs, poultry meat and vegetable oils other than palm and olive oil.

The main destination countries for EU agri-food exports is South Africa (EUR 1.7 billion), followed by Mozambique (EUR 76 million) and Namibia (EUR 30 million).
