INDICATIVE FIGURES
ON THE DISTRIBUTION OF AID, BY SIZE-CLASS OF AID,
RECEIVED IN THE CONTEXT OF DIRECT AID PAID TO THE PRODUCERS ACCORDING TO
COUNCIL REGULATION (EC) NO 1782/2003
(FINANCIAL YEAR 2007)

1. SOURCE OF THE INFORMATION

Pursuant to the 'X-table' regulation, the Commission receives from the Member States, on an annual basis, data on the payments made to the beneficiaries of the European Agricultural Guarantee Fund (EAGF) for further use in the context of the audit procedures as well as for monitoring and forecasting purposes.

2. SCOPE OF THE DISTRIBUTION FIGURES (EU25)

The attached figures cover the expenditure paid as direct aid according to Regulation No 1782/2003 for financial year 2007 and are based on the total amounts aggregated by every individual beneficiary identification code ('unique identifier'). Part of the expenditure (approximately 0.8 %) has been excluded from the overviews because of missing information on the final beneficiary. For financial year 2007, no expenditure as direct aid was made by Bulgaria and Romania.

3. LIMITATIONS AND COMMENTS

3.1. While in general data quality is adequate for use in the audit activity, care must be exercised over use of the data for other, analytical purposes. The requirement for a 'unique identifier' came into effect on 1 January 2003 following the introduction of the new IACS Implementing Regulation¹. Despite the Member States' efforts, inconsistencies in the application of the 'unique identifier' cannot be totally excluded². The attached tables therefore present "indicative" and not totally precise figures.

3.2. The Member States have been invited to confirm the order of magnitude of the draft 2007 figures upon which no substantial differences were notified.

3.3. Some aid schemes have been excluded from the statistics on direct payments. In certain cases, the direct aid is not paid directly to the final beneficiary, but

² In this respect, it must be noted that for financial years 2005 and 2006, there were some problems with the 'unique identifier' across the Dutch paying agencies. The statistics regarding those financial years must therefore be considered as overstated in number of beneficiaries resulting in shift of the expenditure towards the lower strata. As of financial year 2007, this problem no longer occurs as direct payments are henceforth managed by one paying agency.

rather to producer associations or processors which distribute on their turn the money further to their associated producers. This concerns premiums for bananas (€121.6 million), silk worms (€0.6 million) and hops (€2.6 million). Furthermore, data regarding the 'separate sugar payment' (€168.9 million) for EU10 is not yet available and consequently not included.

- 3.4. Because of the growing implementation of decoupled direct aid payments, details per size-class of aid are now given on the level of "All direct aids", "Decoupled direct aid" and "Coupled direct aid".
- 3.5. Numbers of beneficiaries less than 10 have been made invisible.
- 3.6. In order to compare the information across all Member States, the expenditure has been converted into EUR. The exchange rates used for this conversion are listed below and need to be taken into account when evaluating expenditure in national currency.
