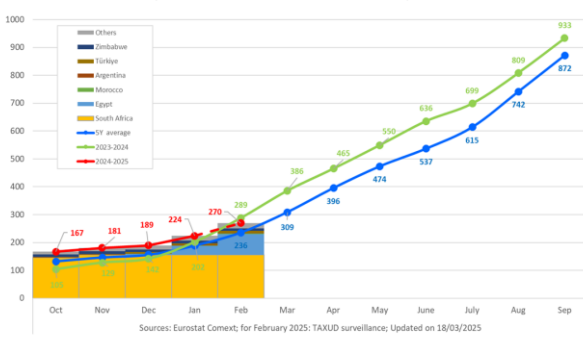

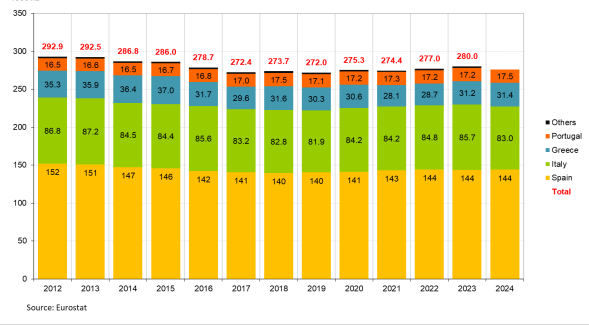


Imports of oranges into the EU (cumulated)



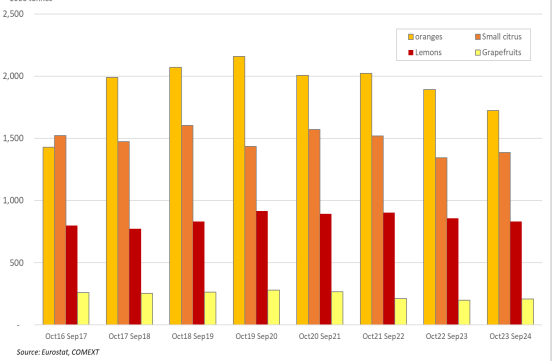

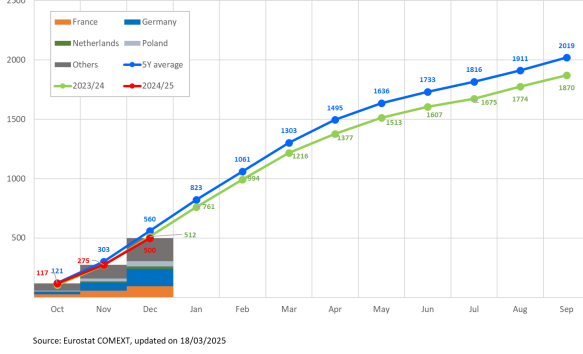


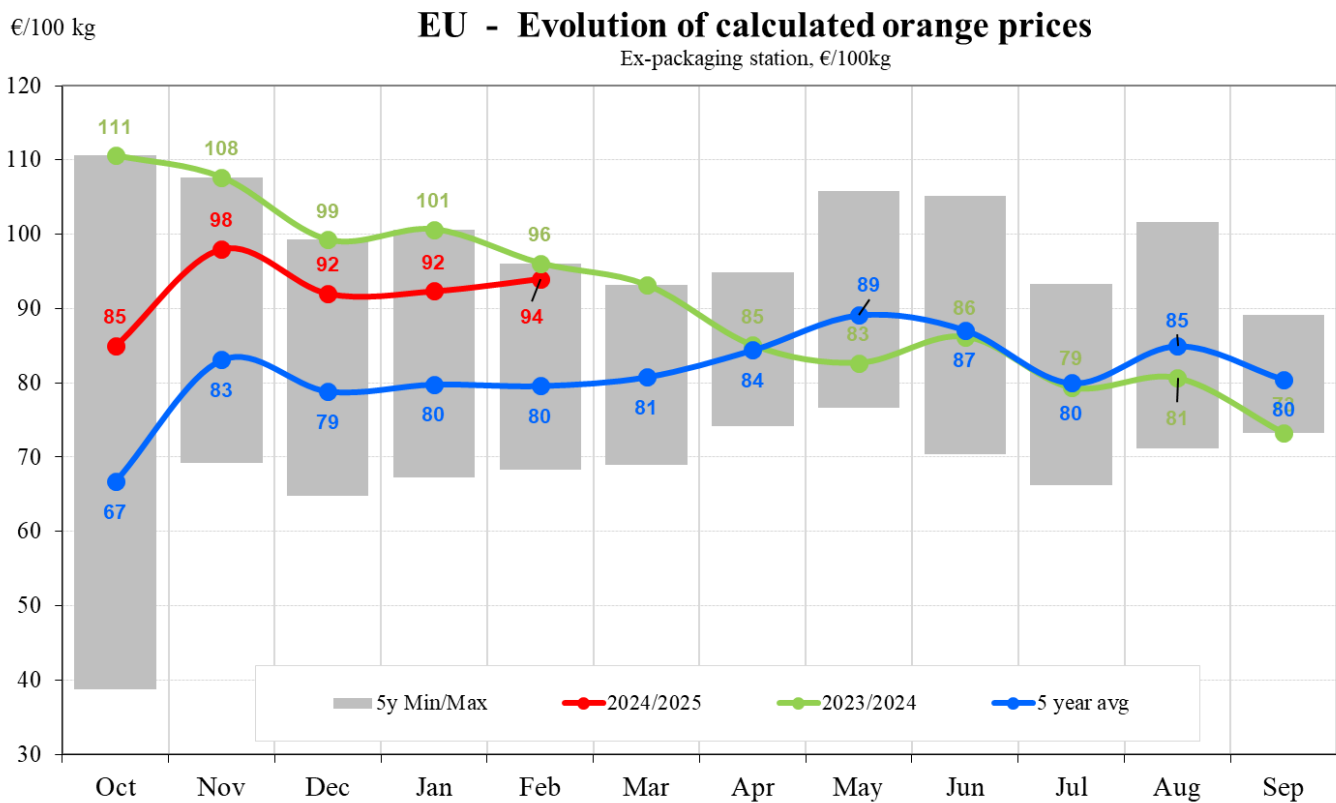

Intra-EU exports of oranges - Main destinations

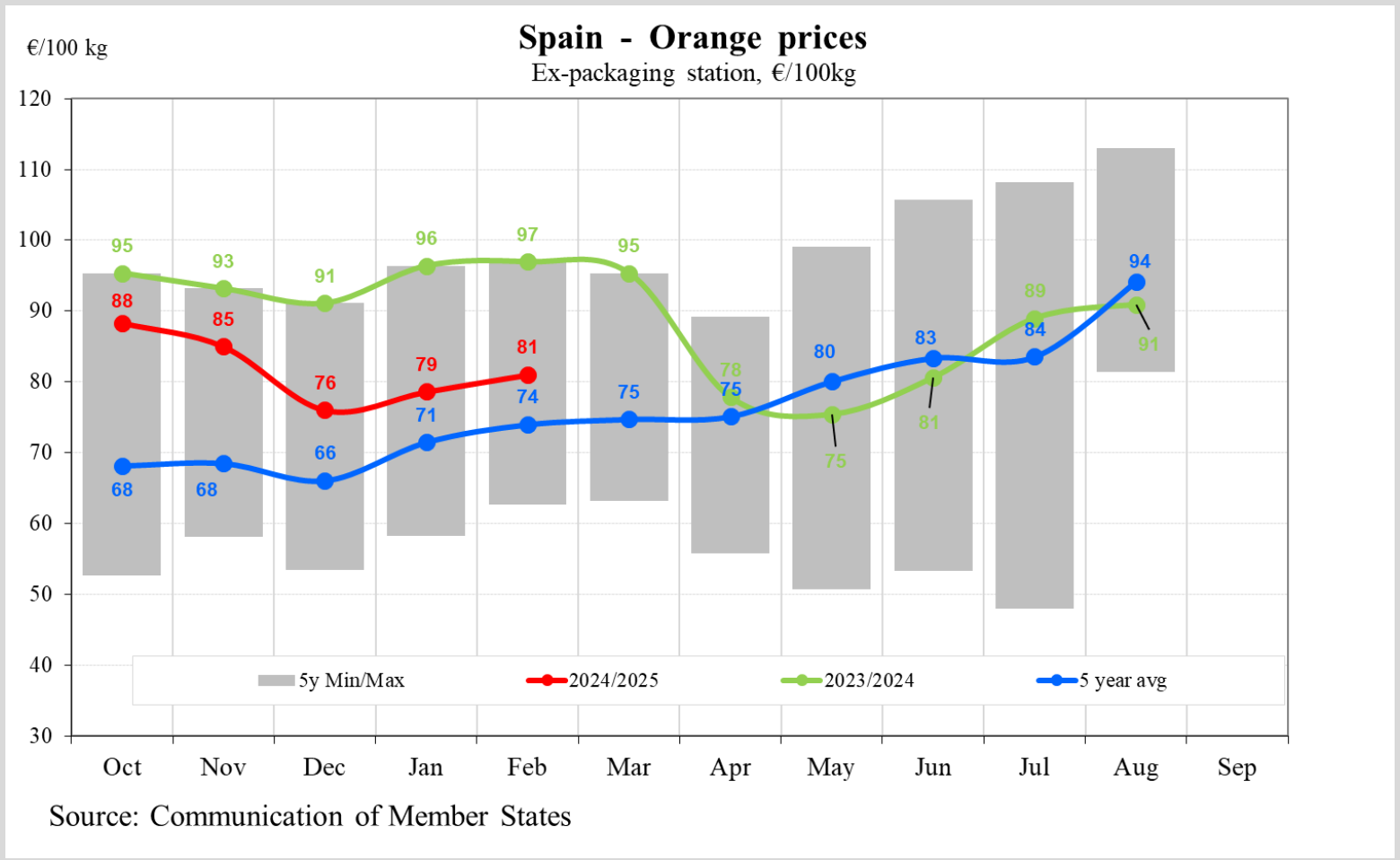


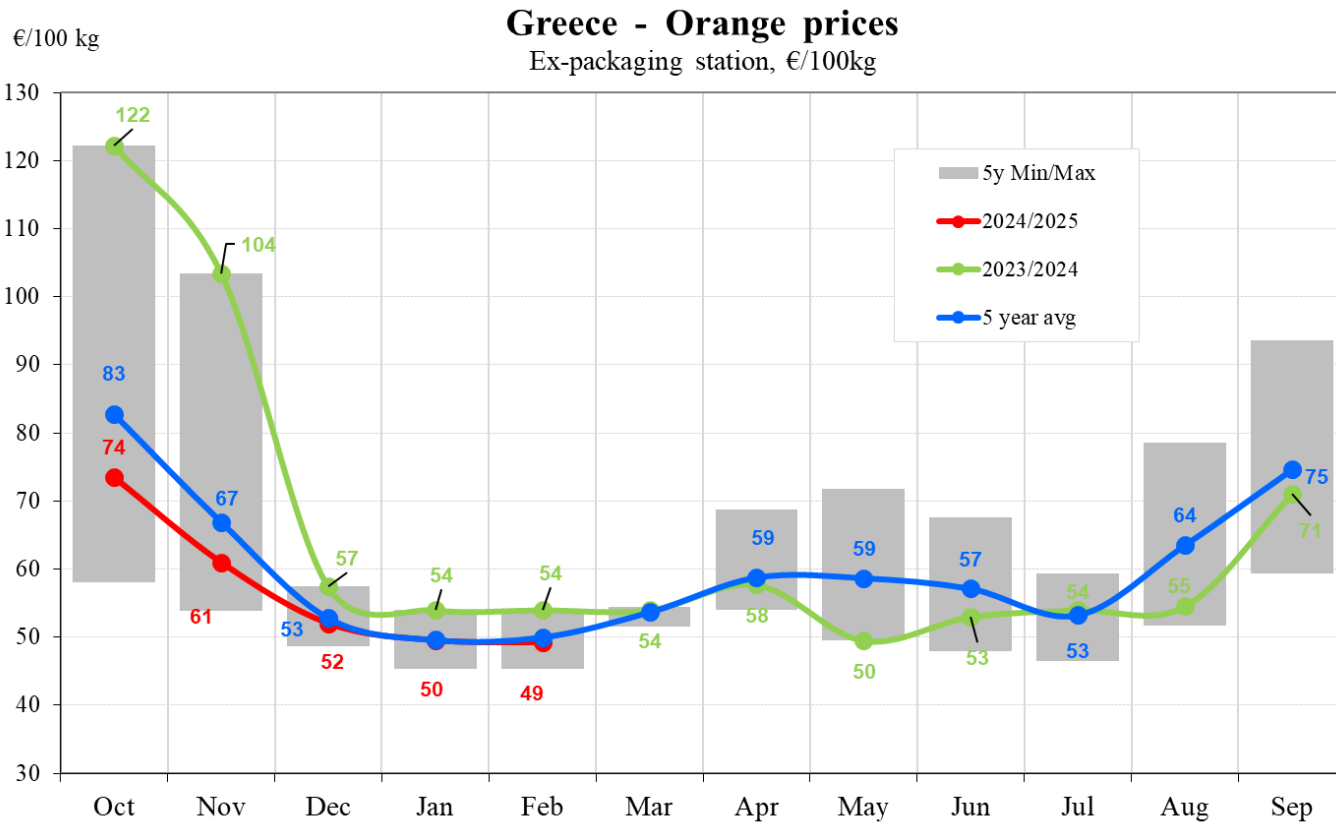

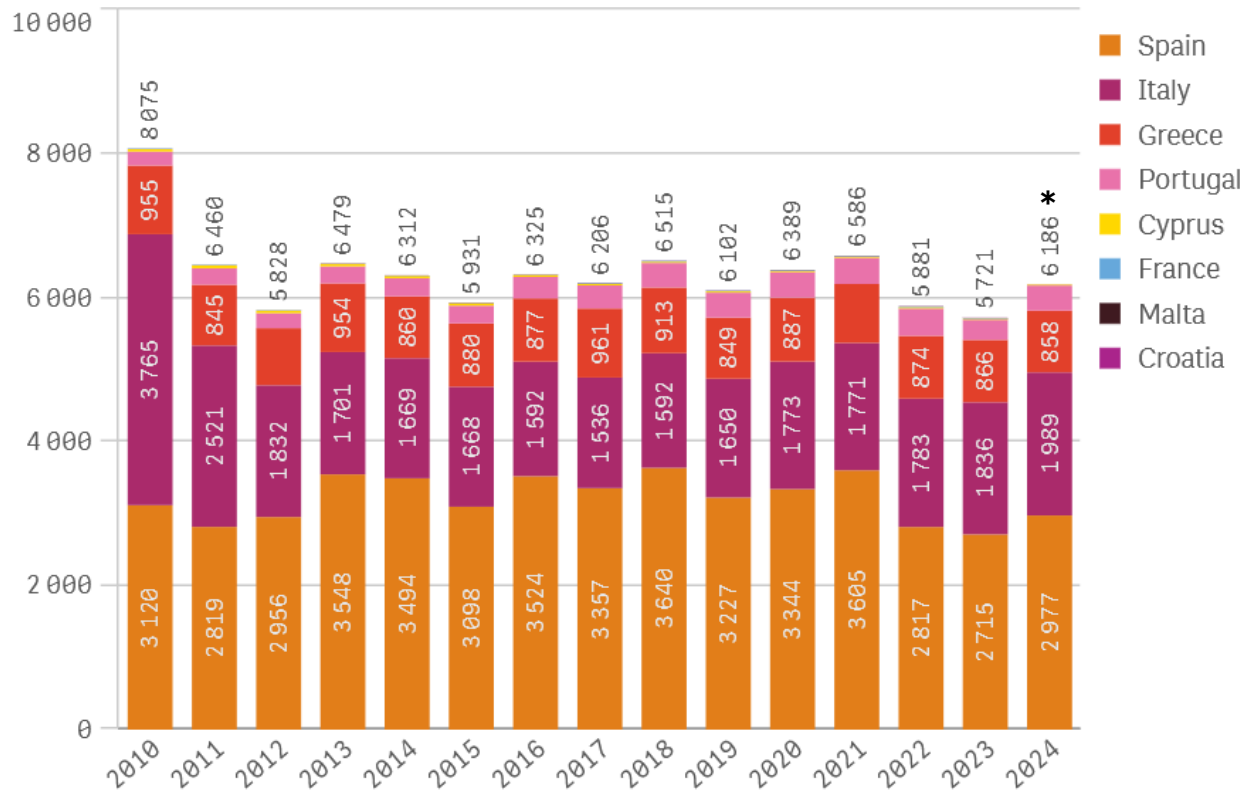

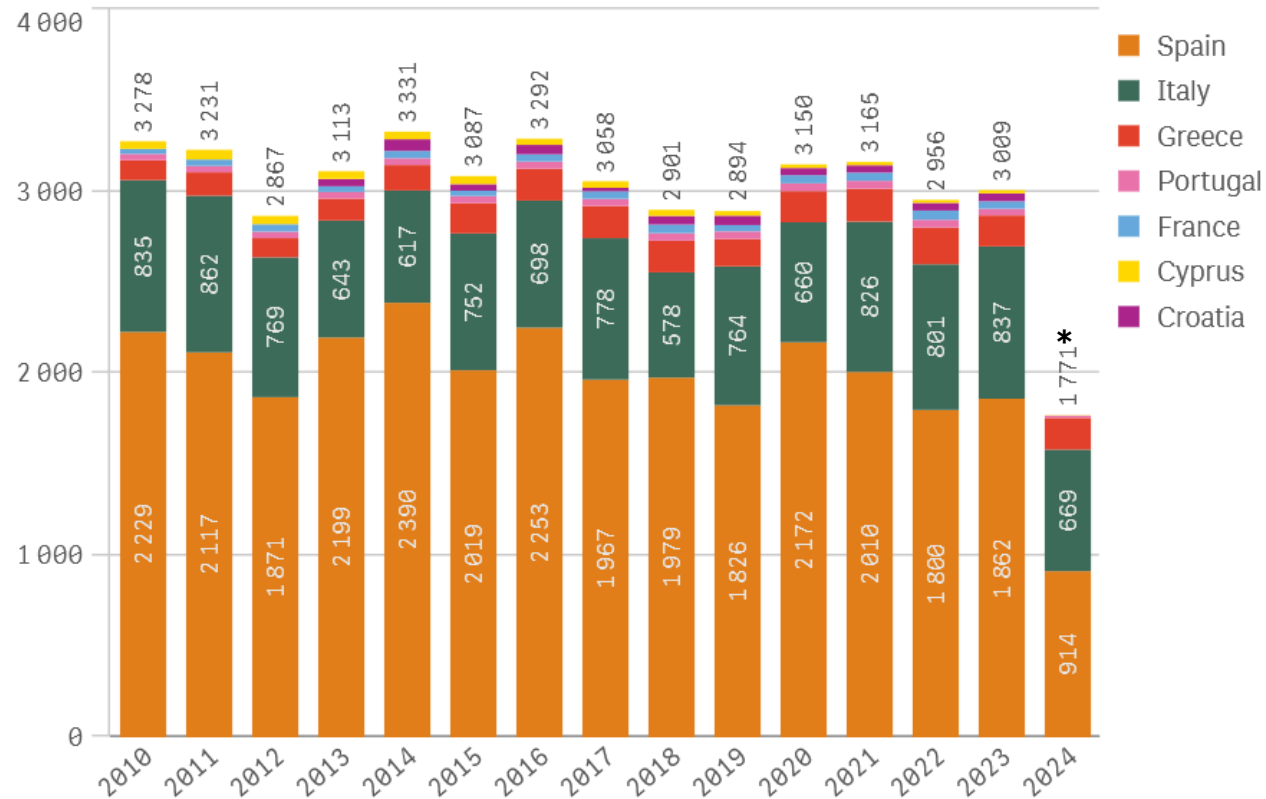

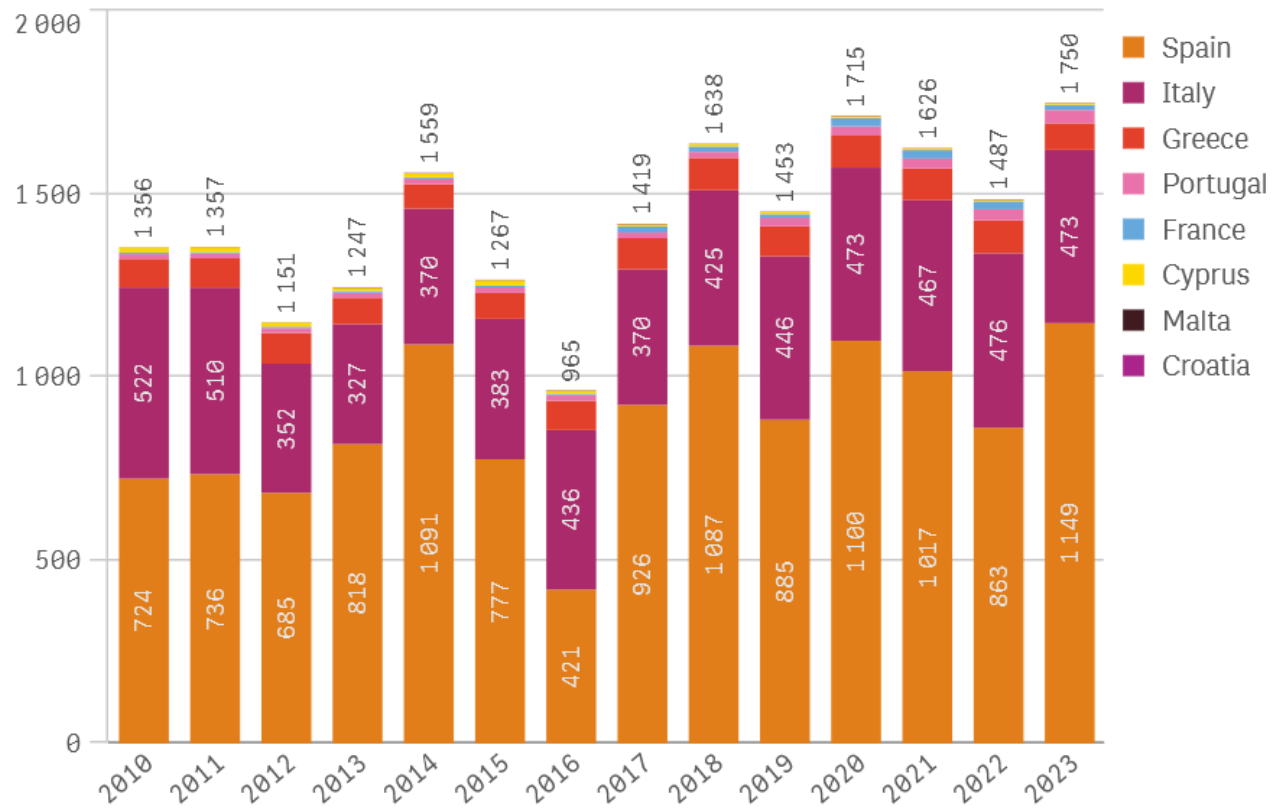

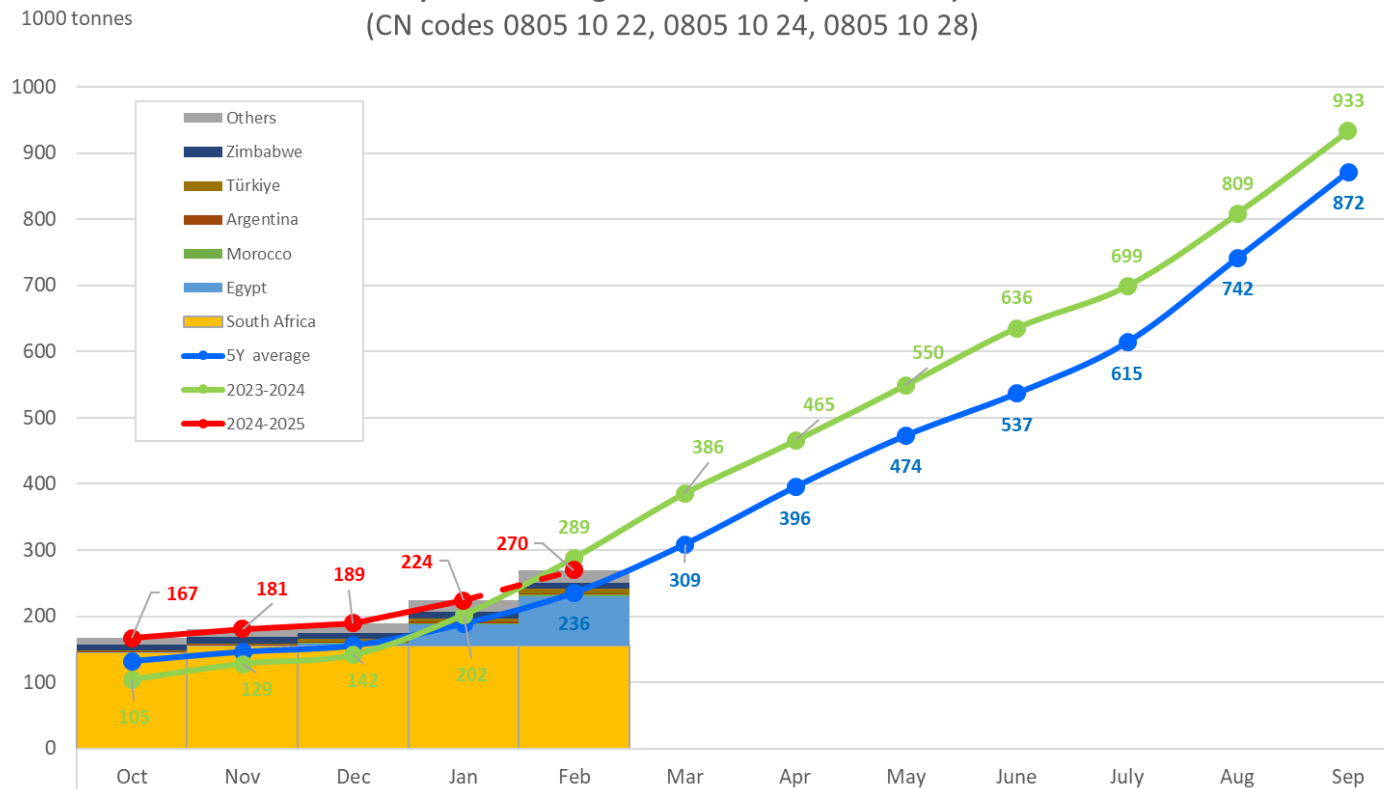
Production of Lemons

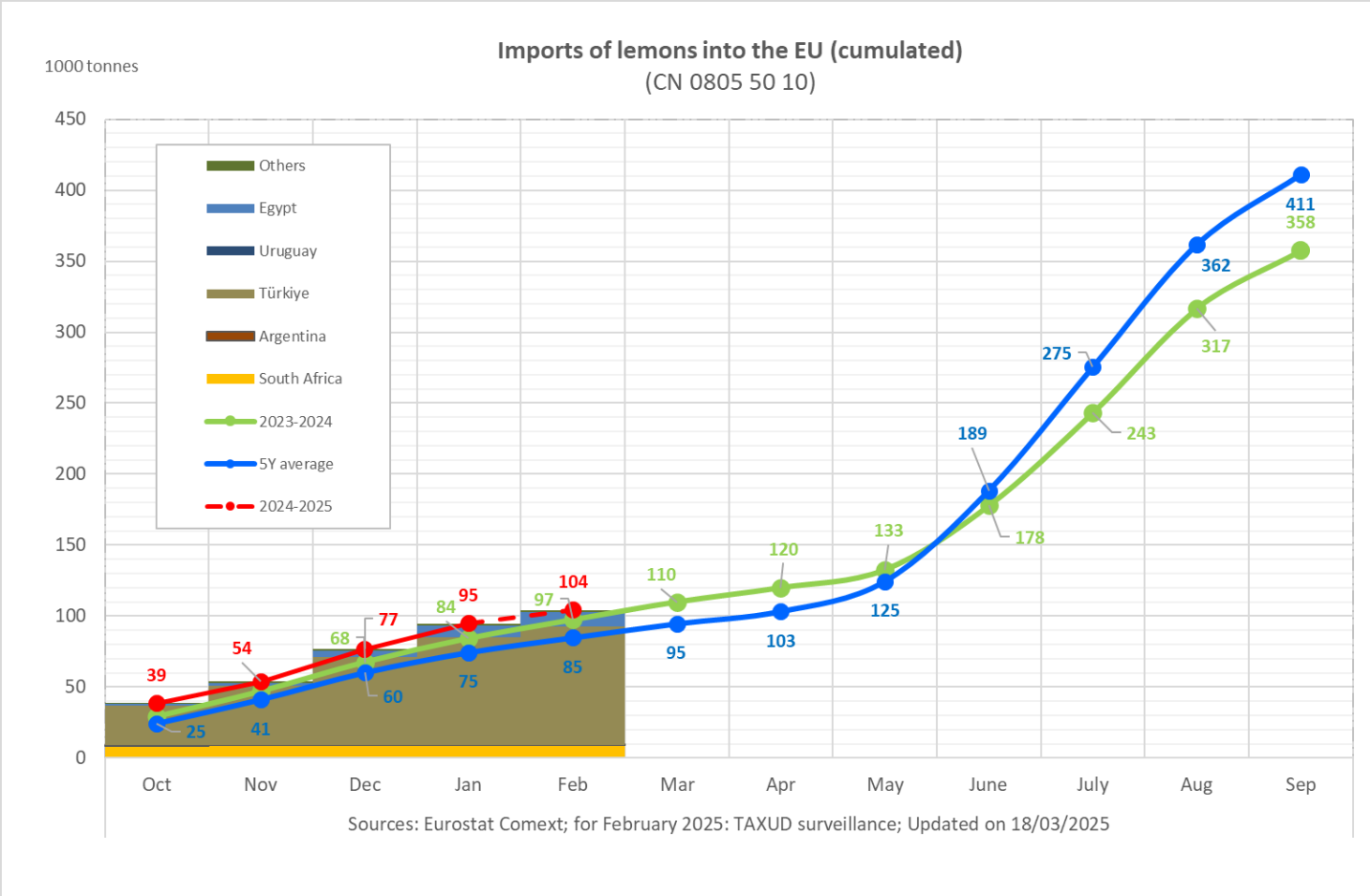

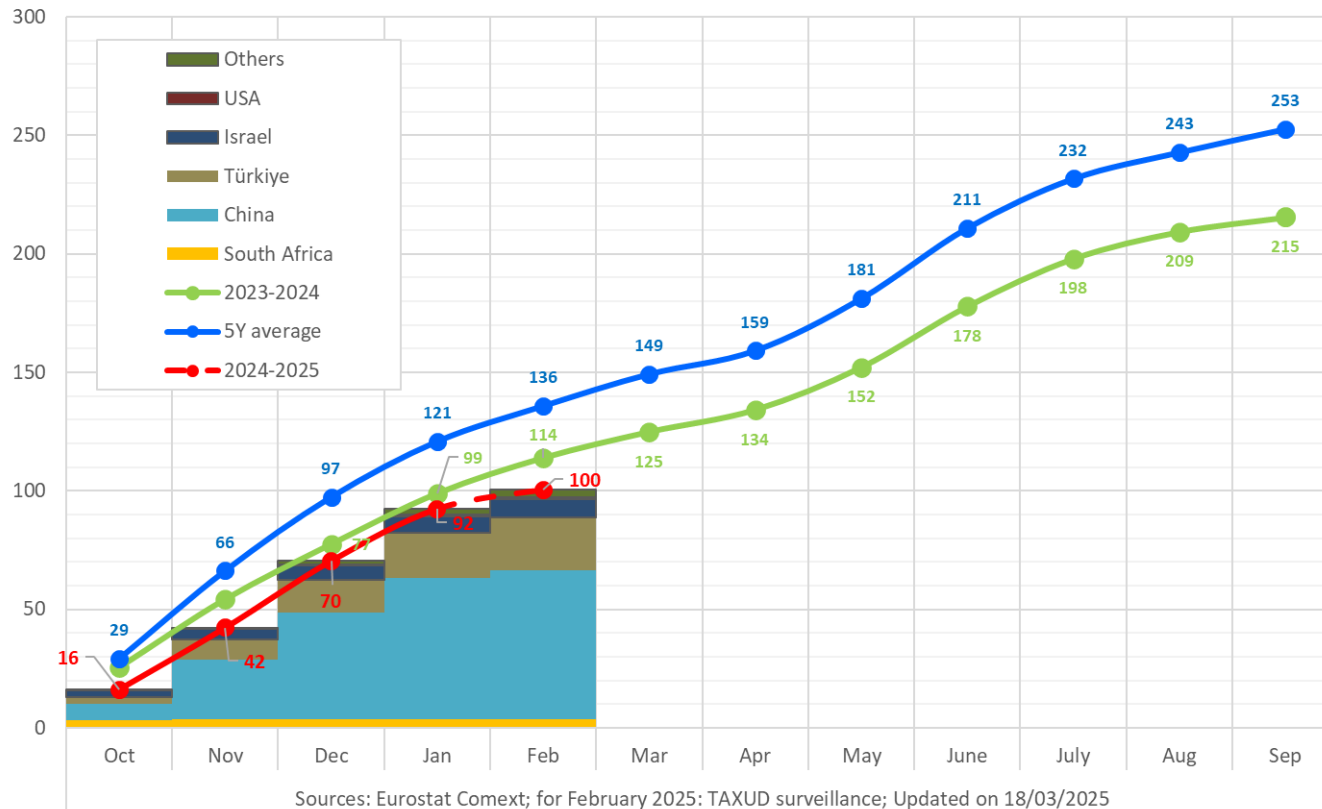

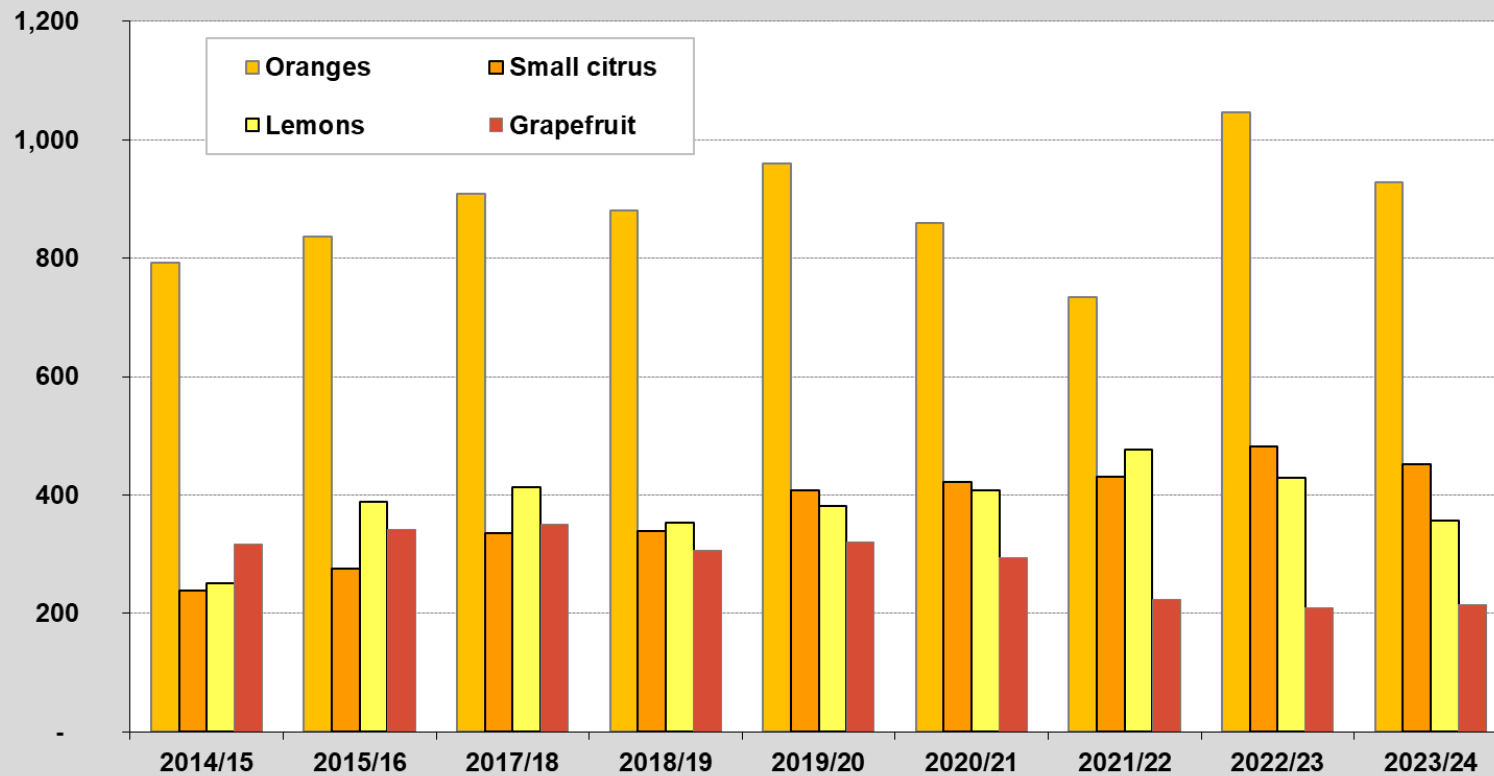

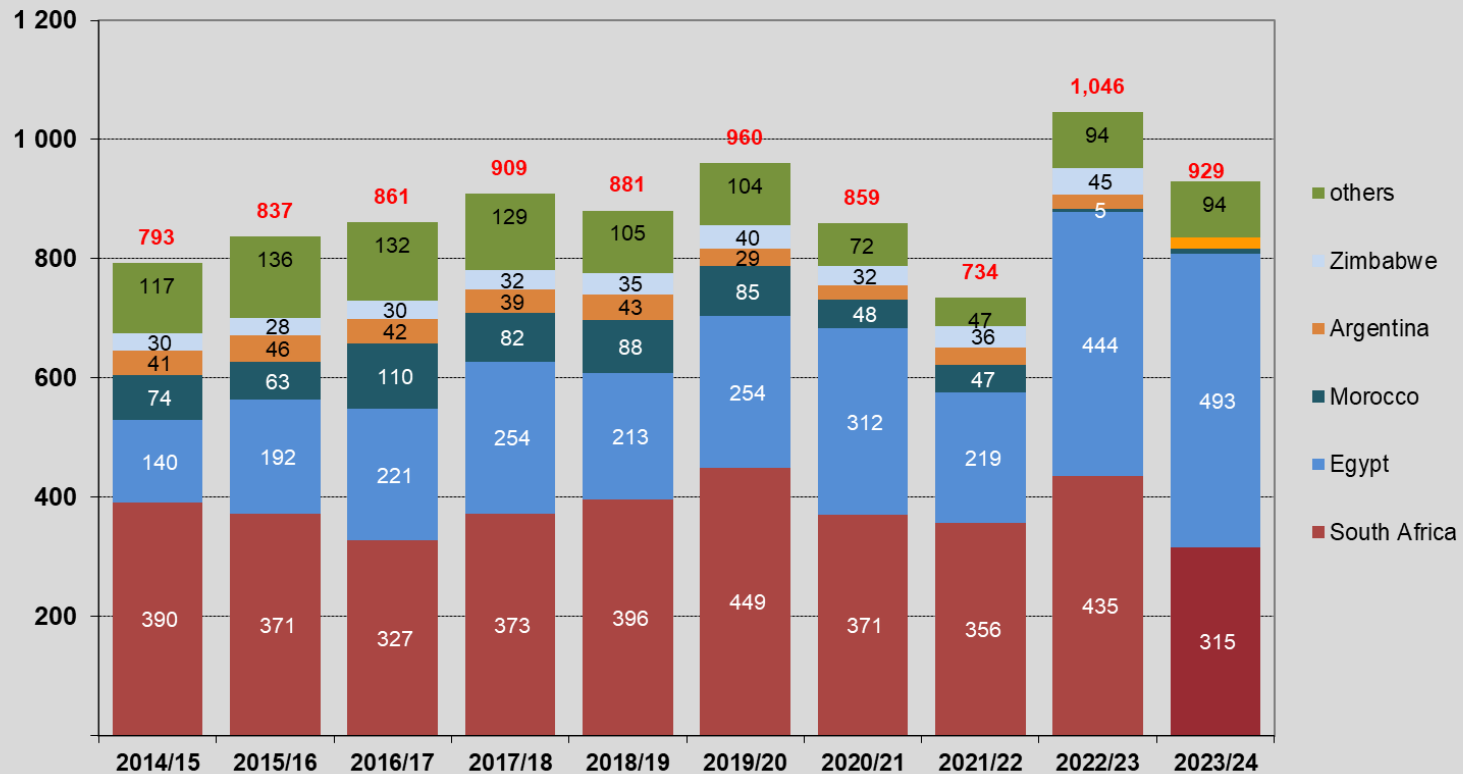

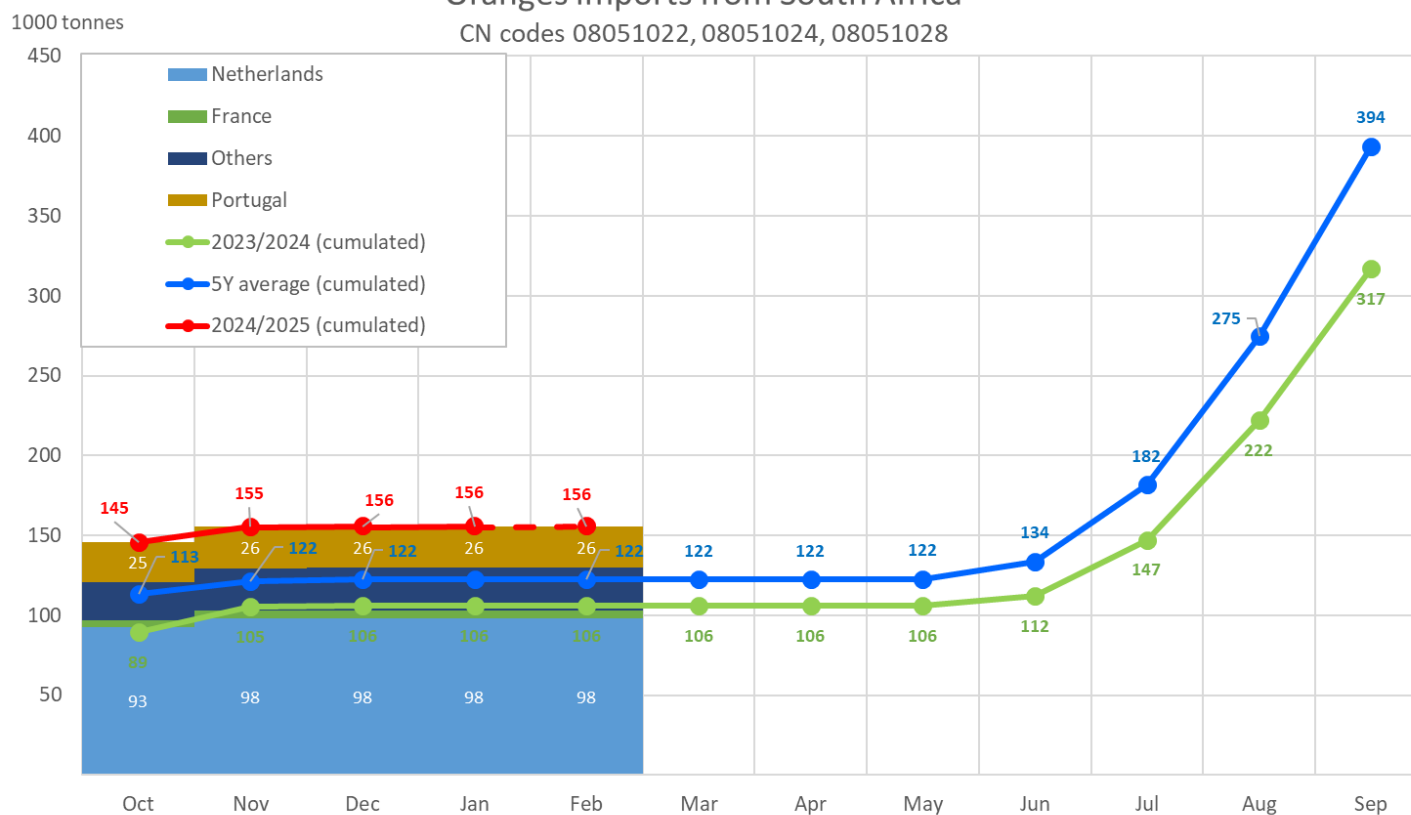
EU orange imports per marketing year (Oct-Sept) [1000 tonnes]

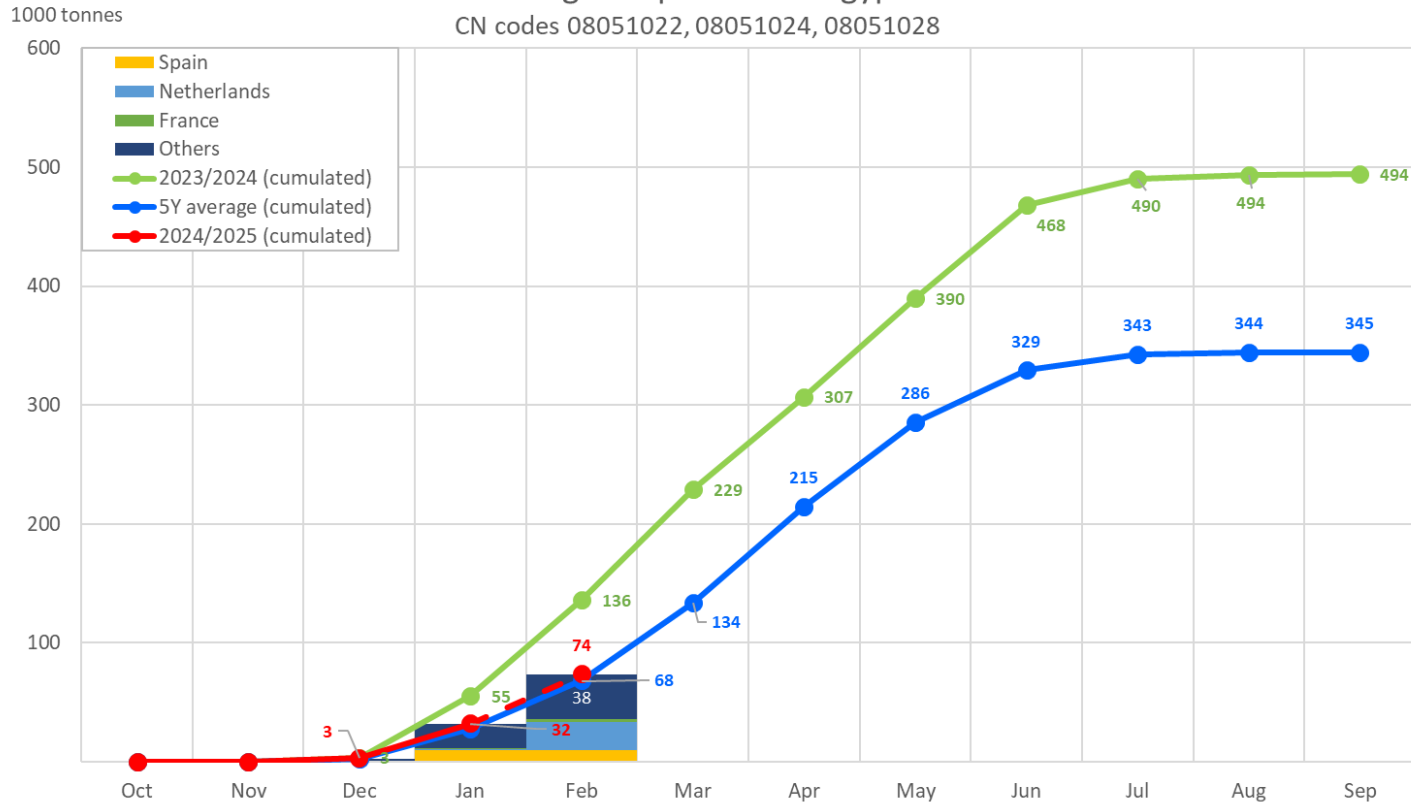

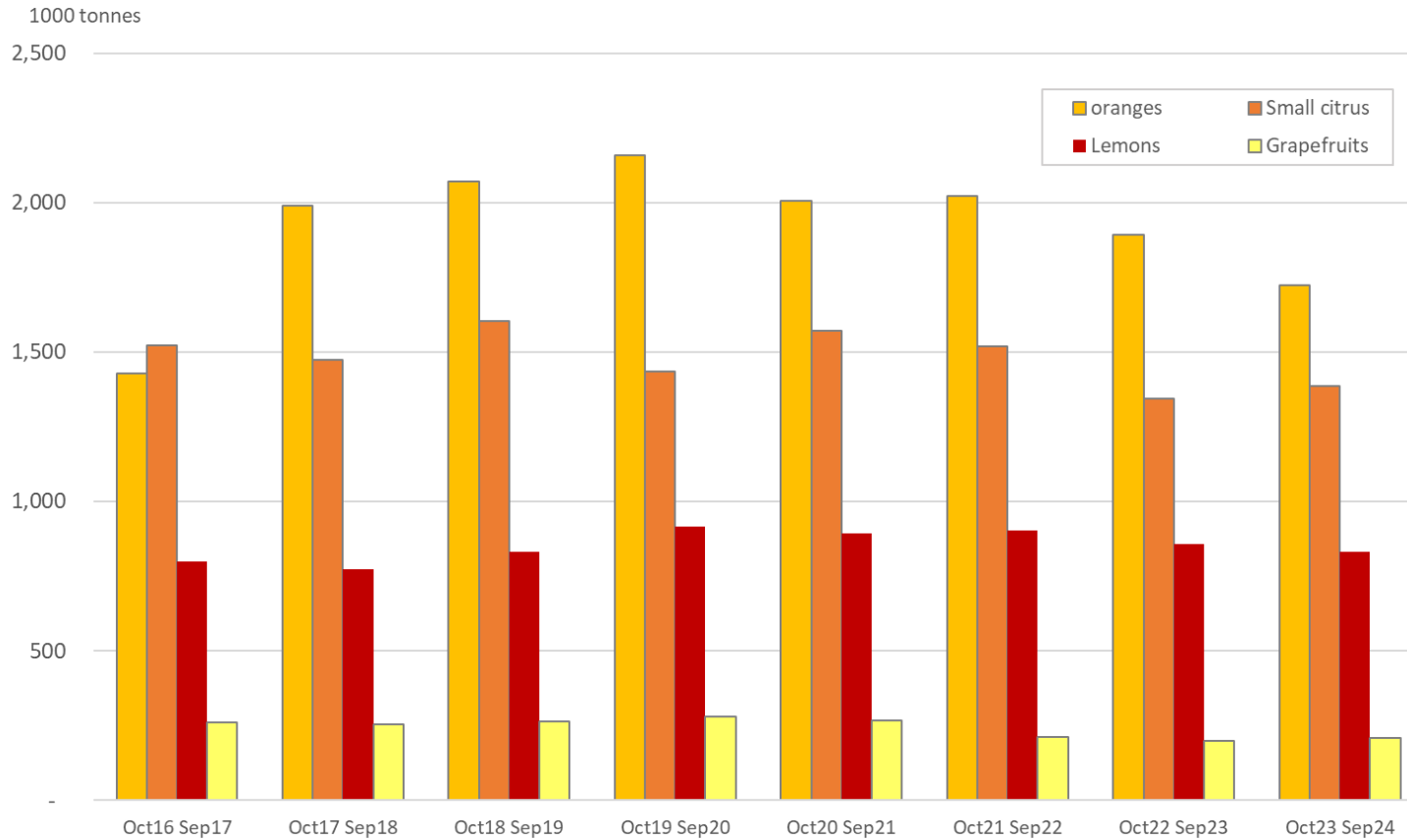

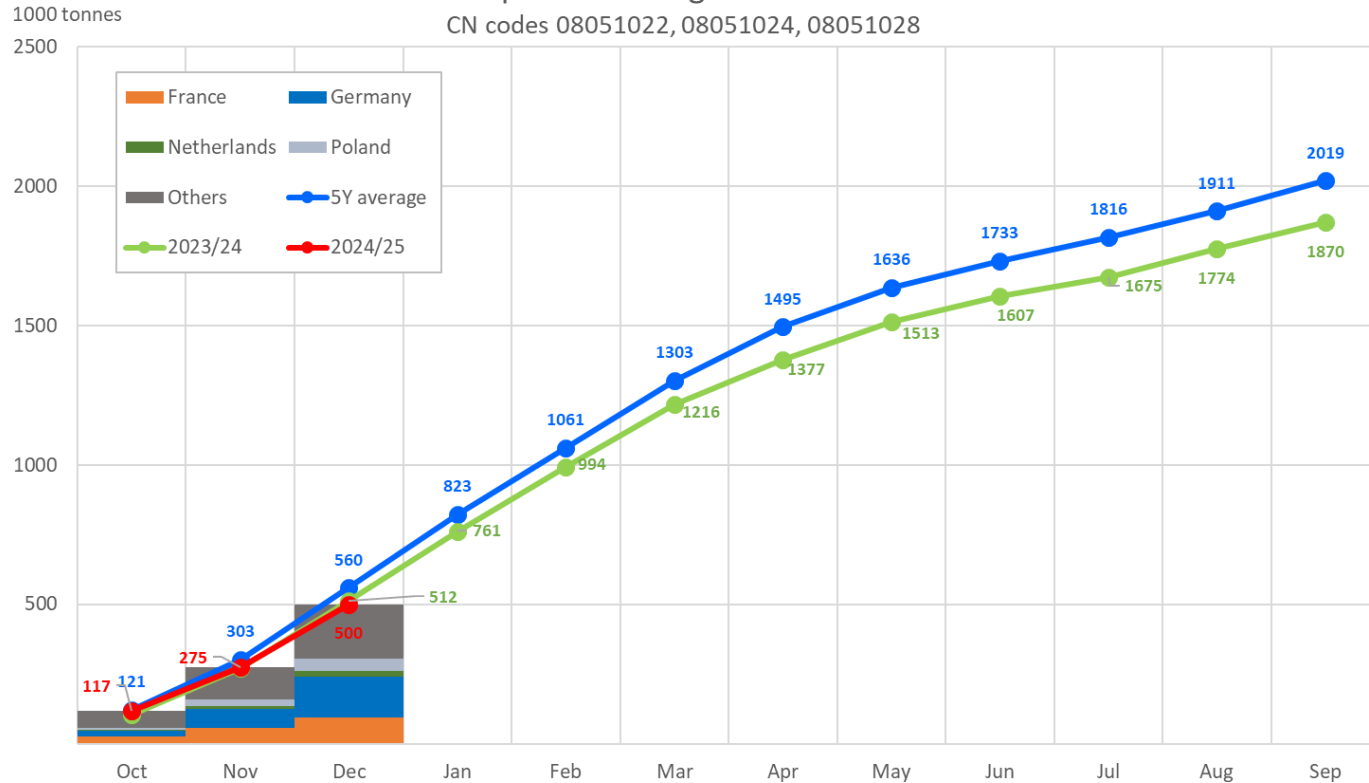
Intra-EU exports of citrus fruits

Intra-EU exports of oranges - Main destinations

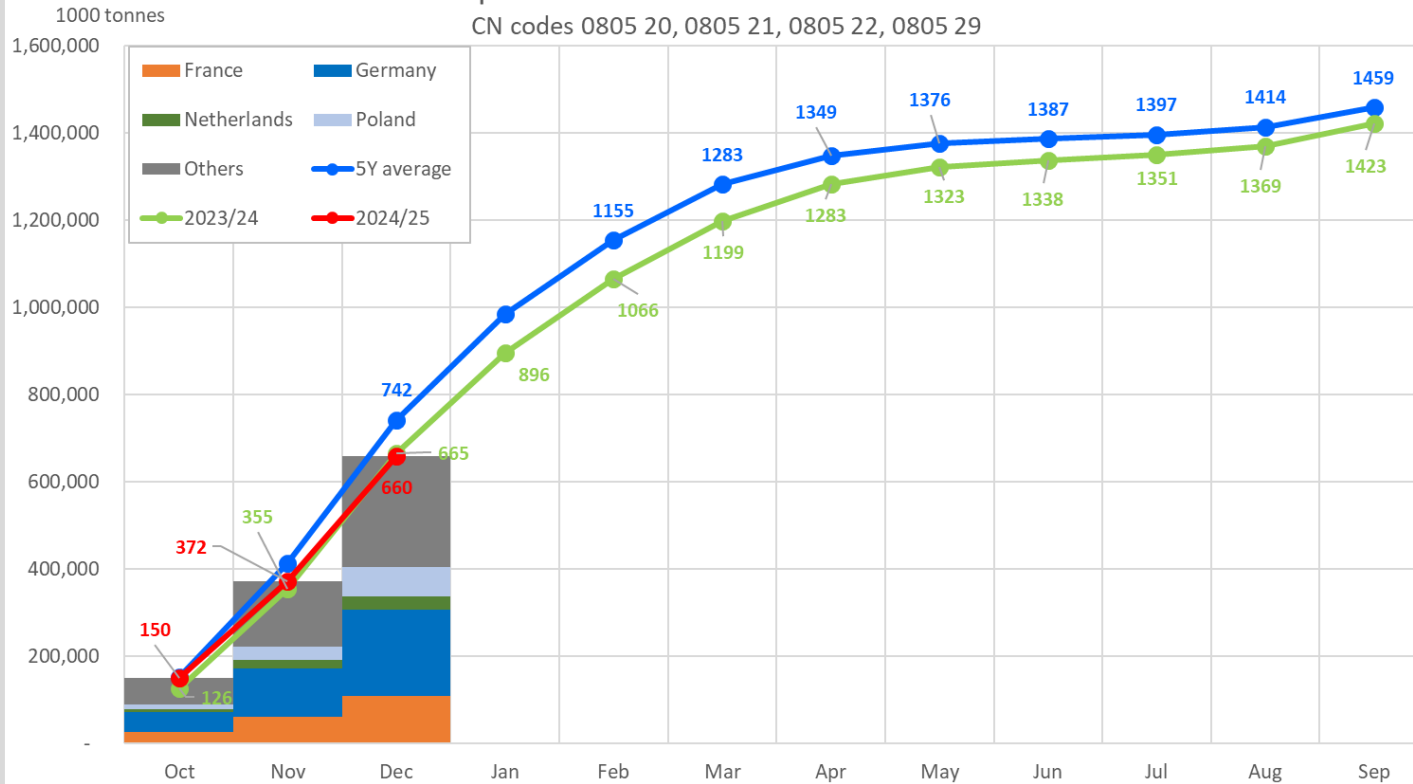

Intra-EU exports of small citrus fruits - Main destinations

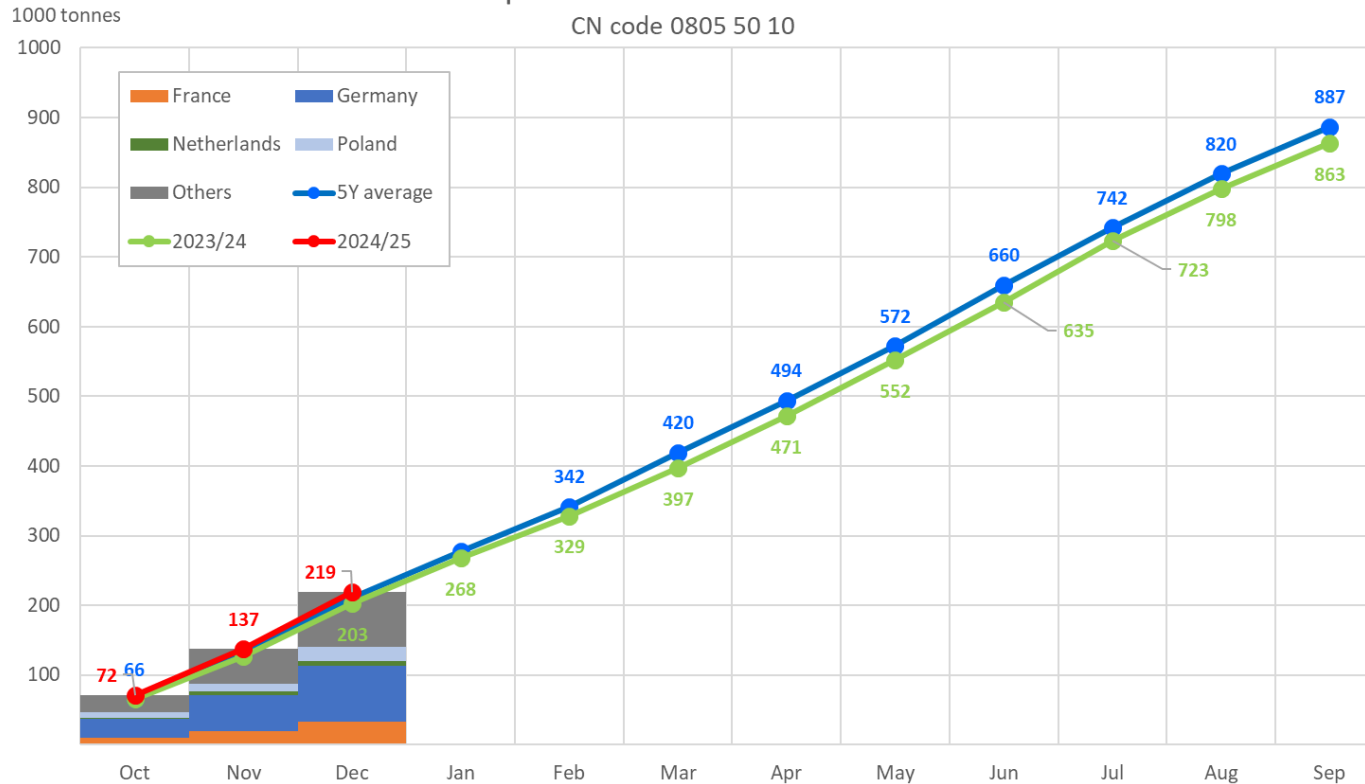

Intra-EU exports of lemons - Main destinations

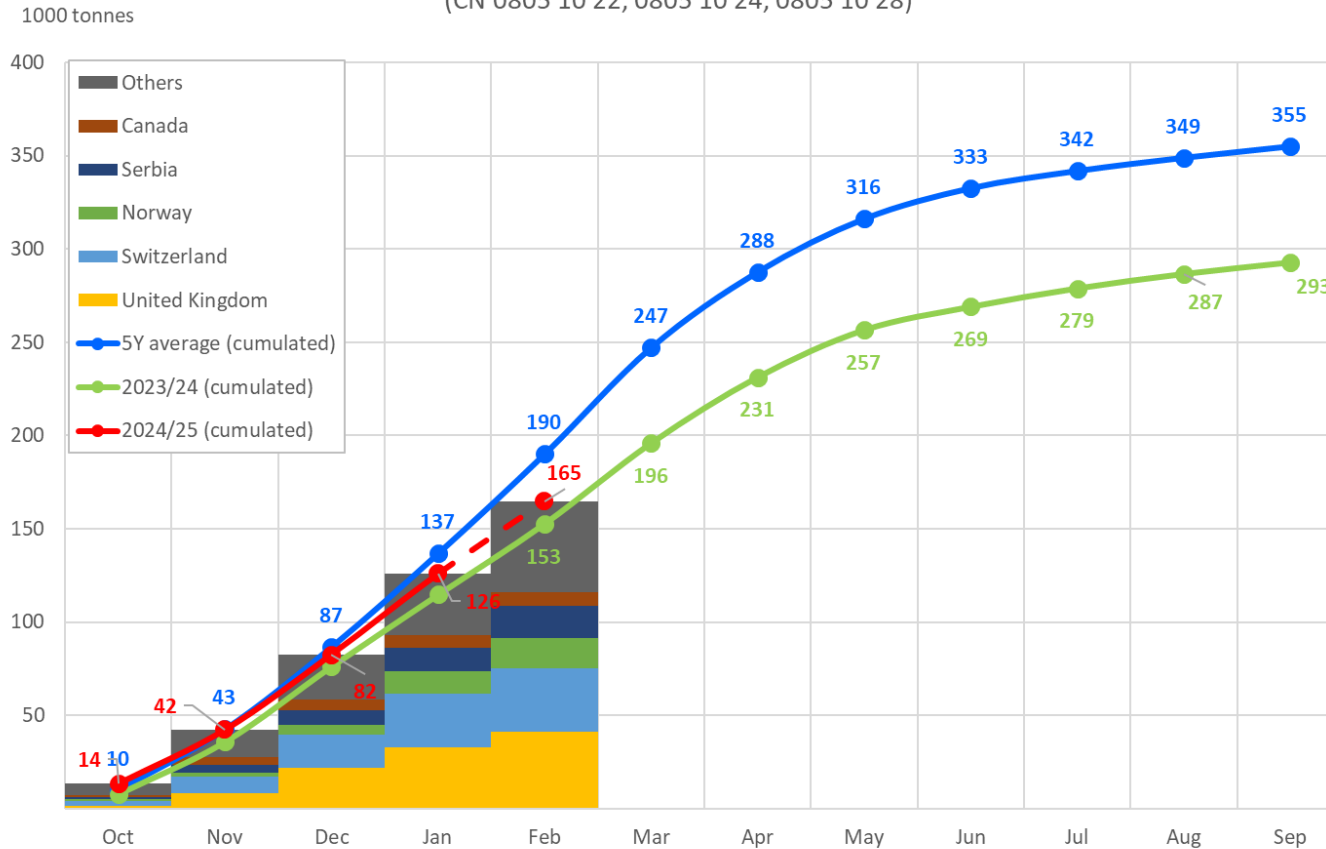

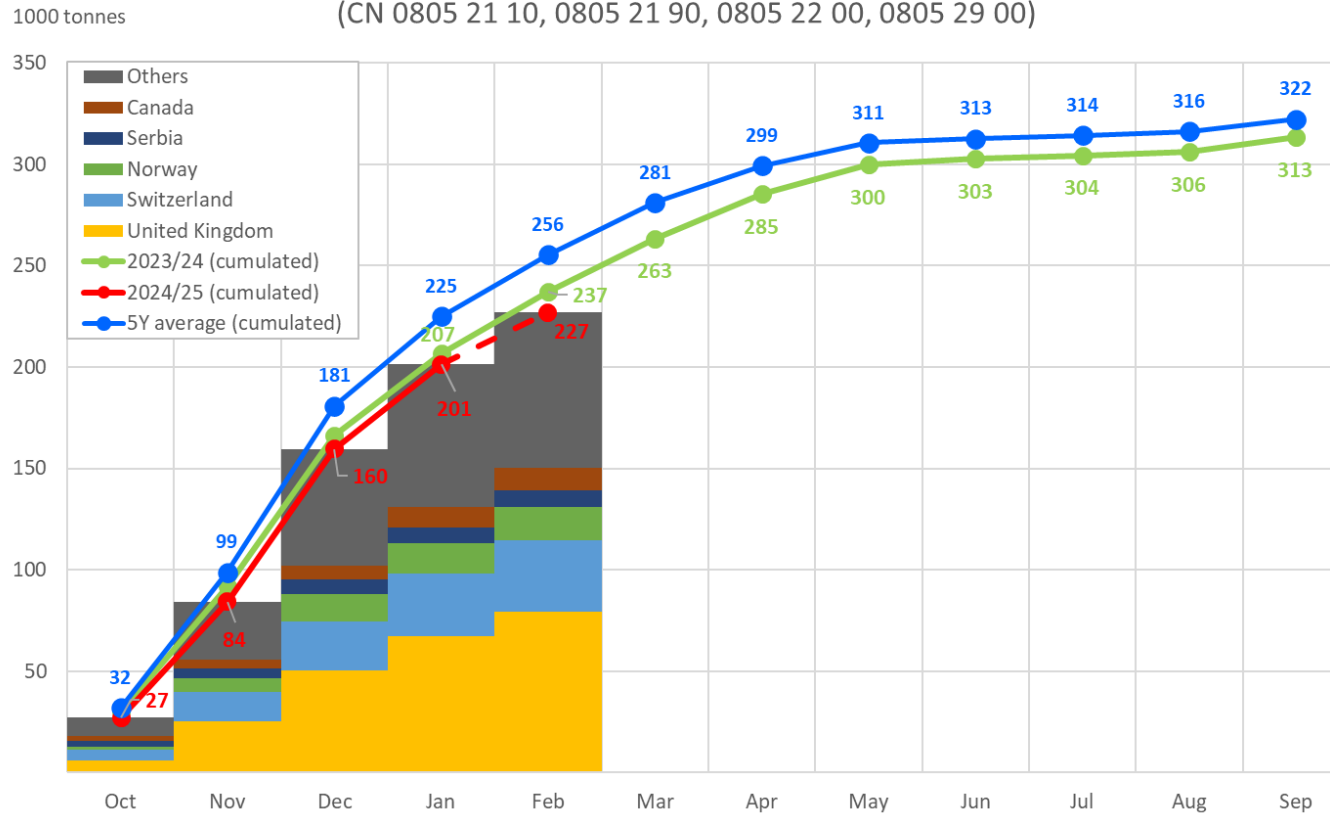
Extra-EU exports of oranges

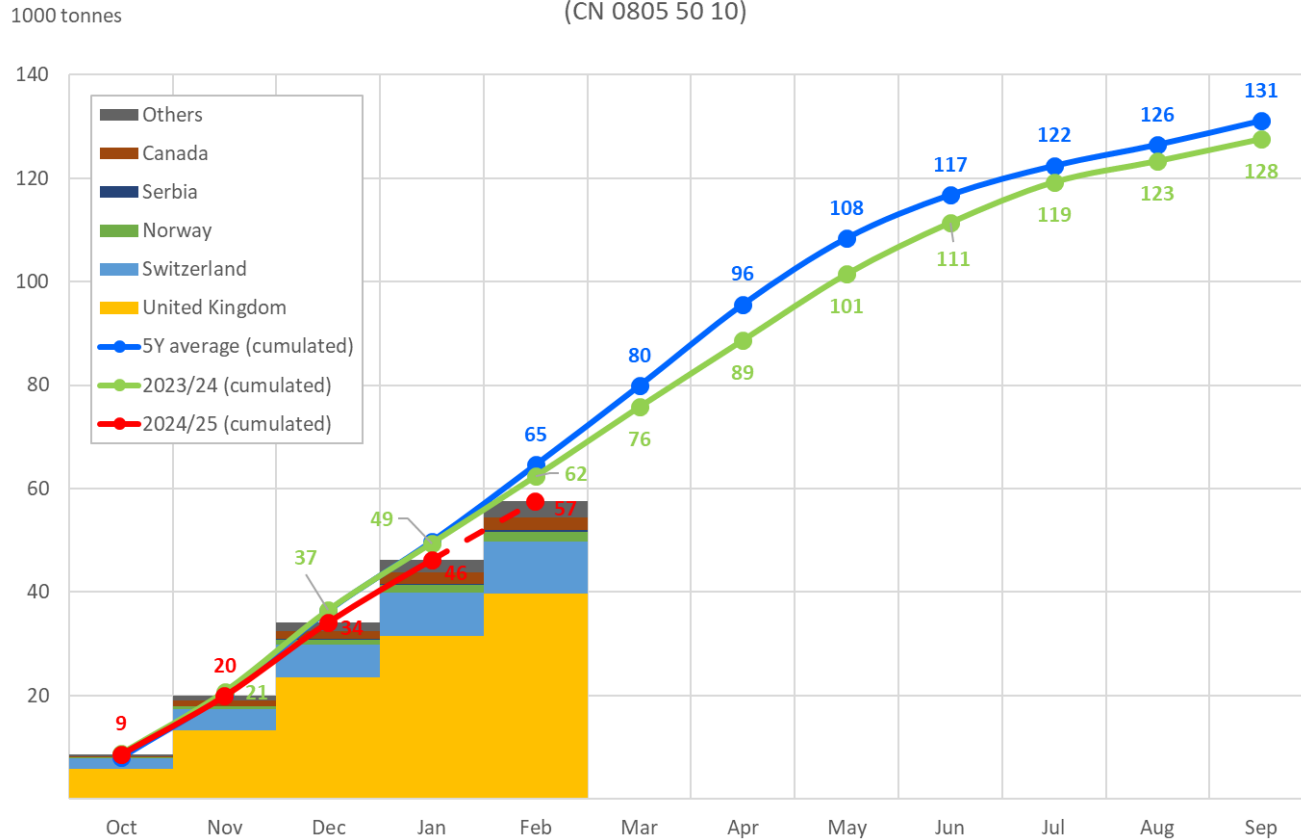

Extra-EU exports of small citrus fruits (CN 0805 21 10, 0805 21 90, 0805 22 00, 0805 29 00)

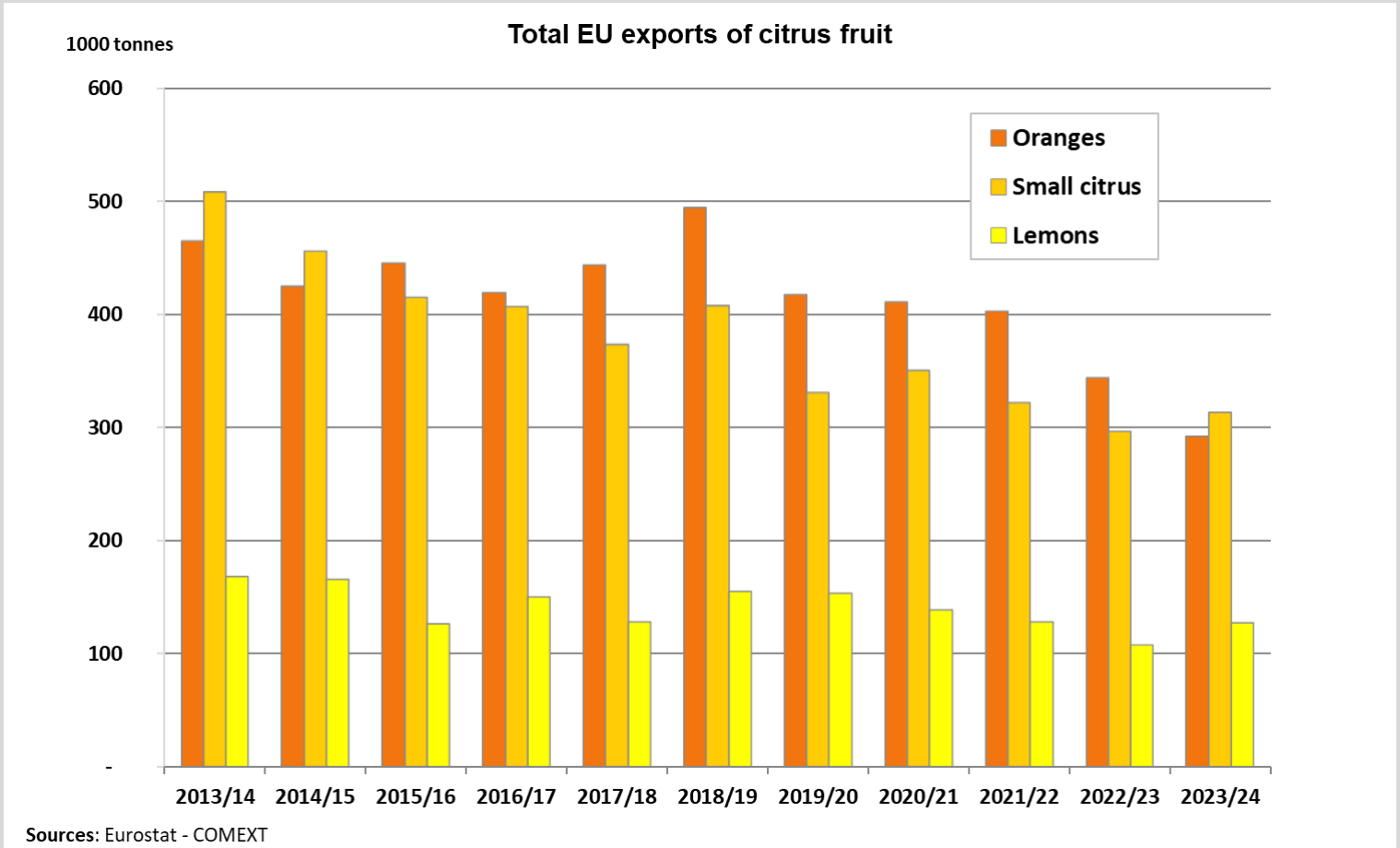

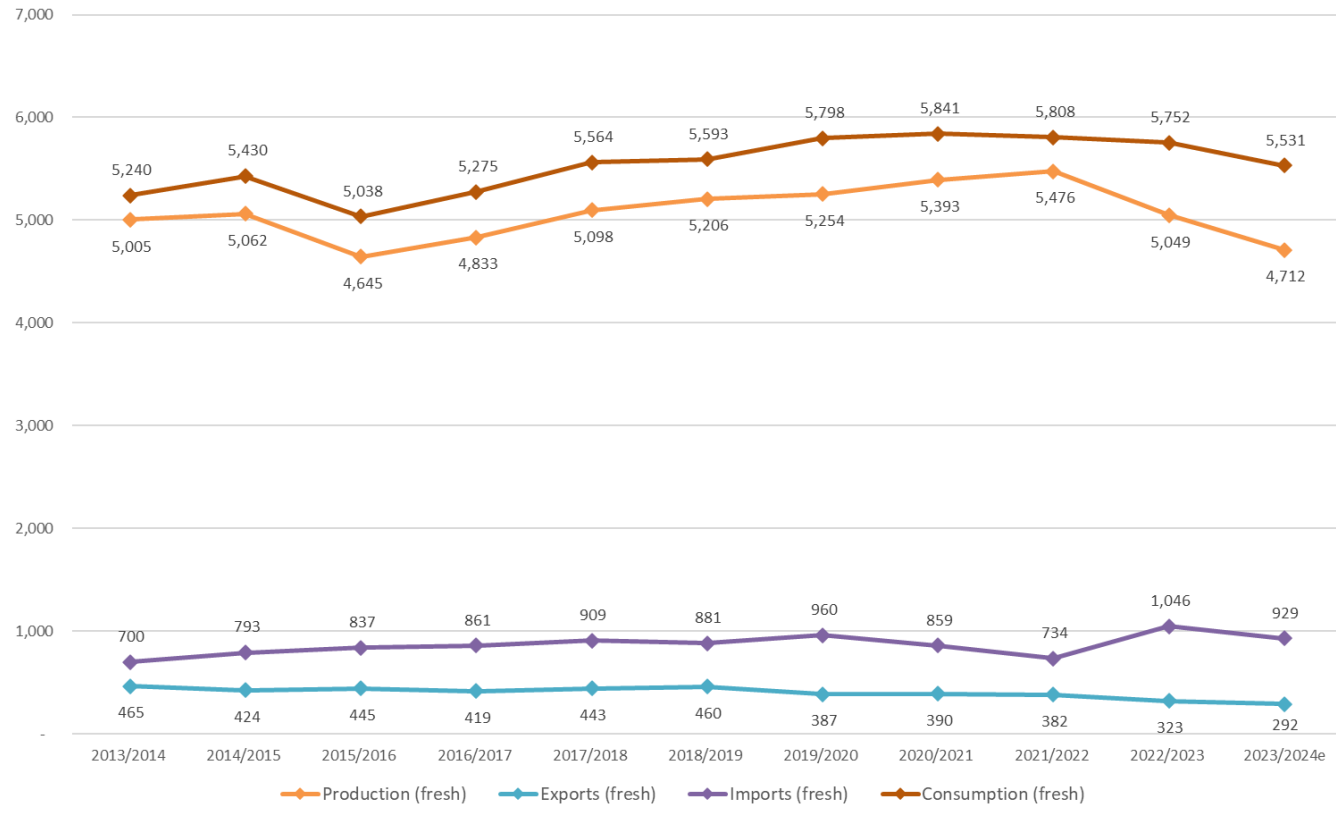
Extra-EU exports of lemons (CN 0805 50 10)



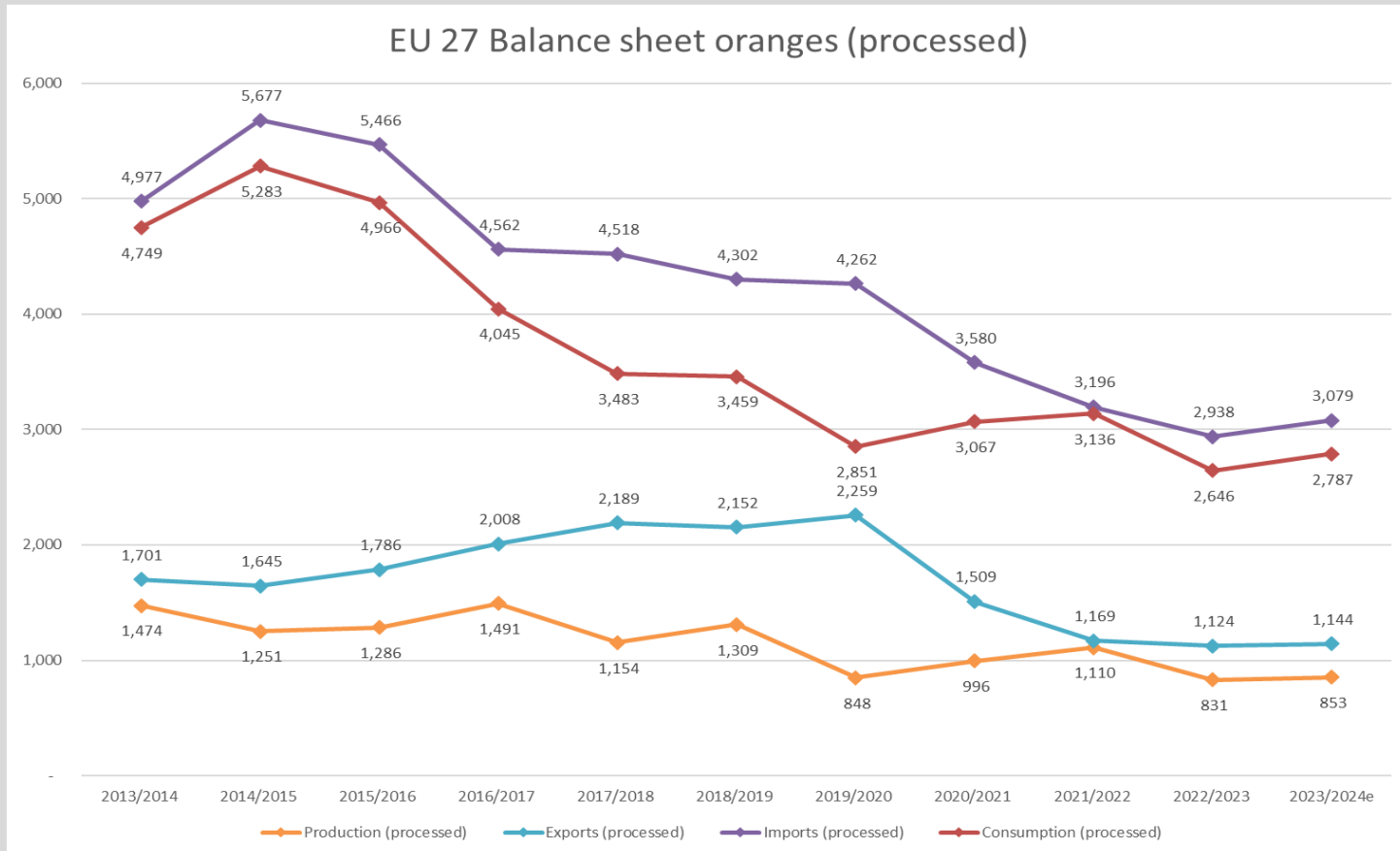

EU 27 balance sheet: oranges (fresh)

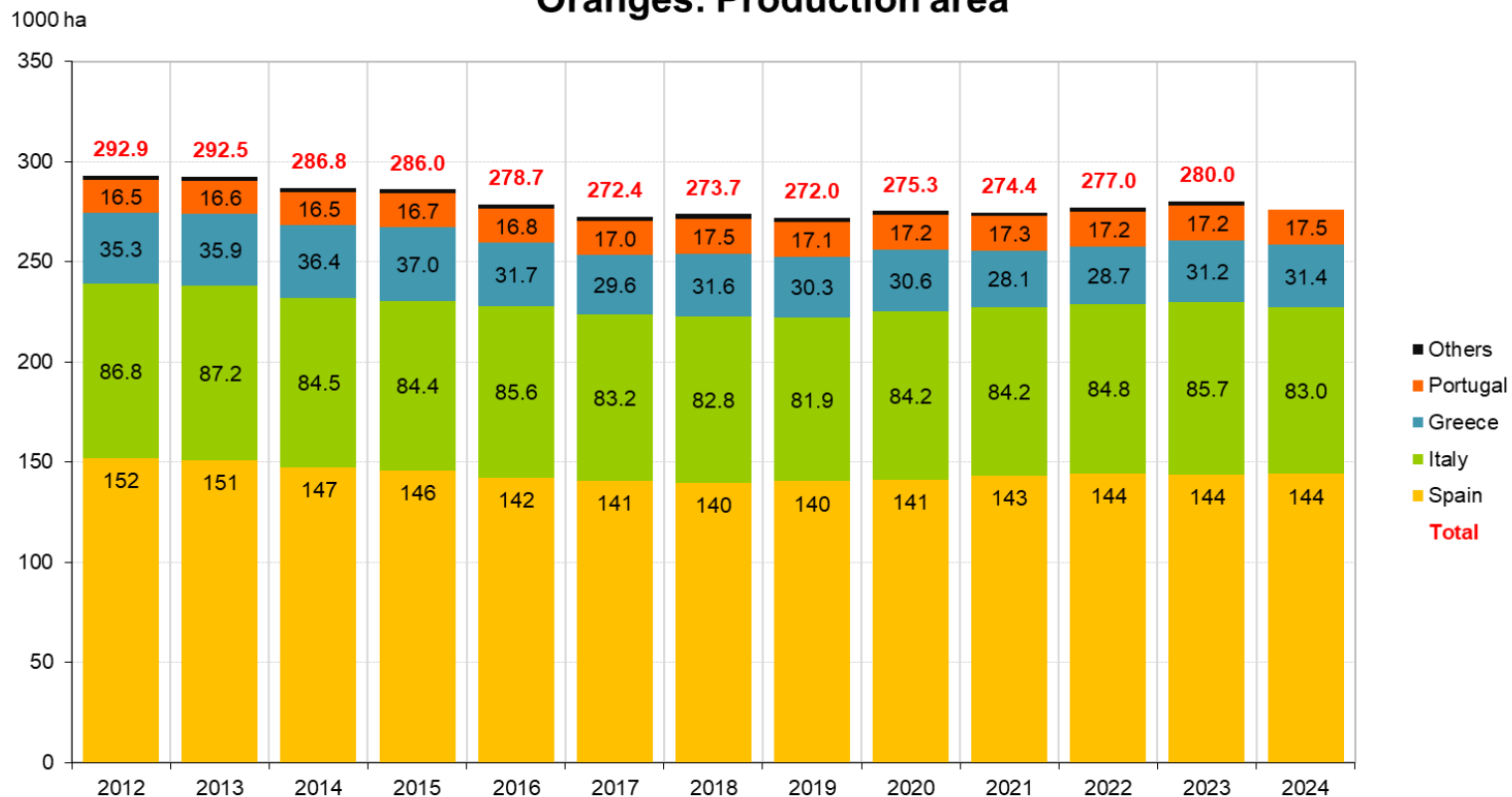

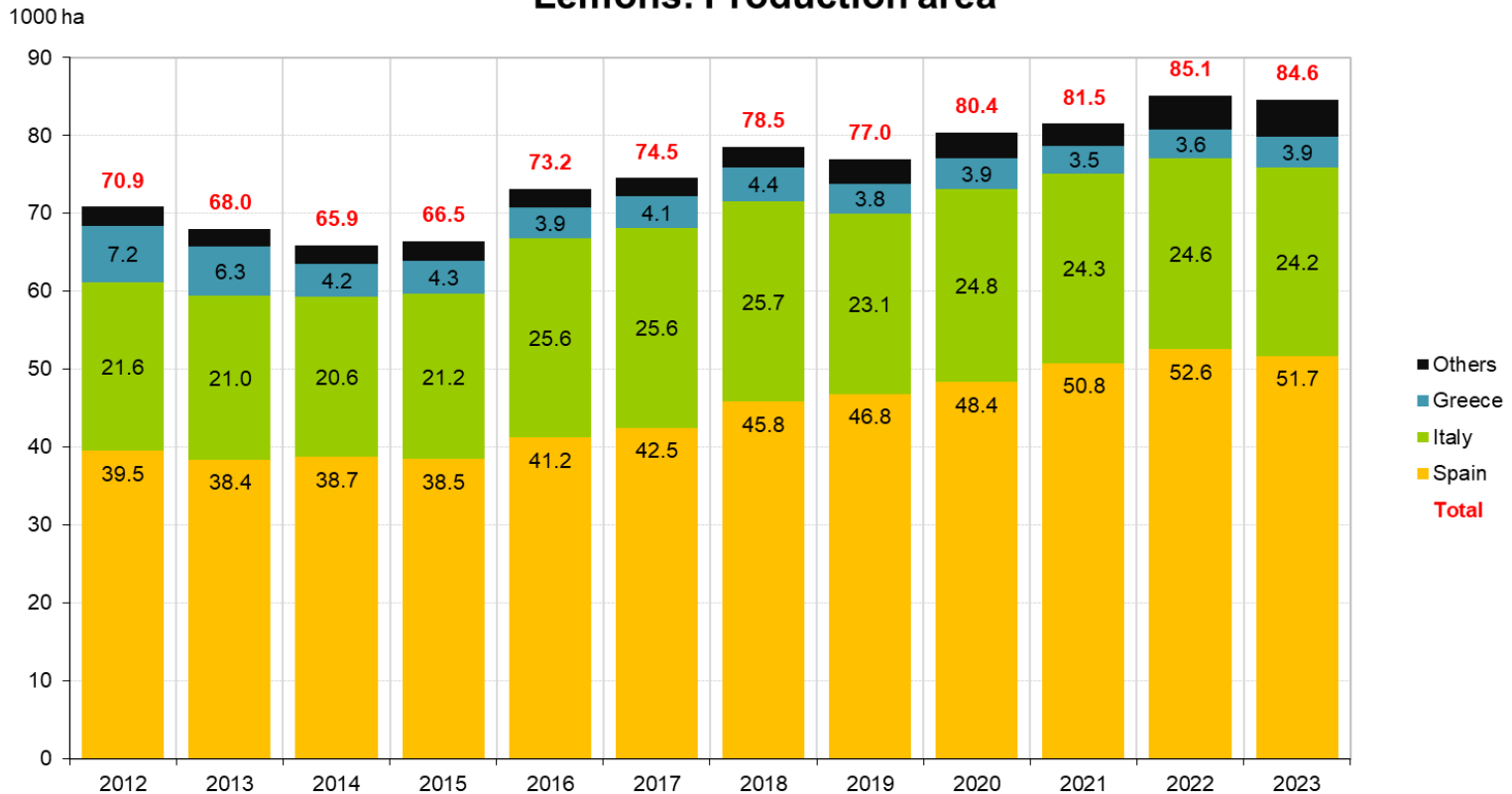

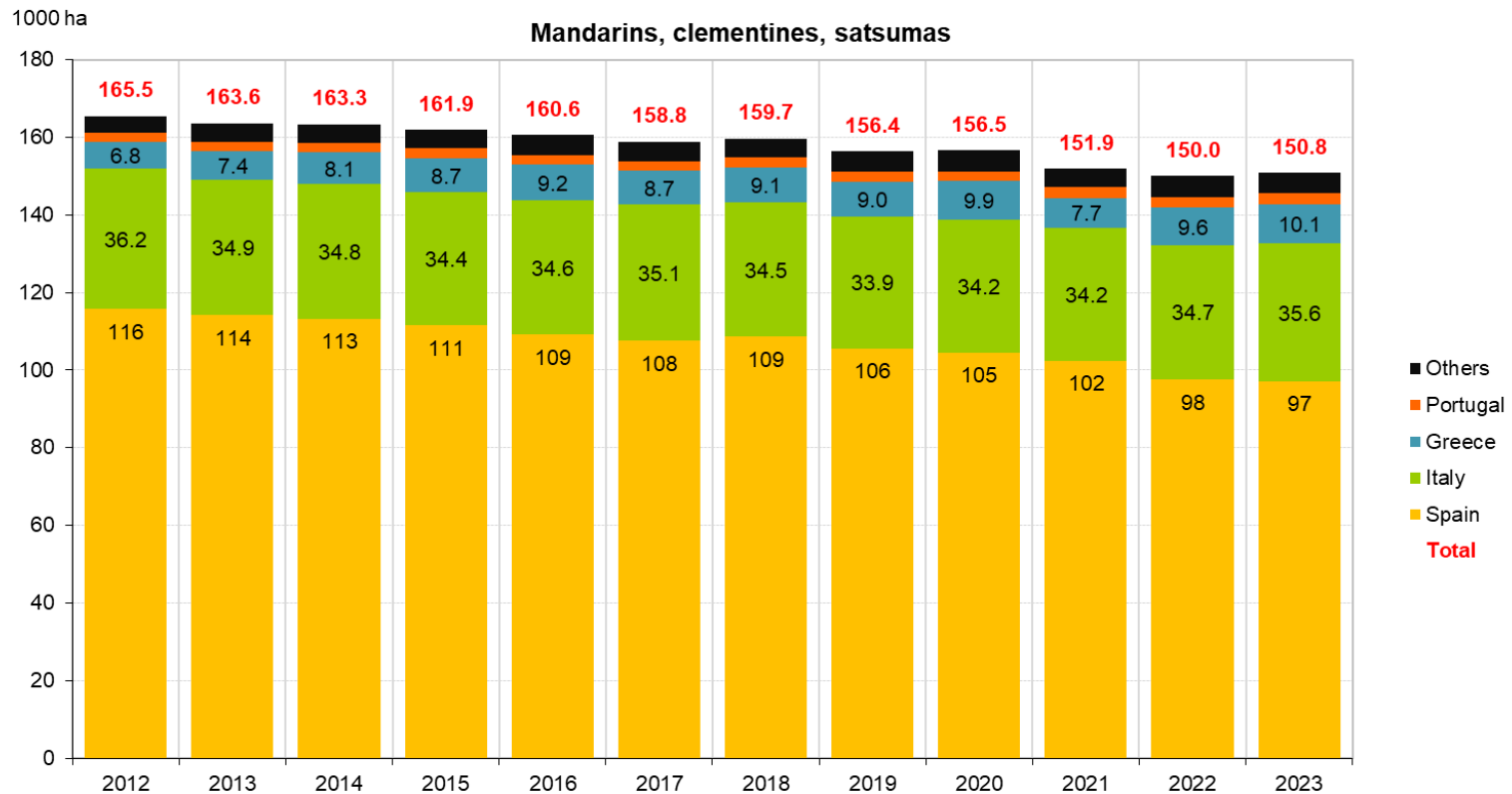

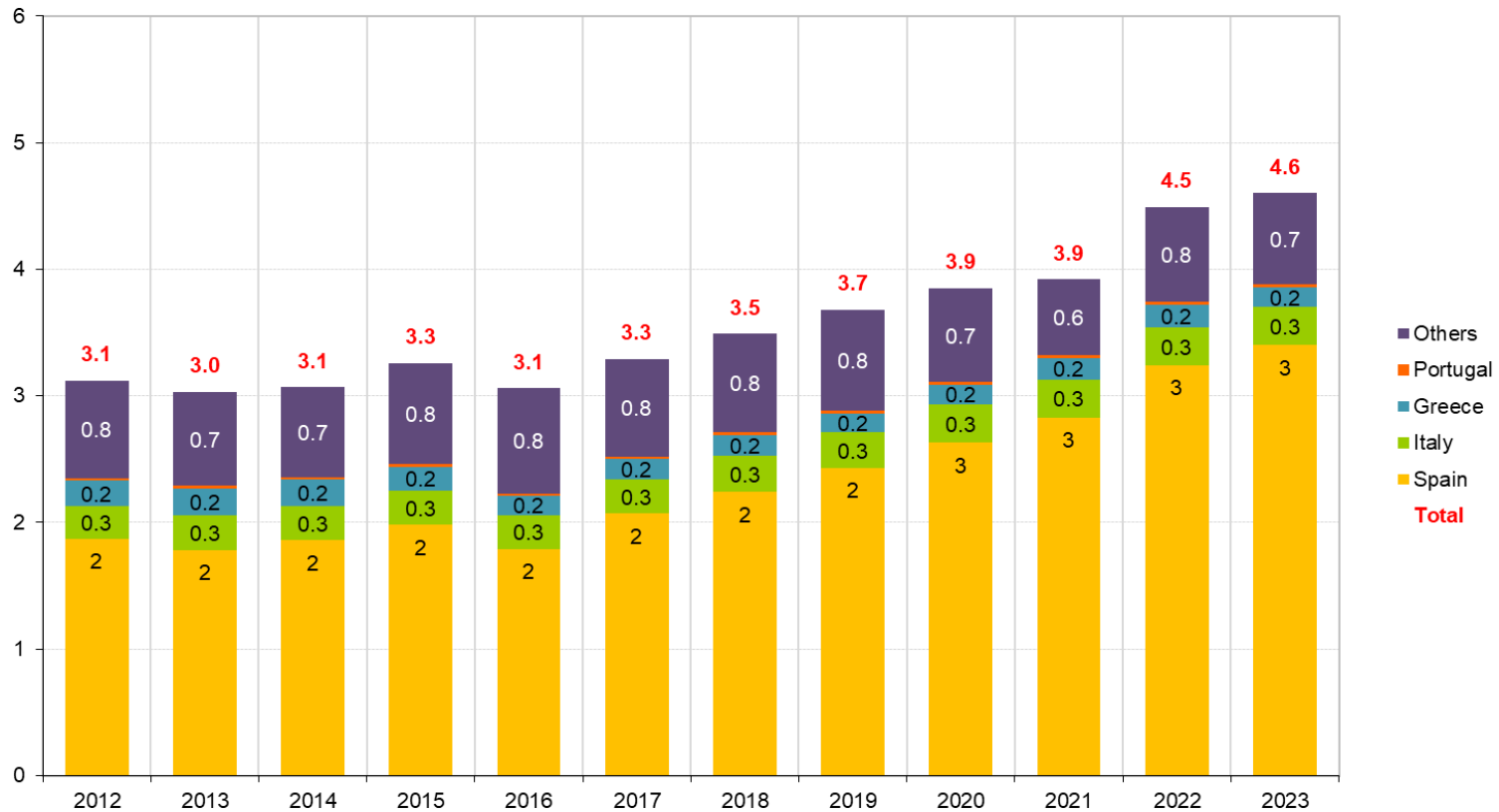
