

JANUARY - JUNE 2020: EU27 AGRI-FOOD TRADE BACK ON AN UPWARD TREND


During the first six months of 2020, EU27 agri-food trade (exports plus imports) reached a value of **EUR 152.9 billion**; i.e. 2.6% more than in January-June 2019. The current growth remained to be driven by higher agri-food exports which increased by 2.7% compared to the corresponding period in 2019, reaching **EUR 90.2 billion**. EU27 imports attained **EUR 62.7 billion**, 2.4% higher than the same six months period in 2019. The monthly values of EU27 exports picked up in June after a fall in May, whereas the monthly value of EU imports have continued to further decrease following the downward trend since March this year.

EU27 EXPORTS: RECORD HIGH TO CHINA AND STRONG GROWTH TO MENA COUNTRIES

On a year over year basis, the highest increases in export values (January-June 2020 compared to January-June 2019) continued to be recorded in trade with **China** (EUR +2 234 million, +36%). Record high exports of pig meat (EUR +1 743 million, + 200%) remained to drive this growth. Other products with highest gains in export values to China continued to be reported for wheat (EUR +278 million from minimal level during the reference period), offal meat (+33%), infant food (+15%) and vegetable oils other than palm and olive oil (+144% - rapeseed/colza oil with low erucic acid).

Saudi Arabia (+484, +29%) came second with EU exports going back to its historical level from 2018, boosted by increased trade of barley, wheat, live animals and some dairy products (butter and other fats). Other top destinations, for which the value of EU27 agri-food exports have increased most since January 2020 (EUR million), were **Algeria** (+385, +31%) and **Morocco** (+350, +37%) - in both cases driven by increased exports of cereals (mainly wheat and meslin) and of certain dairy products (Algeria -milk and cream, Morocco-cheese and curd, butter and other fats). EU27 exports continued to increase significantly as well to Switzerland (+305, +7% - wide range of agri-food products).

For the first six months of 2020, EU27 also recorded major export gains to Ukraine (+236, +21%), Nigeria (+205, +48%) and Iran (+157, +52%) - in both cases primarily driven by higher exports of wheat.



On the other hand, EU27 export values continued to fall most to the **United Kingdom** (-521, -3%), although single market conditions still apply. Similarly to developments in previous months, while decreasing exports to the UK have affected the majority of EU agri-food products, categories

such as wine (-14%), poultry meat (-12%), preparations of fruit and vegetables (-6%), butter (-33%), waters and soft drinks (-9%) declined most in value terms.

Since January 2020, EU27 exports to **the United States** (-440, -4%) have been also steadily declining, primarily driven by a significant fall in exports of spirits and liqueurs (-22%) and wine (-15%). Other product categories that reported relatively important losses include fruit juices (-48%), beer (-8%), and cheese (-12%).

Other destinations, for which the value of EU27 agri-food exports have decreased most since January 2020, were **Hong Kong** (-245, -17%) and **Singapore** (-219, -23%) - in both cases, this was driven by reduced sales of wine, spirits and liqueurs. EU agri-food exports continued to fall significantly to Lebanon (-170, -34% - most EU agri-food categories) that remains deeply impacted by the economic crisis.

The most important EU27 export destinations in the first six months of 2020 were the UK, the USA, China, Switzerland and Japan. More than 51% of EU agri-food exports went to these six countries.

CONTINUED STRONG GROWTH OF EU27 EXPORTS OF CEREALS AND PIGMEAT UNTIL JUNE 2020

Looking at product categories, the increase in export values (January-June 2020 compared to January-June 2019, EUR million) was boosted primarily by continued strong export growth of **wheat** (+1697, +66%- thanks to increased availability, competitive prices and strengthened international demand) and **pig meat** (+1593, +49%- largely to China). Other product categories that reported relatively important gains included **coarse grains** (+427, +39%), pet food (+316, +13%) and infant food (+286, +7%).


On the other hand, biggest losses for EU exports (in value terms) remained to be reported for sectors affected by the economic crisis sparked by the COVID-19, namely **wine** (-1076, -15%), **spirits and liqueurs** (-945 -25%), **raw hides and skins** (-516, -70%), cotton (-275, -37%), chocolate and confectionary (-192, -5%).

The top EU agri-food export products in the period January-June 2020 included wine, pig meat, infant food, wheat, as well as pasta and pastry. These products accounted for more than 26% of EU27 total agri-food exports.

STRONG DECREASE OF IMPORTS FROM THE UK

During the first six months of 2020, the value of EU27 agri-food imports has slightly increased by almost 2.4% (compared to January-June 2019). Continued strong rise of palm oil imports has placed **Indonesia** (+574, +30%) and Malaysia (+326, +38%) as the first and fifth top origin with the biggest increases. **Canada** (+535, +64%) came second with record high imports of rape and colza seeds (+302%) and imports of soya beans (+310%), going back to its historical levels. Other major increases included **Brazil** (+496, +9% - soya beans), and Turkey (+364, +19% - nuts and citrus fruit, preparations of vegetables and fruit). Other origins for which the value of EU27 agri-food imports increased most, were Cote d'Ivoire (+267, +16% - cocoa beans), Morocco (+181, +12% - fruit and tropical fruit), Peru (+175, +17% - tropical fruit) and Argentina (+175, +9% - groundnuts, fruit and citrus fruit).

For the period January-June 2020, the value of monthly imports from the **United Kingdom** continued to fall (-863, -11%). While decreasing imports from the UK have affected the majority of agri-food products, the highest losses were reported for spirits and liqueurs (-26%), pasta and pastry (-16%), and chocolate and confectionary (-13%). Other countries, for which EU27 imports decreased most in value terms, include **Ukraine** (-328, -10%; decline largely driven by falling imports of corn, wheat and oilcakes); **the United States** (-304, -6% - mainly driven by reductions in soybeans and oilcake imports); India (-241, -16% - other feed and feed ingredients, oilcakes); and Australia (-154, -16%; oilseeds, wool).



The top EU agri-food origins in the six months period include the UK, Brazil, USA, Ukraine and China. These countries have accounted for almost 38% of EU27 agri-food imports.

EU27 IMPORT INCREASE DRIVEN BY FRUIT, PALM OIL AND OILSEEDS

Looking at product categories, since the beginning of 2020, the highest increases in import values were reported for **fresh and dried tropical fruit** (+768, +12%), oilseeds other than soybeans - mainly **rapeseed and sunflower seeds** (+489, +27%), **palm and palm kernel oil** (+478, +19%), fatty acids and waxes (+433, +37%) and fruit fresh or dried (+358, +11%).

On the other hand, imports of **coarse grains** (-664, -29%), **spirits and liqueurs** (-295, -18%) **oilcakes** (-262, -8%), raw tobacco (-201, -15%), and bovine meat (-184, -19%) have continued to decrease most in value terms. Furthermore, EU27 import values of wool, infant food and meat preparations have remained on a downward trend.

The top EU agri-food import products in the first six months of 2020 included fruit (tropical and other than citrus), unroasted coffee and tea, oilcakes and palm and palm kernel oil. They have accounted for nearly 32% of EU27 agri-food imports.

As a result, the agri-food export surplus during the period January-June 2020 stood at EUR **27.4 billion**, an increase by 3% compared to the corresponding period in 2019, despite the Covid-19 crisis. This net trade balance remained boosted by continued strong exports of **pig meat, wheat and coarse grains**. By contrast, the EU27 net trade balance further deteriorated to reach negative values for **raw hides and skins, citrus fruit and ethanol**.
