Note to the reader

The latest available consolidated trade data at EU level cover market developments in January 2023. Monthly figures can be compared with the previous month. Year-to-year change compares the cumulative trade since the beginning of the year with the same period in the previous year.

The trade figures are expressed in values, except when specifically mentioned. The unit value is the average price of products traded in the period concerned (trade value at the border divided by quantity registered).

HIGHLIGHTS:

EU agri-food trade slow down in January 2023

In January 2023, agri-food trade (exports + imports) reached EUR 31.8 billion, after a sharp decline in December. This downward trend after the bump at the end of the year has been a usual pattern in recent years. Still, exports amounted EUR 18 billion and imports were at EUR 13.8 billion.

The EU trade balance for cereal preparations and milling products showed the most important surplus of all agri-food products (+EUR 1.4 billion). For cereals, the trade balance was also positive at +EUR 619 million. Looking at the beverage industry (wine, spirits and liqueurs and other beverages), the EU trade balance in January reached EUR 2.0 billion. Food industry products (including mixed food preparations and confectionery and chocolate) had a positive trade balance of EUR 1.7 billion.

Conversely, the EU had a negative trade balance in the meat sector. In January, the trade balance was negative for beef and veal (- EUR 1.8 billion), sheep and goat meat (- EUR 1.3 billion), poultry and eggs (- EUR 1.2 billion) and for pigmeat (- EUR 695 million).

EU AGRI-FOOD EXPORTS

DECLINE IN EU EXPORT VALUES AT THE BEGINNING OF THE YEAR 2023

In January 2023 **EU agri-food exports** declined compared to December but still reached a value of **EUR 18.0 billion** (+EUR 2.3 billion compared to January 2022, +15%). The United Kingdom remains by far the first destination of EU agri-food exports, representing 22% of the total. The United States is second, with 11% and China remains third with 7%.


EU exports to **the UK** amounted EUR 3.9 billion. Compared to January 2022, exports to UK increased by EUR 0.6 billion. This is a 17% increase year-to-year. Export values of cereal preparations and mixed food preparations to the UK were 35% and 14% higher than January 2022, respectively. Wine exports to the UK were down by 9% compared to January 2022 and reached the lowest point for the past two years. This is driven mainly by a decline in quantities.

EU exports to **the US** totalled EUR 2.0 billion in January 2023 (+8% compared to January last year). For wine, the leading export product to the US, values continued their decline seen in the past months, since their highest point in May 2022. For spirits and liqueurs, despite the rebound in January, EU exports are still at a two-year low. For both wine and spirits, this is due to a decline in volumes exported. Regarding cereal preparations and mixed food preparations, EU exports to the US reached prewar levels, in both quantity and value terms.

EU exports to **China** in January 2023 reached EUR 1.3 billion. It is a 19% increase year-to-year (+EUR 201 million). Despite the increase of EU pigmeat exports along the second semester of 2022, monthly exports in January 2023 fell by 16% (-207 thousand tonnes compared to December 2022). It is slightly below last year in January (-4%). EU exports of cereal preparations and milling products are keeping their upward trend over the past year (+57% year-to-year in value terms, +11% in quantity).

MOST OF EXPORT VALUES STILL HIGHER THAN JANUARY 2022

In January 2023, the EU exported mainly **cereal preparations and milling products** (EUR 1.9 billion EUR, +28% year-to-year). Cereals exports are also slightly up compared to last year (+4%) and reached EUR 1.1 billion. **Dairy products** are also higher than in January 2022 (+19%) and reached EUR 1.6 billion, mostly thanks to cheese and curd and dairy powders.

EU AGRI-FOOD IMPORTS

BRAZIL AND UKRAINE: MAIN SOURCES OF EU IMPORTS IN JANUARY 2023

In **January 2023**, EU agri-food imports reached **EUR 13.8 billion** (+EUR 1.3 billion year-to-year, +10%). Brazil remained the first import source for the EU, representing 10% of total imports. Ukraine ranked second, with 9% of imports in 2022. The US is the third import source of EU agri-food imports.


EU agri-food imports from **Brazil** reached EUR 1.3 billion in January 2023. This confirms Brazil as the first import source of the EU. Commodity prices in January 2023 remained high and EU import values from Brazil were 20% higher than January 2022. Maize imports increased most compared to January 2022 (+259%, +EUR 144 million)

In January 2023, EU imports from **Ukraine** increased by 16% year-to-year, to reach EUR 1.2 billion. While still high, EU imports of cereals declined for the second month in a row in January, reaching a value of EUR 608 million. Vegetable oil imports also dropped to EUR 138 million (-54% year-to-year) due to less volumes imported (106 thousand tonnes were imported in January 2023, compared to 241 thousand tonnes in January 2022). Fruit and nuts imports also declined compared to last year (-53%) to reach EUR 11.9 million.

OVERALL LESS DYNAMIC EU IMPORTS IN JANUARY 2023

EU **cereals** imports increased the most in January 2023, compared to last year. Import values are still 50% higher year-to-year, led by prices that remained elevated during this month and with dynamic trade. Indeed, the EU imported 3.9 million t in January 2023. This was slightly less compared to the previous month but still elevated compared to the same month in previous years.

Imports of **oilseeds and protein crops** remained relatively stable in the recent months. In January 2023, the EU imported 3.8 million t of oilseeds and protein crops (+10% year-to-year). This represents a value of EUR 2.1 billion (+23% year-to-year).
