Need for sustainable „intensification“

1. Available tools?
2. Declining number of agricultural producers

Agri-Food Trade will play an increasingly important role in mitigating the effects of climate change, conflicts and exceptional global events



Definition: Limited guidance through research & science is preventing to define and to „redefine“ sustainable agri-food trade; leading concludingly to a „restrictive“ rather than opportunity-oriented regulatory environment



Disconnect: between the Multilateral, EU and stakeholder debate vs. the current policy space given to environmental challenges and trade is not enough to address the challenges of climate change



Fragmentation and missing harmonization of environmental standards: „Environmental sustainability“ is becoming a market access barrier; compliance and costs,



Changing trade patterns: Proven shifting of agri-food trade patterns caused by climate change and necessary „contingency“ planning are not a substantial part of the current policy debate



Competitiveness: Addressing reciprocity / economic sustainability / diverging / competitiveness concerns needs proactive, honest and innovative approaches & creative solutions



Agri-food trade contribution: Policy makers and food chain partners have not yet understood the contribution of agri-food trade to sustainable food systems



Better integration of the interest of agri-food trade in current EU policy developments & **better cohesion/coordination of policies through a designated contact point** in EU Policy Making



Considerations on Sustainability Equivalence as a concept: to ensure the practicability of EU (environmental) sustainability policies in a highly interconnected and globalised agri-food environment

1. Work towards recognition of mutual sustainability endeavours in FTA's as well as conceptually at multilateral level, building on experience with already existing models (e.g. SPS equivalence)






To further equip Sustainable Food Systems chapters: with concrete tools, cooperation and support mechanisms and systems of checks and balances;



Stronger multilateral engagement on trade/environment/sustainability elements in the sphere of agriculture/agri-food trade: as the impact on global agri-food production and trade is imminent; including stronger focus on harmonization and standard setting;
