

## Experts EU production forecast on Poultry and Rabbit













## Change in Poultry slaughter 2017/2016 (up to July)




## Placings of broiler chicks (1 000 pieces)



## Production forecast of broiler (In tonnes)








### Evolution of the weekly EU average price for Broiler










## EU Poultry meat Export

EU EXPORTS of Poultry Meat (1000 EUR)





## Lifting the ban after country free status

- Experiences from previous outbreaks: timelines to recognise country freedom after outbreaks, examples:
- 3-5 months: Japan, Singapore
- 5-7 months: Australia, Malaysia, Morocco, The Philippines
- 7-9 months: South Korea, South Africa, Kenya
- 9-11 months: Brazil, India
- 11-13 months: Algeria, Indonesia
- 13-15 months: Iraq
- >15 months: China, Thailand



## Highlights positive developments

- Ukraine: mutual recognition of regionalisation for AI agreed
- Thailand: recognition of regionalisation for FR – pilot
- Recognition of regionalisation in trade – topic is actively discussed in WTO SPS Committee – support from other main trading partners such as USA.
