RECEIVED IN THE CONTEXT OF DIRECT AID PAID TO THE PRODUCERS ACCORDING TO
COUNCIL REGULATION (EC) No 1259/1999 AND COUNCIL REGULATION (EC) No
1782/2003

(FINANCIAL YEAR 2005)

1. SOURCE OF THE INFORMATION

Pursuant to Commission Regulation (EC) No 2390/1999, the services of the Commission receive from the Member States, on an annual basis, data on the payments made to the beneficiaries of the EAGGF¹ Guarantee section, for further use in the context of the "Clearance of Accounts" procedure.

Commission Regulation (EC) No 419/2002 allows aggregating these detailed computer records for monitoring developments and providing forecasts in the agricultural sector. The attached tables have been produced in this context.

2. SCOPE OF THE DISTRIBUTION FIGURES (EU25)

The figures cover the expenditure paid as direct aid according to Regulations (EC) No 1259/1999 and No 1782/2003 for financial year 2005 and are based on the total amounts aggregated by every individual beneficiary identification code ('unique identifier'). Part of the expenditure (approximately 3.6 %) has been excluded from the overviews because of missing information on the final beneficiary or because of known cases of problems with the 'unique identifier'.

3. LIMITATIONS AND COMMENTS

3.1. While in general data quality is adequate for use in the clearance of accounts activity, care must be exercised over use of the data for other, analytical purposes. The requirement for a 'unique identifier' only came into effect from 1st January 2003 onwards following the introduction of the new IACS Implementing Regulation². However, inconsistencies in the application of the 'unique identifier' can not yet be totally excluded. The attached tables therefore present "indicative" and not totally precise figures.

3.2. The Member States have been invited to confirm the order of magnitude of the draft 2005 figures.

- 3.3. Furthermore, it should be clear that in the statistics on all direct payments, some sectors are not included. Indeed, in certain cases, the direct aid is not paid directly to the final beneficiary, but rather to producer associations which distribute on their turn the money further to their associates. This mainly concerns premiums for tobacco and bananas with respectively an approximate expenditure of €905 million and €175 million for 2005.
- 3.4. Compared to previous years, 'area payments for nuts' and 'aid for starch potato' have been included into IACS – plant products, while 'dairy premium and additional payment' has been added to IACS – animal premiums. Furthermore, information on 'dried grapes' and 'POSEIDOM, POSEIMA, POSEICAN and Aegean Islands' is now part of the indicative figures.
- 3.5. Numbers of beneficiaries less than 10 have been made invisible in the attached tables, although they figure in the totals.
- 3.6. In order to compare the information across all Member States, all expenditure has been converted into EUR. The exchange rates used for this conversion are listed below and need to be taken into account when evaluating expenditure in national currency.
