





Foreword

It is my great pleasure to welcome you to the conference "Our Forests, Our Future". The importance of forests for our society and the unique and indispensable role they play in our planet are increasingly acknowledged. As stated in the Cork 2.0 Declaration on the future of EU rural development, forests and the forest-based sector can greatly contribute to delivering sustainable solutions to current and future societal challenges, such as combating climate change, reducing reliance on fossil fuels, promoting the circular bioeconomy, and protecting biodiversity and natural resources. In the European Union, forests cover about 40% of the territory, and the forestbased sector provides more than 3.5 million jobs. Forests are a great asset in the EU and around the world: forest value chains are engines of rural growth and generate multiple benefits to society, including benefits for human health, recreation and tourism

This event comes a few months after the European Commission presented the report on the review of the EU Forest Strategy. The report illustrates the progress achieved over the last four years in a number of priority areas and how the Forest Strategy is effectively supporting the contribution of EU forests to many policy priorities and to the global sustainability agenda.

The recent revision of the EU Bioeconomy Strategy highlights the role of forests and forest products in developing the bioeconomy and promoting innovation, jobs and growth in rural areas. The conference will analyse the main challenges and opportunities for the forest-based sector as well as main factors affecting the development of the bioeconomy in the long-term.

We will also address the importance of forests for EU climate action and for achieving the objectives of the Paris Agreement, notably in the achievement of the long-term objective of balancing greenhouse gas emissions by sources and removals by sinks in the second half of the century. In the EU we have included forests in the scope of our emission reduction targets for 2030 through the adoption of the LULUCF Regulation. We have identified a way forward which emphasises the role of European forests and wood in reducing greenhouse gas emissions and enhancing carbon sequestration.

At the same time, our forests are increasingly exposed to the effects of changing climatic conditions. In recent years, EU forests were strongly affected by forest fires, pest outbreaks

and storms in many Member States. These events underline the importance of enhancing the resilience of forests to ensure their long-term sustainability. In line with this, the provision of ecosystems service and biodiversity conservation will also be at the heart of discussions with scientists, forest owners, environmental NGOs and policy makers. Presentations will illustrate ongoing efforts for improving the delivery of those services to society.

Reflecting these priorities, the rural development policy provides substantial support to the protection and sustainable management of forests. The future CAP post-2020 will provide Member States with greater subsidiarity and flexibility to design interventions more suitable to increase further the role of forests in addressing key future objectives.

During the second day, the conference will address EU actions to promote the protection and sustainable management of forests at global level, and discuss effective measures to combat deforestation and forest degradation.

Finally, the conference will also cover the link between forests and society and present different initiatives from civil society aimed at promoting the benefits of forests and trees for the environment, the climate and quality of life. It will also touch upon issues related to public perception of forests and how to communicate better to society the multiple benefits stemming from the protection and sustainable management of forests.

I am confident that these two days will be inspiring and bring new ideas and sound reflections for the future of our forests and forestry. I am delighted that you have joined us and I look forward to your input in the discussions.


