Note to the reader

The latest available consolidated trade data at EU level cover market developments in January 2024. Monthly figures can be compared with the previous month. Year-on-year change compares the cumulative trade since the beginning of the year with the same period in the previous year.

The trade figures are expressed in values, except when specifically mentioned. The unit value is the average price of products traded in the period concerned (trade value at the border divided by quantity registered).

HIGHLIGHTS: EU agri-food trade increased in January 2024 month-on-month

EU agri-food trade surplus reached EUR 5 billion in January 2024. This is a reduction of 9% compared to the previous month and 27% higher compared to January 2023.

EU exports increased by 4% month-on-month in January, reaching EUR 18.4 billion, a similar level than in January 2023 (+2%). Export values increased in olives and olive oil and cereal preparations, partly due to increased prices. However, reductions in the price of vegetables oils and dairy products could be observed.

EU imports also increased, by 10% month-on-month, to reach EUR 13.4 billion in January 2024. However, they remained 5% below their level of January 2023. Imports of cocoa products and olives and olive oil increased, while those of oilseeds and cereals decreased.

EU AGRI-FOOD EXPORTS

EU AGRI-FOOD EXPORTS INCREASED IN JANUARY

EU agri-food exports reached EUR 18.4 billion

in January 2024, an increase of 4% month-onmonth and at a similar level as in January 2023, despite reduced prices for some key EU exports (cereals, cereal preparations and milling products and dairy products).

The **UK** remained the first destination of EU exports, representing 23% of EU export value in January 2024. The UK also saw the largest increase in EU exports compared to January 2023. They increased by EUR 304 million (+8%), mostly due to higher unit values for beer, cider and other beverages, pig meat and preparations of fruit and nuts.

The **US** was the second destination of EU exports in January (12% of total EU export value). EU exports to the US grew by EUR 179 million (+9%) compared to January 2023. This is explained to a large extent by an increase in volumes and prices of exports of olives and olive oil.

On the other hand, EU exports to **China** decreased by EUR 141 million (-11%), mainly due to reduced export volumes and prices of cereal preparations and pigmeat. Still, China remained the third destination of EU exports (6%). EU exports to **Russia** decreased by EUR 163 million in January 2024 compared to 2023, due to reduced exported volumes across most categories.

EU exports of **olives and olive oil** increased the most in value compared to January 2023 (+EUR 175 million, +146%). However, this is mainly by increased prices while volumes exported remained stable. Exports of **mixed food preparations and ingredients** also increased, by EUR 119 million (+10%), due to increase of both prices and volumes. They remain the first product category exported by the EU (10% of EU export value).

Among other significant increases, exports of **sugar and isoglucose** increased by 152% in volumes compared to January 2023 (+EUR 76 million, +149% in value, mainly in white sugar). They continue at a high level after they increased in the end of 2023, following lower levels in the first part of the year.

Exports of **cereals** increased in volumes (+44%, mainly in wheat) and moderately increased in value (+EUR 58 million, +5%), despite reduced prices.

On the other hand, exports of **vegetable oils** decreased by EUR 176 million (-43%), due to both reduced prices and volumes. Exports of **dairy products** also decreased by EUR 108 million (-7%), mainly due to lower prices. Still, dairy products remain the second product category exported by the EU (8%).





EU AGRI-FOOD IMPORTS

EU IMPORTS INCREASED, BUT REMAINED BELOW JANUARY 2023

The value of EU agri-food imports reached EUR 13.4 billion in January, an increase of 10% compared to the previous month, but 5% below their level in January 2023, mainly due to reduced prices across many product categories.

Brazil remained the first source of agri-food imports for the EU in January 2024, representing 10% of total EU imports. They remained stable in value overall (+2%), with an increase of imports of oilseeds and protein crops compensating low imports of cereals.

Ukraine followed just behind as the second source of EU imports in January (10%), despite a reduced import value compared to January 2023 (-2%). This small reduction is mainly explained by reduced prices for cereals and oilseeds, despite increases in volumes imported (+17% and +7% respectively compared to January 2023).

The **UK** followed as the third source of EU imports (10%), despite a reduction of EUR 57 million (-5%) compared to January 2023.

Among other significant evolution, imports from **Côte d'Ivoire** grew by EUR 260 million (+83%), pulled by increases in both imported volumes and prices of cocoa products.

On the other hand, reductions in imports could be observed from **Australia** (-EUR 313 million, -78%, mainly in rapeseed), **Indonesia** (-EUR 235 million, -44%, mainly due to reduced palm oil imports) and **Argentina** (-EUR 170 million, -35%, mainly from reduced soya meals).

The increase of imports and prices of cocoa products also explains the broader growth of imports in the **coffee, tea, cocoa and spices** category, with an increase of EUR 353 million (+20%).

Imports of **olives and olive oil** grew significantly by EUR 80 million (+168%) compared to January 2023, due to both increased volumes (+97%) and increased prices. This continued a trend that started in 2023.

Imports of **cereals** declined by EUR 472 million (-34%), due to reduction in imported volumes (-14%) and prices. Imports of **oilseeds and protein crops** also decreased by EUR 312 million (-14%), as well as those of **vegetables oils**, which decreased by EUR 192 million (-25%), mainly due to reduced prices.
