Note to the reader

The latest available consolidated trade data at EU level cover market developments in July 2024. Monthly figures can be compared with the previous month. Year-on-year change compares the cumulative trade since the beginning of the year with the same period in the previous year.

The trade figures are expressed in values, except when specifically mentioned. The unit value is the average price of products traded in the period concerned (trade value at the border divided by quantity registered).

HIGHLIGHTS: EU agri-food trade increased in July 2024

EU agri-food trade surplus increased by 8% in July 2024 compared to the previous month, with a value of EUR 6.1 billion, and is stable compared to July 2023. EU surplus reached EUR 39.7 billion between January and July 2024, an increase of EUR 1.1 billion compared to the same period in 2023.

EU exports reached EUR 20.8 billion in July 2024, an increase of 10% on the previous month and 15% higher than in July 2023. Since January, cumulative EU exports reached EUR 137.2 billion, 3% higher than on the same period in 2023. EU export value increased significantly for olives and olive oil due to increased prices compared to 2023. On the other hand, exports decreased for vegetable oils and cereals. EU exports to the US and the UK increased the most, while exports in direction of China and Russia decreased.

EU imports increased by 11% month-on-month in July and reached EUR 14.6 billion, a 23% increase compared to July 2023. Cumulative imports between January and July reached EUR 97.5 billion, 2% higher compared to 2023. Import values for cocoa products increased compared to 2023 due to higher prices, while those of oilseeds and cereals decreased. Imports from Côte d'Ivoire had the largest increase in value, while those from Australia had the largest reduction.

EU AGRI-FOOD EXPORTS

EU EXPORTS INCREASED IN DIRECTION OF THE US

EU agri-food exports reached EUR 20.8 billion

in July 2024, a 10% increase month-on-month and 15% higher than in July 2023. Cumulative exports since January reached EUR 137.2 billion, a 3% increase on the period in 2023 (+EUR 3.4 billion).

The **US** was the destination with the largest increase of EU exports between January and July compared to 2023 (+EUR 1.5 billion, +10%). This is explained in part by an increase in prices of olives and olive oil exports.

EU exports to the **UK** increased by EUR 914 million (+3%) over the first half of the year compared to 2023, spread across a variety of products.

EU exports also increased in direction of **Brazil** by EUR 253 million (+18%, mainly due to higher prices of olives and olive oil).

On the other hand, EU exports to **China** declined by EUR 728 million (-8%) between January and July 2024 compared to 2023. This is mainly explained by reductions in several EU main exported products to China, in particular: frozen pig meat, skimmed milk powder and fresh dairy products, cereals and cereal preparations.

EU exports to **Russia** decreased by EUR 511 million (-12%) compared to 2023, due to reduced exported volumes across many agri-food categories, in particular spirit and liqueurs and wine and wine-based products.

EU exports also decreased in direction of **Algeria** (-EUR 272 million, -14%), mainly explained by reduced exports of vegetable oils and cereals.

OLIVE OIL AND COCOA PRODUCTS DRIVE EU EXPORT VALUE IN 2024

EU exports of **olives and olive oil** increased the most compared to 2023 (+EUR 1.7 billion, +59%), mainly due to high prices.


Exports in the **coffee, tea, cocoa and spices** category continued to rise in July, with an increase in value of EUR 1.2 billion (+25%) between January and July compared to the same period in 2023. This is mainly explained by higher prices and volumes exported of cocoa paste, butter and powder.

Exports of **sugar and isoglucose** have increased by 151% compared to the same period of 2023 (+EUR 523 million). Volumes exported have nearly tripled (+189%), while prices decreased by 13%.

On the other hand, the value of EU **cereals** exports decreased by EUR 1.2 billion (-13%). However, this is explained by a reduction of prices, while volumes exported increased by 6%.

Exports of **vegetable oils** also decreased by EUR 844 million (-36%), due to both reduced prices and volumes (-21%).

EU exports of **wine and wine-based products** decreased by EUR 437 million (-4%), due to lower prices and volumes.



EU AGRI-FOOD IMPORTS

EU IMPORTS REBOUNDED IN JULY 2024

The value of EU agri-food imports reached EUR 14.6 billion in July. It is an 11% increase compared to the previous month and 23% higher than in July 2023. Cumulative imports since January reached EUR 97.5 billion, 2% higher compared to 2023 (EUR 2.2 billion).

Imports originating from **Côte d'Ivoire** had the largest increase (+EUR 1.2 billion, +50%). This is mainly explained by higher prices of cocoa products. They were followed by imports from **Nigeria** which also increased significantly, by 150% (+EUR 600 million) for the same reason.

Imports from **Tunisia** also doubled with an increase of EUR 460 million (+99%), mainly due to increased olive oil imported volumes and prices.

On the other hand, imports from **Australia** increased in July, but cumulated imports since January remain EUR 752 million lower than in 2023 (-38%), due to a reduction in rapeseed imported volumes.

EU imports from **Brazil** decreased by EUR 509 million (-5%), mainly due to lower oilseeds prices and a fall of maize imported volumes. Imports also decreased from **Canada** (-EUR 460 million, -25%, mainly due to lower maize and wheat imports), as

well as from **Indonesia** (-EUR 431 million, -13%, mainly due to reduced palm oil imports).

COCOA IMPORT PRICES REMAIN HIGH

Imports of **coffee, tea, cocoa and spices** continued at a high level, with an increase of EUR 3.8 billion (+31%), mainly explained by high prices of cocoa products, notably cocoa beans. Imports of **fruit and nuts** also grew by EUR 950 million (+7%), mainly due to increased prices (esp. nuts).

Imports of **olives and olive oil** also remained high and more than doubled in value compared to 2023, increasing by EUR 663 million (+115%) compared to 2023, due to both increased volumes (+53%) and prices.

On the other hand, cumulative imports of **oilseeds** and **protein crops** had the largest reduction in value compared to 2023, with a decrease of EUR 1.9 billion (-15%), notably form Australia, Brazil and the US. This was overall due to a reduction in prices, while imported volumes increased by 2%.

Imports of **cereals** decreased by EUR 1.5 billion between January and July compared to 2023 (-20%). It is mainly explained by reduced prices, while imported volumes have stabilized and even increased in July. Imports of **sugar and isoglucose** also decreased by EUR 508 million (-39%) compared to 2023, due to reduced imported volumes.


