Note to the reader

The latest available consolidated trade data at EU level cover market developments in September 2024. Monthly figures can be compared with the previous month. Year-on-year change compares the cumulative trade since the beginning of the year with the same period in the previous year.


The trade figures are expressed in values, except when specifically mentioned. The unit value is the average price of products traded in the period concerned (trade value at the border divided by quantity registered).

HIGHLIGHTS: EU agri-food exports increased in September 2024

EU agri-food trade surplus increased by 15% in September 2024 compared to the previous month, with a value of EUR 6 billion. This remains 10% lower than in September 2023. EU surplus reached EUR 50.6 billion between January and September 2024 and remained stable compared to the same period in 2023.

EU exports reached EUR 19.6 billion in September 2024, an increase of 5% on the previous month and 3% higher than in September 2023. Since January, cumulative EU exports reached EUR 175.5 billion, 2% higher than on the same period in 2023. EU export value increased significantly for olives and olive oil and cocoa products due to increased prices. On the other hand, exports decreased for vegetable oils and cereals. EU exports to the US and the UK increased the most, while exports in direction of China and Russia decreased.

EU imports remained stable month-on-month in September and reached EUR 13.6 billion. However, they remain 11% higher compared to September 2023. Cumulative imports between January and September reached EUR 124.9 billion, 4% higher compared to 2023. Import values for cocoa products increased the most compared to 2023, as their prices kept increasing, while those of oilseeds and cereals decreased. Imports from Côte d'Ivoire had the largest increase in value, while those from Australia had the largest reduction.





EU AGRI-FOOD EXPORTS

EU EXPORTS INCREASED IN SEPTEMBER

EU agri-food exports reached EUR 19.6 billion in **September** 2024, a 5% increase on the previous month and 3% higher than in September 2023. Cumulative exports since January reached EUR 175.5 billion, a 2% increase on the same period in 2023 (+EUR 4.2 billion).

EU exports to the **US** had the largest increase compared to 2023 (+EUR 2.2 billion, +11%). This is explained in part by an increase in prices of olives and olive oil exports.

The **UK** was the destination with the second largest increase of EU export value, with a rise of EUR 1.1 billion (+3%) compared to the same period in 2023, due to increases across a variety of products.

EU exports to **Mexico** also increased by 17% (+EUR 294 million) compared to 2023, mainly due to increased exports of olives and olive oil, tobacco products and vegetable oils.

On the other hand, exports to **China** had the largest reduction, with a decrease of EUR 878 million (-8%) compared to 2023. This is explained in particular by reductions in exports of pigmeat, cereals and dairy products.

EU exports to **Russia** followed, with a reduction of EUR 562 million (-11%) compared to 2023, due to reduced exported volumes across many agri-food categories, in particular spirit and liqueurs and wine and wine-based products.

OLIVE OIL AND COCOA PRODUCTS KEEP DRIVING EU EXPORTS


EU exports of **olives and olive oil** increased the most in value compared to 2023 (+EUR 2 billion, +54%). This is mainly explained by sustained high prices, although they have started to weaken in the past months.

Exports in the **coffee, tea, cocoa and spices** continued at a high level with an increase in value of EUR 1.7 billion (+29%) compared to 2023. This is mainly driven by the continuing growth of the prices of cocoa paste, butter and powder, as well as higher export volumes. However, the EU remains a net importer for these products.

Exports of **sugar and isoglucose** have more than doubled in value (+136%, +EUR 636 million), compared to the same period in 2023. Volumes exported have increased by +179%, while prices decreased by 15%.

On the other hand, EU **cereals** exports had the largest reduction in value, with a decrease of EUR 1.7 billion in value (-15%). This is explained by a reduction of prices (-16%). Volumes exported increased for wheat (+6%, +1.6 million tonnes) but decreased for maize (-28%, -1 million tonnes).

Exports of **vegetable oils** also decreased by EUR 936 million (-33%), due to both reduced prices and volumes (-20%).



EU AGRI-FOOD IMPORTS

COCOA IMPORTS FROM COTE D'IVOIRE AND NIGERIA CONTINUE TO INCREASE

The value of EU agri-food imports reached EUR 13.6 billion in August. This is stable compared to the previous month but remains 11% higher than in September 2023. This is mainly explained by an increase of import prices for a range of products in the past months, in particular cocoa products, as well as higher volumes of key EU imports. Cumulative imports since January reached EUR 124.9 billion, 4% higher compared to 2023 (+EUR 4.7 billion).

Imports originating from **Côte d'Ivoire** had the largest increase in value between January and September compared to 2023 (+EUR 1.7 billion, +57%). This is mainly explained by the continuing increase of cocoa prices. Imports from **Nigeria** also increased significantly, by 150% (+EUR 761 million) for the same reason.

Imports from **Ukraine** had the second largest increase in value, with a growth of EUR 834 million compared to 2023 (+10%). This is mainly explained by higher import volumes of vegetable oils and oilseeds, in particular in rapeseed.

On the other hand, imports from **Australia** had the largest reduction in value (-EUR 793 million, -36%), due to a reduction in rapeseed volumes and prices.

Imports from **Brazil** had the second largest reduction in value, with a decrease of EUR 549

million (-4%, mainly due to reduced oilseeds prices and cereals volumes).

They were followed by imports from **Russia** which decreased by 39% (-EUR 544 million), due mainly to reduction in the prices and volumes of oilseeds and cereals imports.

PRICES OF CEREALS AND OILSEEDS REMAIN LOWER THAN IN 2023

Imports of **coffee, tea, cocoa and spices** continued at a high level, with an increase of EUR 5.5 billion (+36%) compared to 2023, as the price of cocoa products kept climbing.

Imports of **fruit and nuts** also grew by EUR 1.4 billion (+8%), mainly due to increased prices.

Imports of **olives and olive oil** have slowed down but their cumulated value since January remains 75% higher than in 2023 (+EUR 623 million), due to both increased volumes and prices.

On the other hand, cumulative imports of **oilseeds and protein crops** had the largest reduction in value compared to 2023, with a decrease of EUR 1.9 billion (-12%). This was overall due to a reduction in prices (-15%), while imported volumes increased by 4%.

Imports of **cereals** decreased by EUR 1.8 billion compared to 2023 (-20%). It is mainly explained by reduced prices (-17%), while imported volumes decreased by 5%.


