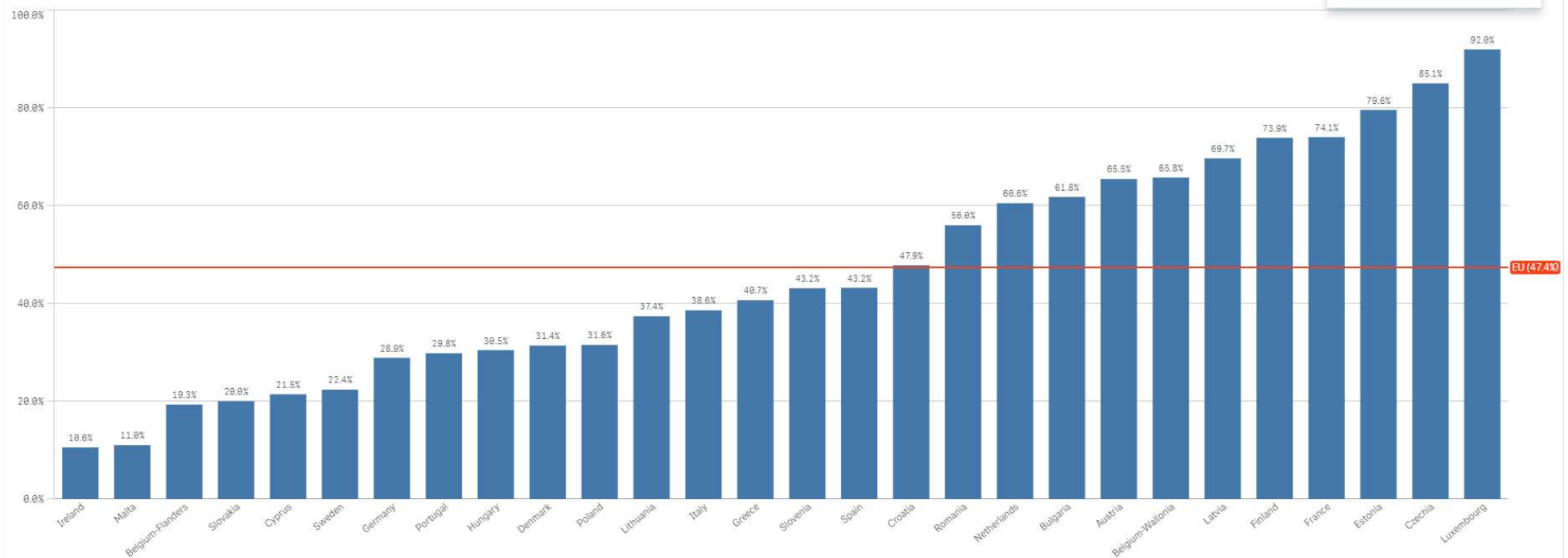

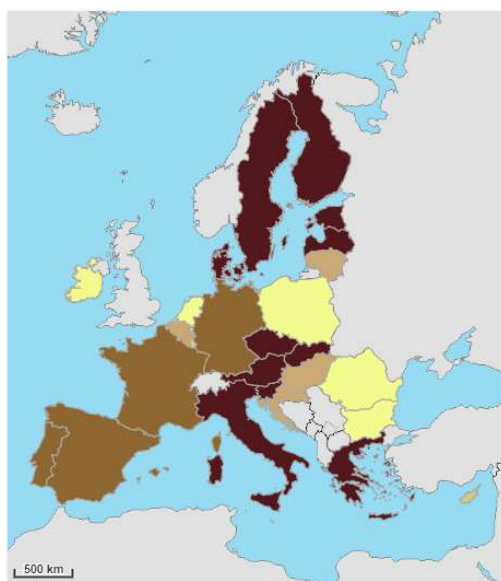

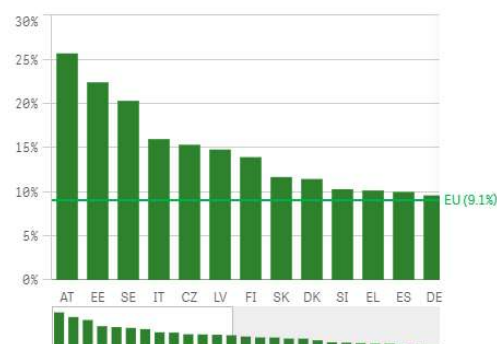
Share of organic farming area in total UAA in 2020

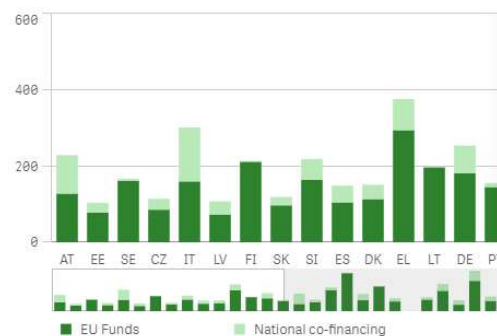
Share of organic farming area in total UAA by MS (%)
 In 2020



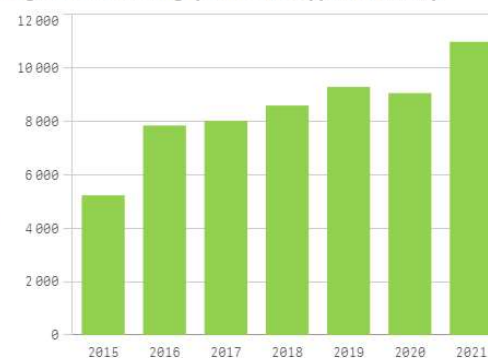
Share of organic farming area in total UAA by MS (%)

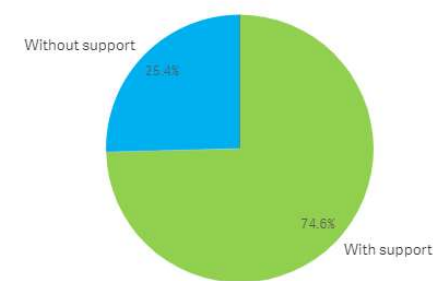
Average specific CAP support per ha (EUR/ha)

Organic area receiving specific CAP support (1 000 ha)



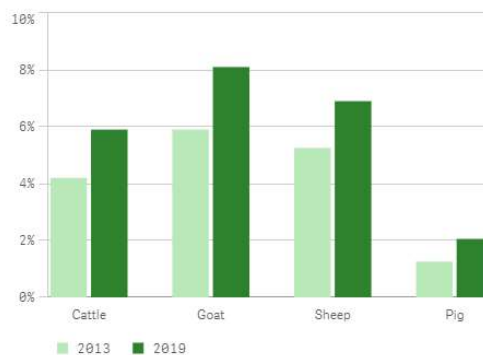
Share of organic area receiving specific CAP support
