Registration:

- Only the participants registered via AGM will be authorised to join the meeting. It will allow the Commission to properly identify all the participants, including those connecting remotely.
- The **listed participants** should confirm via AGM their attendance **no later than 12 March 2023, 23:00** and **indicate via AGM** how they intend to participate: **physically or online**.
- After the above deadline, the online participants will receive an email with all technical details for the connection by videoconference and the physical participants will receive their authorisation document to enter the building (“V-pass”).

- Attention: we will **strictly apply the abovementioned deadline for registration**: no additional physical participant can be accepted after the given deadline, since it affects the choice of venue/meeting room and other preparations for the meeting.

Participation/Reimbursement:

- Only delegates participating **physically** will be entitled to **reimbursement of travel costs** (see reimbursement details in Annex). For delegates participating online there will be no reimbursement of costs.
- We remind the physical participants that they need to **sign a list of presence** at the entrance of the meeting room, or else, they cannot be marked as present at the meeting.
- Physical participants will be asked to pass through an obligatory control (X-ray devices and/or walk-through detectors) when entering the building.
