Four waves of simplification

- First wave: voluntary coupled support schemes
extension of final date for submission of applications
(March 2015)
- Second wave: guideline documents on EFA, OTSC, LPIS and aid` ` applications (May 2015)
- Third wave: Voluntary coupled support, Young farmers Scheme (DA)
IACS (checks and penalties -IA/DA) (Nov/Dec 2015 - May 2016)
- Fourth wave: Greening (under scrutiny) and greening penalties (adopted April 25th)



CMO – state of play

Since the activity began:

- 18 new delegated regulations and 18 new implementing regulations have been adopted and published in the OJ;
- 30 regulations have been repealed (as a consequence of the above activity) or are time expired;
- 57 regulations have been declared obsolete.
- further delegated and implementing regulations are in the pipeline planned for adoption in 2017


