2021 calls for proposals: general remarks

- The number of proposals is higher than in 2020
- Competition is high in « new » topics dedicated to sustainability and organic on internal market. Not enough interest for promotion of organic products in third countries.
- New award criteria assessing alignment with F2F objectives not always well addressed in proposals
