


Monitoring EU Agri-Food Trade: Development until July 2019



July 2019

The strong start to the EU agri-food exports in 2019 continued in July with another monthly record figure of EUR 13.07 billion, 12.6% above the level of July 2018. Imports also increased to EUR 9.92 billion - 6% above the level of July 2018. As a result, the monthly agri-food trade surplus stood at EUR 3.15 billion – a 40% increase of the positive trade balance compared to EUR 2.25 billion in July 2018.

The highest increases in monthly export values (July 2019 compared to July 2018, EUR million) were recorded for the USA (+393, +20.5%), China (+269, +26.5%) and Japan (+215, +37.5%), while exports decreased most to Hong Kong (-45, -13.6%), Libya (-34, -28%) and Turkey (-22, -8%).

Looking at product categories, the increase in export values was driven in particular by pork meat (+164, +46%), spirits and liqueurs (+120, +12%), milk powders and whey (+102, +30%), wine and vermouth (+101, +9%) and offal and

other meats (+69, +34%) exports. On the other hand, exports of beet and cane sugar (-39, -49%), vegetable oils (excluding palm and olive oil) (-37, -19%), oilseeds other than soyabeans (-14, -22%), essential oils (-11, -16%) and wool and silk (-7, -50%) decreased the most in value terms.

The value of July 2019 EU agri-food imports compared to July 2018 increased most from Ukraine (+195, +62%), Brazil (+182, +18%) and China (+73, +16%). The value of imports went down most from the USA (-144, -15%), Indonesia (-67, 19%) and New Zealand (-33, -12%).

Increases were recorded in import values of tropical fruit (+149, +15%), coarse cereals (+146, +63%) and vegetable oils (+88, +49%), while imports of soyabeans (-64, -13%), palm oil (-50, -11%) and citrus fruit (-47, -17%) fell the most in value terms.

EU agri-food exports grew the most to the USA and China

For the 12-month period from August 2018 to July 2019, EU agri-food exports reached EUR 144.4 billion, i.e. a new record and a significant increase of +5% compared to the same twelve months period one year ago.

The main export destinations in the most recent twelve months (in EUR billion) were the USA (23.8), China (12.5), Switzerland (8.4), Japan (7.3) and Russia (6.9).

Major gains in annual values (in EUR billion, % change from 2017-18) have been achieved in agri-food exports to the USA (+1.9, +9%), China (+1.15, +10%), Japan (+0.72, +11%), Ukraine (+0.29, +15%), Russia (+0.27, +4%), Mexico (+0.23, +17%), Switzerland (+0.16, +2%), Indonesia (+0.15, +20%) and Thailand (+0.12, +11%).

Exports in the last 12 months fell significantly (in EUR billion, % change from 2017-18) for Turkey (-0.57, -16%), Hong Kong (-0.44, -11%), Angola (-0.13, -19%), Pakistan (-0.5, -14%) and Ethiopia (-0.11, -6%).

Spirits, pork meat, milk powders and whey reported the biggest growth in exports

In products, spirits and liqueurs (+1.1, +10%), pork meat (+0.59, +12%), milk powders and whey (+0.4, +10%), wine and vermouth (+0.36, +3%), cigars and cigarettes (0.15, +4.3%) have reported important increases (% change from 2017-18). Export performance on a yearly basis also rose notably for wheat (+0.64, +17%), pasta and pastry (+0.43, +8%), water and soft drinks (+0.42, +11%), cotton, flax and hemp (+0.4, +48%) and preparations of vegetables, fruit and nuts (+0.38, +8%).

On the other hand, annual exports of beet and cane sugar (-0.46, -39%), raw hides and skins (-0.26, -16%), live animals (-0.13, -4%), vegetable oils other than palm & olive oil (-0.12, -5%), olive oil (-0.12, -4%) have experienced the most significant drop in value terms. Other categories with notable reductions in export values over the last 12 months were fatty acids and waxes (-0.9, -14.6%), soyabeans (-0.54, -45%), unroasted coffee and tea (-0.45, -9%).

USA and Ukraine account for most of EU agri-food import growth

For the year 12-month period from August 2018 to July 2019, agri-food imports from third countries accounted for EUR 118.6 billion, i.e. an increase of 3% compared to August 2017 – July 2018.

The most important origins for EU agri-food imports over the past 12 months (EUR billion) were the USA (12.5), Brazil (11.7), followed by Ukraine (6.7) and China (6.0). Other significant origins were Argentina (5.0), Switzerland (4.6), Turkey (4.5) and Indonesia (4.2).

On a year-on-year basis, the value of agri-food imports (in EUR billion, % change) continued to grow impressively from Ukraine (+1.7, +34%) and the USA (+1.5, +14%). Other significant import increases were recorded from China (+0.56, +10%), Peru (+0.32, +15%) and Thailand (+0.2, +9%). By contrast, significantly fewer imports in value terms have been received in the same period from Indonesia (-0.46, -10%), Argentina (-0.27, -5%), Australia (-0.23, -11%), Vietnam (-0.17, -7%) and Chile (-0.13, -5%).

Imports into the EU of coarse grains on rise while palm oil falls the most

Looking at product categories, the highest increases in import values over the last months (in EUR billion, % change) were observed for coarse grains (+1.48, +46%), oilcakes (+0.43, +6%), cocoa beans (+0.40, +11%), other vegetables oils (+0.33, +15%) and vegetables (+0.33, +7%). However, some import values decreased significantly, in particular for palm oil (-0.75, -13%), unroasted coffee and tea (-0.23, -3%), tropical fruit (-0.22, -2%), olive oil (-0.18, -30%) and sheep meat (-0.18, -17%).

Trade surplus increases further as EU agrifood export growth outpaces import rise

With the strong export performance in 2019 and somewhat weaker growth in imports, the trade surplus for the 12-month period from August 2018 to July 2019 was EUR 3.4 billion higher than in August 2017 - July 2018 and has reached a record level of EUR 25.85 billion.
