



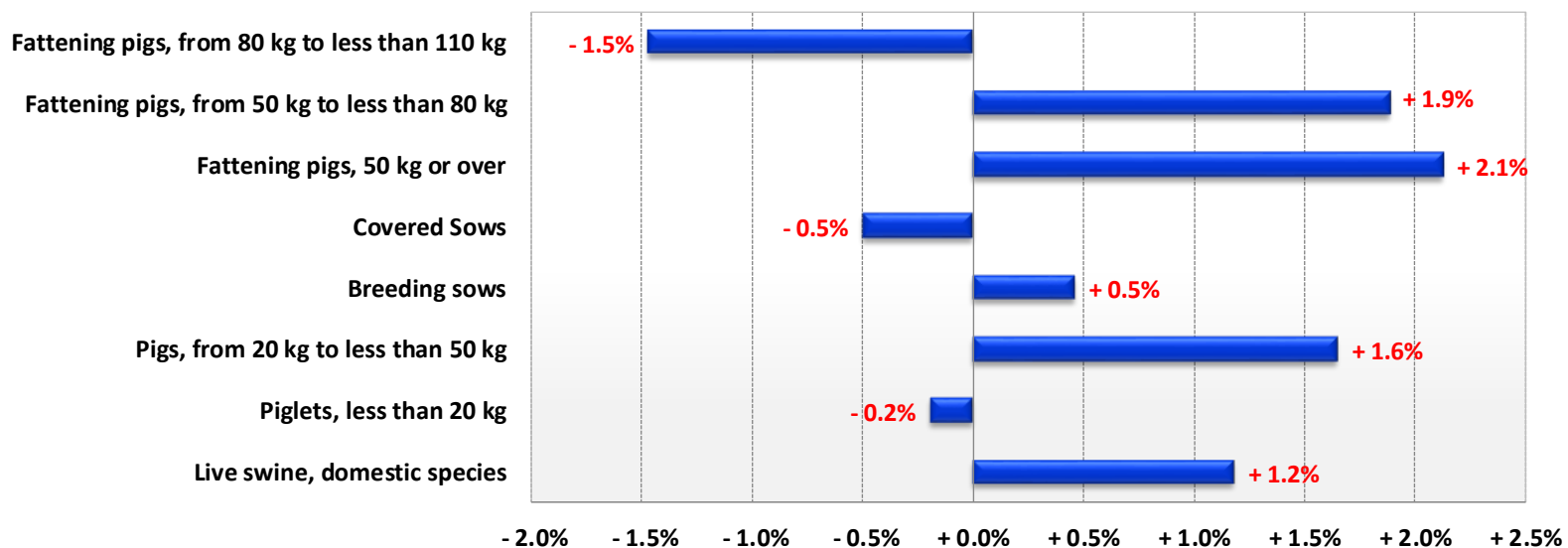

Change in pig population - Livestock survey results May-June 2020 compared to May-June 2019

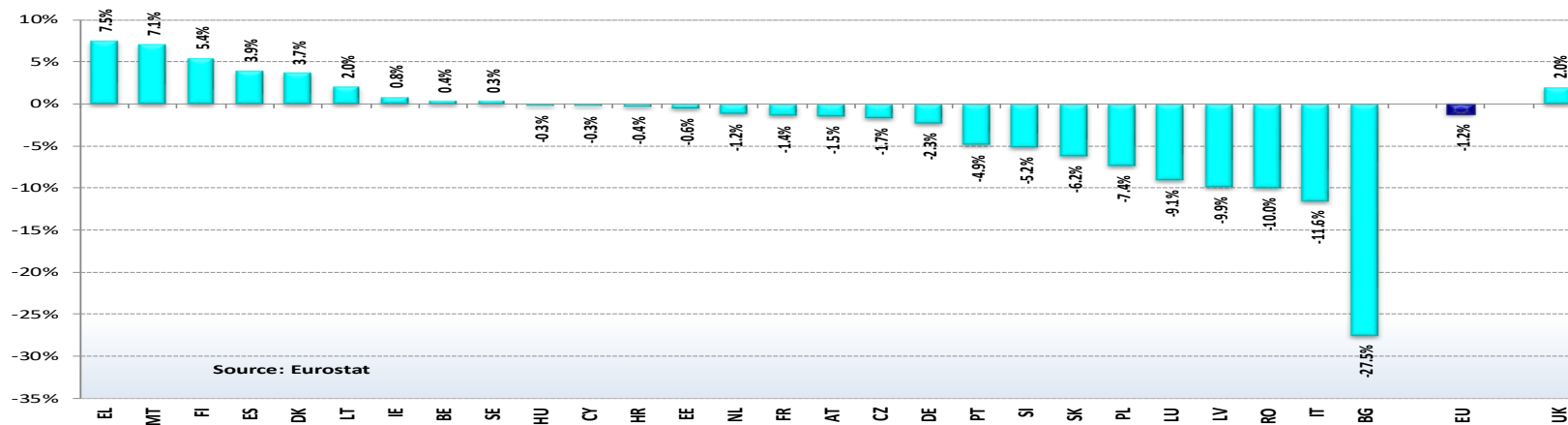

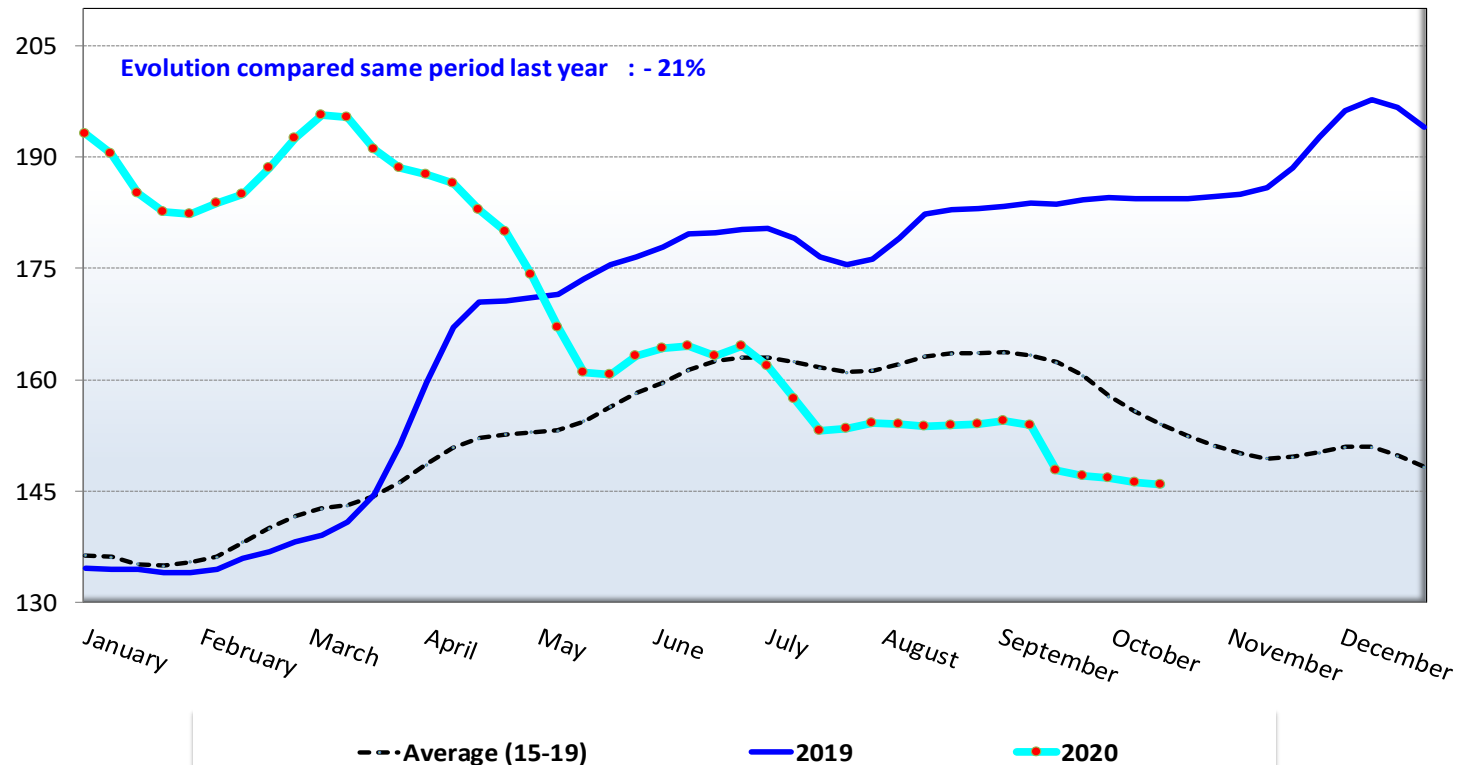

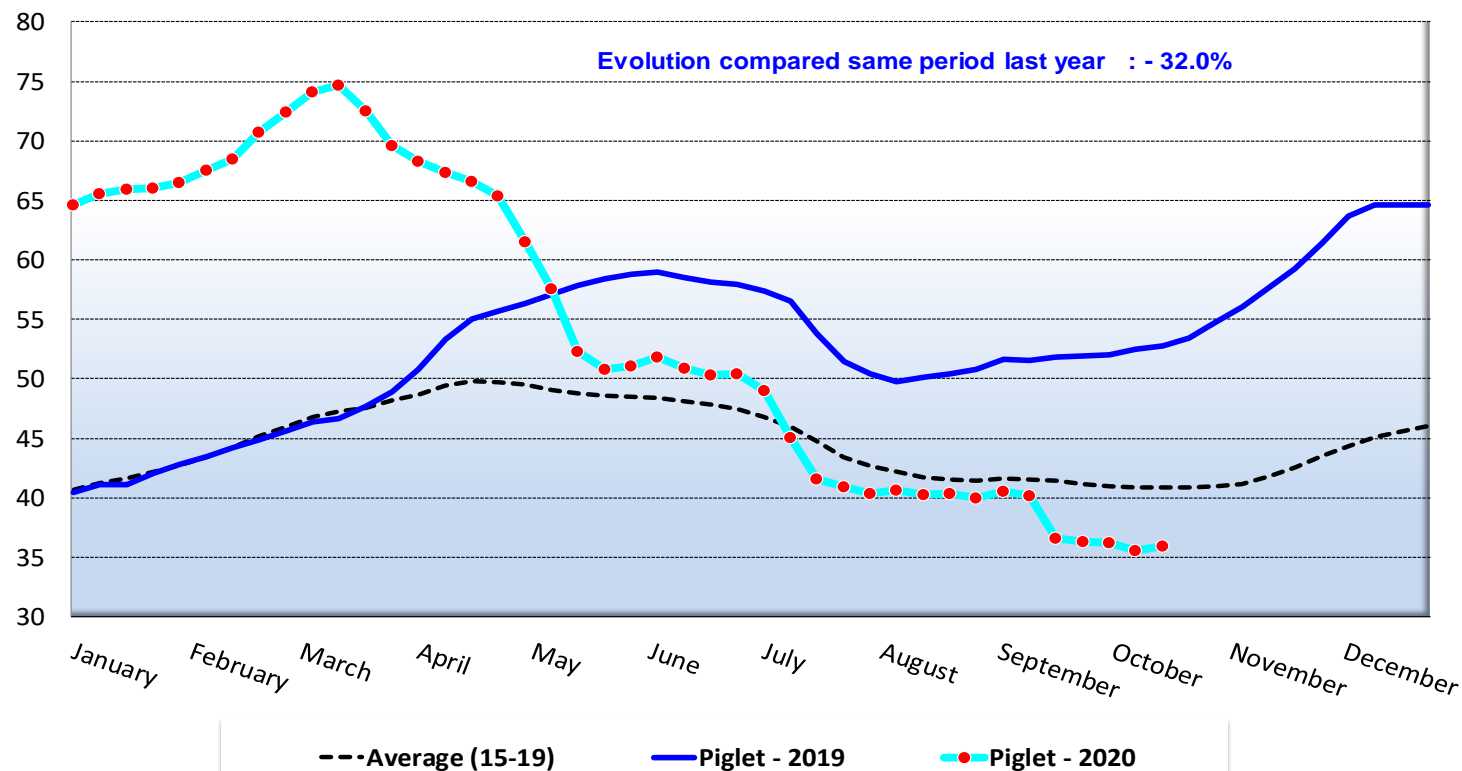

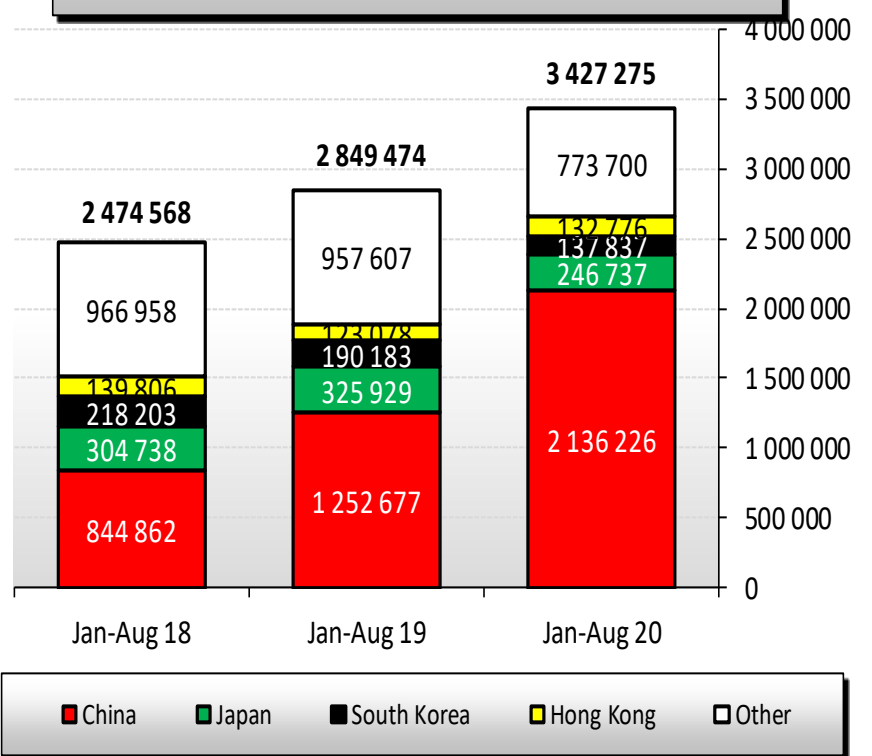

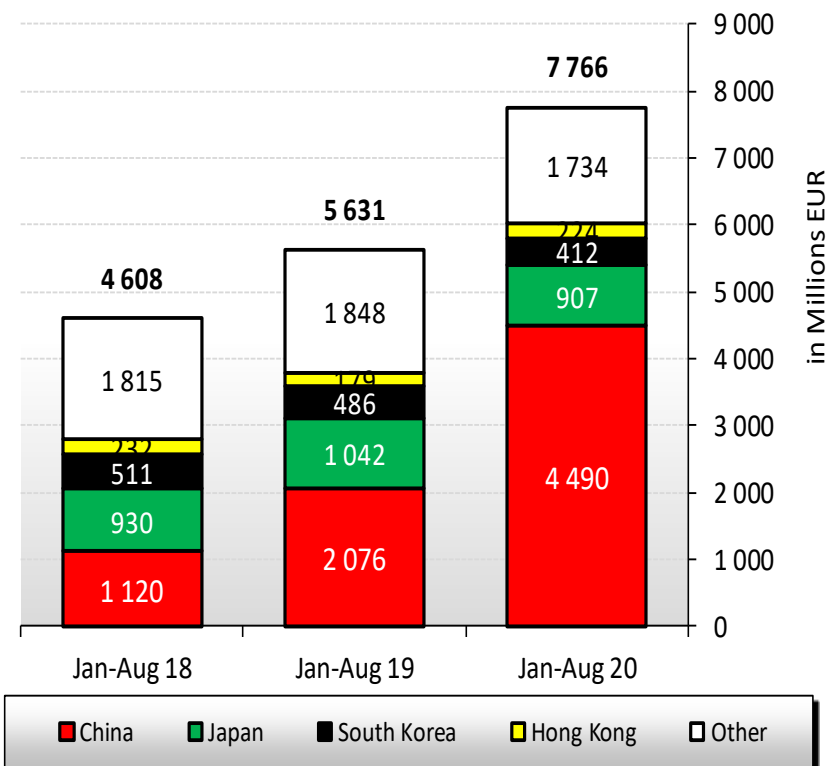

EU EXPORTS of PIG Meat (Tonnes carc. weight) without UK

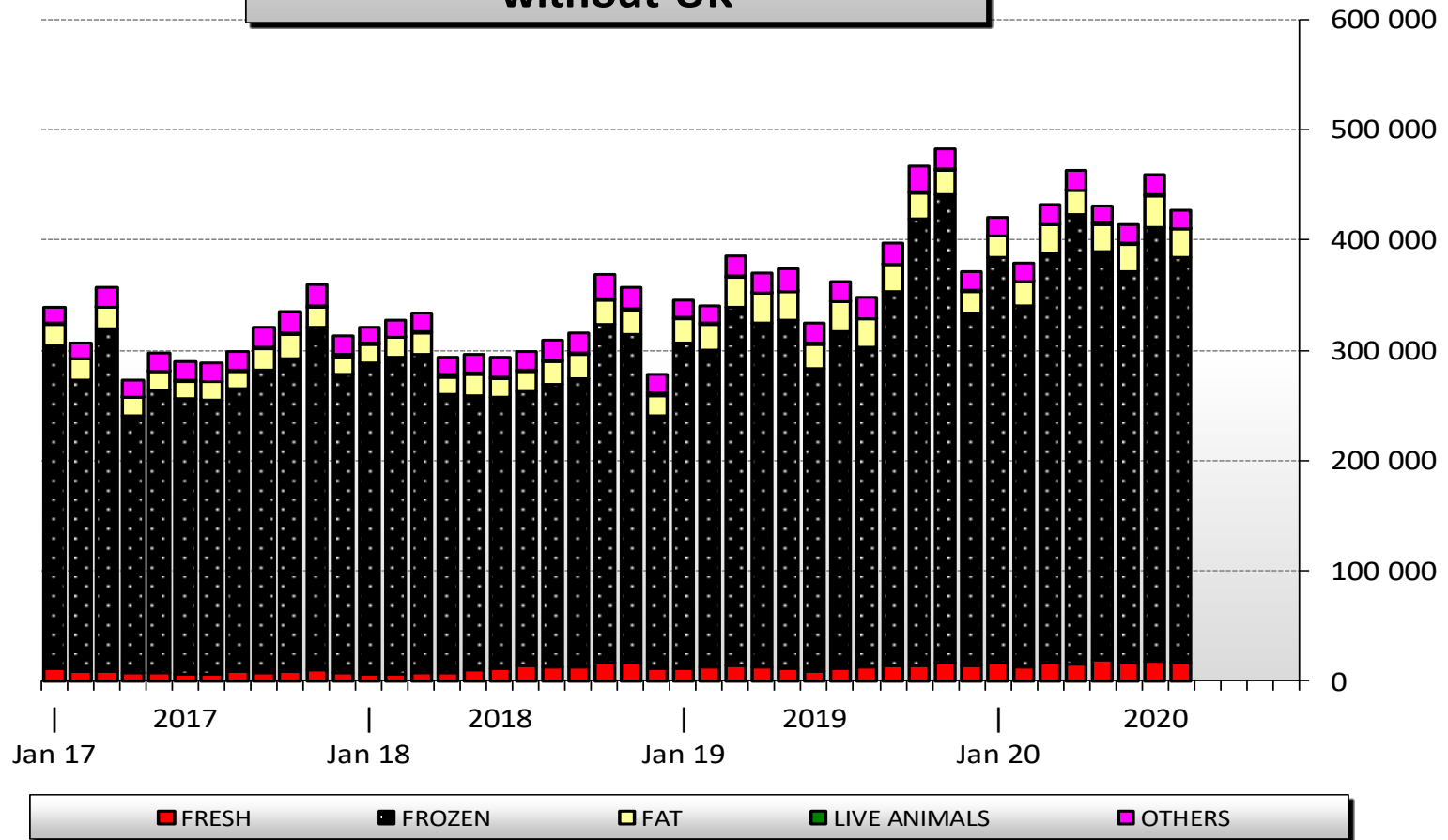


EU EXPORTS of PIG Meat (Millions EUR) without UK

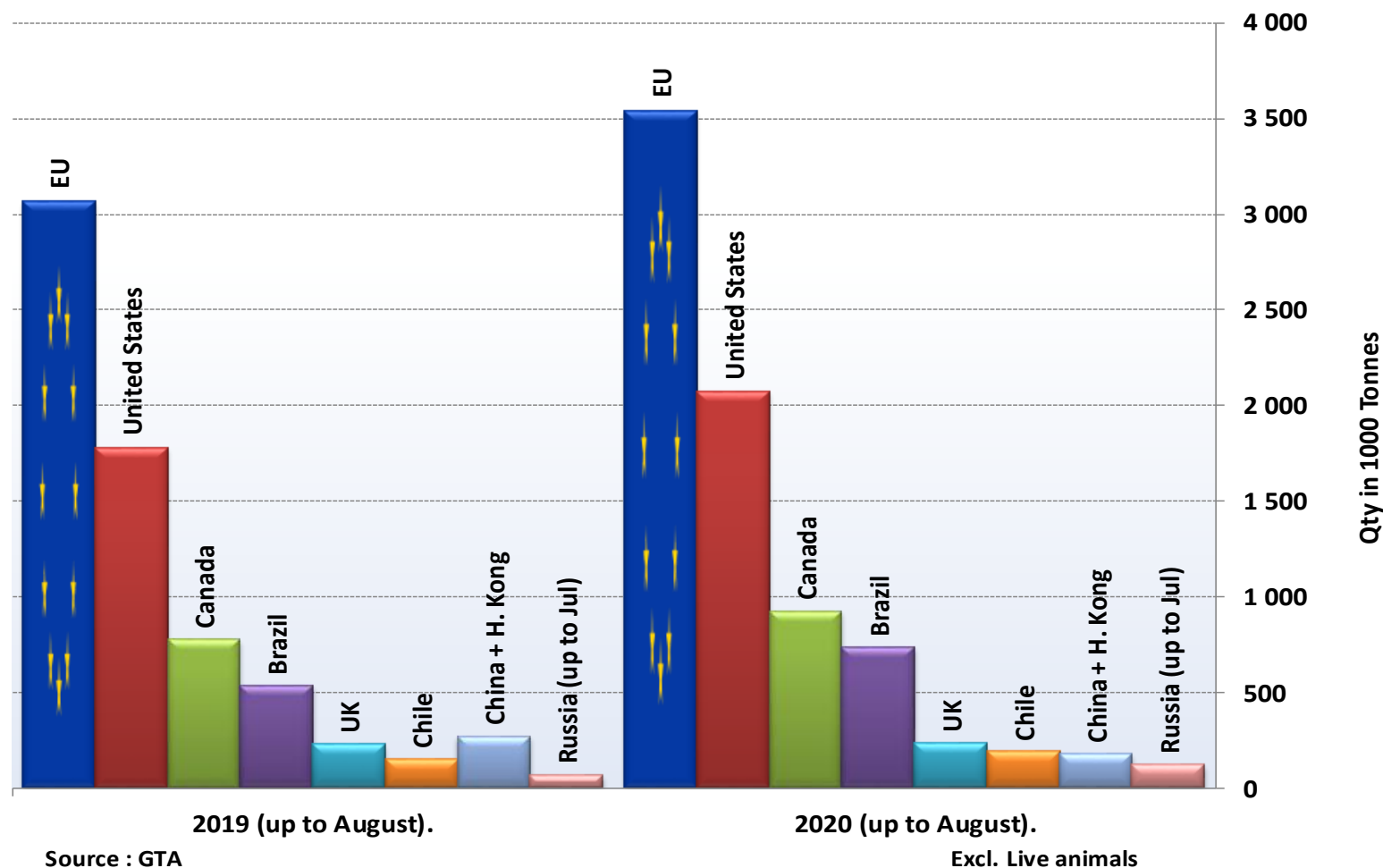

(carcase weight)

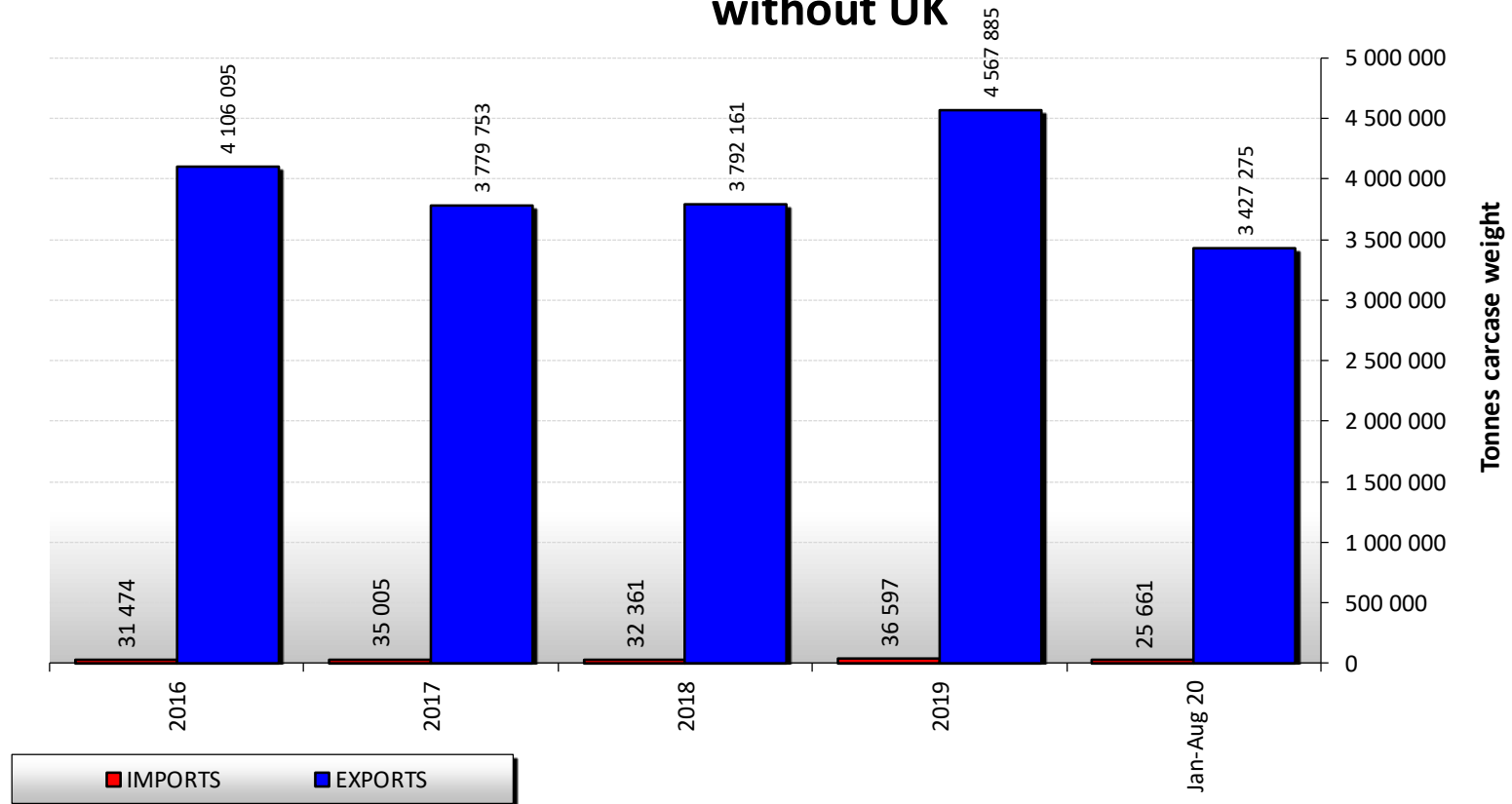


Main Exporters of PIG Products (up to August).
