



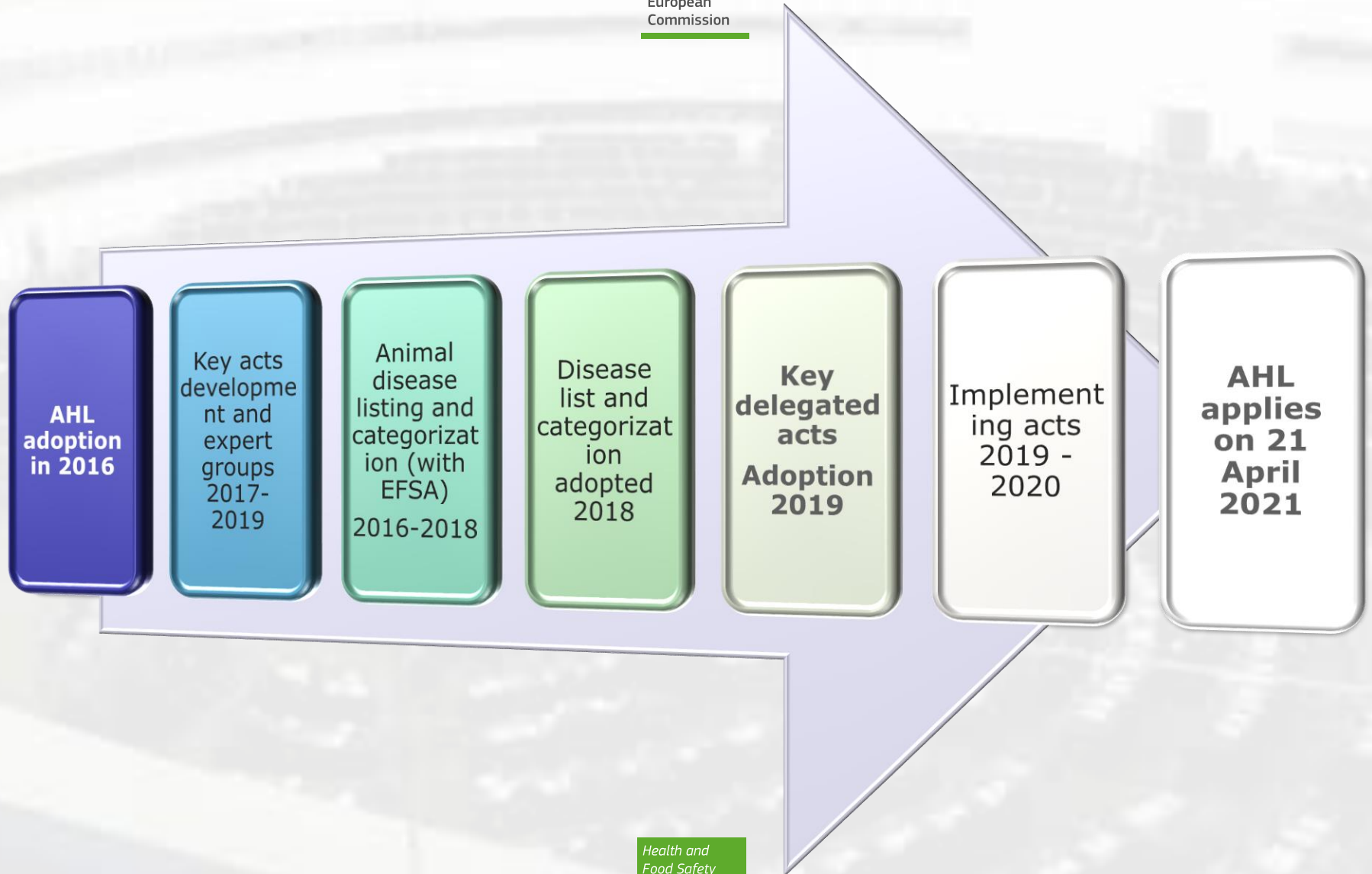

Registration obligation

- ✓ **Registration obligation** of operators of kept ungulates:
 - ✓ Inform the competent authority of their activity;
 - ✓ Provide information on:
 - ✓ The name and address of the operator
 - ✓ The location of the establishments and description of its facilities
 - ✓ The categories, species and numbers of kept ungulates the operators intend to keep and the capacity of the establishment
 - ✓ The type of establishment
 - ✓ Provide information on any changes the matters above and cessation of transport activity
- ✓ Competent authority obligation to keep register of establishments

Record keeping obligation

- ✓ **Record keeping obligation** of operators of kept porcine animals:
 - ✓ The categories, species and numbers of kept porcine animals
 - ✓ Movements into and out of the establishments: group recording
 - ✓ Mortality of kept porcine (natural death, slaughter or loss)
 - ✓ References to documents accompanying the animals
 - ✓ Information related to treatments, test results etc
 - ✓ Records in paper or electronic form, at least 3 years or as set by CA

Traceability of kept porcine animals

✓ Means of identification:



OR



OR



✓ ID code of the animals: birth holding number

✓ Derogation: no means of identification for porcine moving within food supply chain

✓ Exemption: if authorised by CA, operators of confined establishments (zoos) and operators keeping porcine animals for cultural, recreational or scientific purposes:



Traceability of kept porcine animals

- ✓ **CA obligation** to keep a computer database of kept porcine animals:
 - ✓ Establishments keeping porcine animals
 - ✓ Movement records of animals into and from that establishment

- ✓ **Operators obligation** to ensure that porcine animals are accompanied by a movement document when moved within its MS territory:
 - ✓ Origin and destination establishment
 - ✓ Nr of animals moved
 - ✓ Date of departure
 - ✓ Transporters unique registration number
 - ✓ Lice plate number of registration number of the means of transport
