Legislation (2)



- **Pet food:** lex specialis on labelling in decide planning, procedure COM proposal to the EP and the Council
- Draft DA detailed production rules for **sea salt and other salts** for food and feed: empowerment Article 21 production, Article 30 (7)(a) labelling if needed – GREX 16 May
- Draft DA detailed production rules for **insects for feed and food:** empowerment Article 14(2)(e) adding detailed rules on livestock production rules as regards derogations as regards the origin of animals, nutrition, housing and husbandry practices, health care, animal welfare – GREX 16 May
- Draft IA amending list of **authorized products and substances**, regular review at least annual: empowerment Article 24 pending files already examined by EGTOP and feed additives pet food – COP 17 May
