The UK withdrew from the Union on 1 February 2020 but, in accordance with the Withdrawal Agreement, could continue to participate in the EU school scheme in 2020 and be reimbursed for payments made to aid applicants by 15 October 2020 (= 2020 financial year for the European Agricultural Guarantee Fund).

Disclaimer. While due care was paid to ensure factually correct information, the competent authorities in the Member States are the only qualified reference point. Figures on budget execution (December 2020) are preliminary as corrections are possible and payments were, and may still be, made.
