

## MONITORING EU AGRI-FOOD TRADE: DEVELOPMENTS JANUARY 2021




#### JANUARY 2021: EU27 AGRI-FOOD TRADE DECREASES SIGNIFICANTLY

In January 2021, EU27 agri-food trade (exports plus imports) reached a value of €22.6 billion; i.e. 13% less than in January 2020. EU27 exports decreased by 11%, reaching €13.5 billion. EU27 imports attained €9.1 billion, 16% less than in January 2020. Looking at the developments from the perspective of preceding months, in January 2021 the value for EU27 exports fell by 15% when comparing to December 2020 and the value of EU imports decreased by 9%.

## **EU27** EXPORTS: MAJOR FALL WITH **EU** EXPORTS TO THE **UK**

On a year over year basis, the highest increases in monthly export values (January 2021 compared to January 2020, EUR million) were recorded for **China** (+€146 m, +11%). This continued to be primarily driven by an increase in the EU exports of pig meat (+€90 m, +20%), however at a slower pace than recorded in previous months due to the Chinese sanitary restrictions on pig meat imports from some EU countries. Other products with highest gains in export values to China continued to be coarse grains (+€71 m), and rapeseed and sunflower oils (+€51 m).

Apart from China, other countries for which the value of EU agri-food exports increased most include **Chile** (+€29 m, +55%), **Pakistan** (+€24 m, +101%), Norway (+€24 m, +6%), Lebanon (+€18 m, +37%) and Canada (+€17 m, +6%).



On the other hand, the EU27 export values in January 2021 decreased most to the **United Kingdom** (-€792 m, -24%). The significant falls in EU27 exports concern the majority of agri-food products. Looking at the developments from the perspective of preceding months, the value of EU27 exports to the UK were 32% lower than in December 2020 following the decrease of 9% already in November 2020.

Other destinations, for which the value of EU27 agri-food exports fell most, include the United States (- $\in$ 254 m, -14%), the Russian Federation (- $\in$ 110 m, -17%), Japan (- $\in$ 66 m, -11%) and Saudi Arabia (- $\in$ 62 m, -18%).

The main EU27 export destinations in January 2021 were the UK, the USA, China, Switzerland and Russia. Almost 50% of EU agri-food exports went to these five countries.

#### **EU27** EXPORTS: DECREASE DRIVEN BY FALLS OF SOME TOP EU EXPORT PRODUCTS


Looking at product categories, the highest increases in export values (though minor) in January 2021 compared to the same month 2020 were reported for **pet food** (+ $\in$ 17 m, +4%), **rapeseed and sunflower oils** (+ $\in$ 15 m, +6%), **citrus fruit** (+ $\in$ 11 m, +10%), oilcakes (+ $\in$ 8 m, +16%), cocoa paste and powder (+ $\in$ 7 m, +5%).

On the other hand, significant reductions in EU exports in value terms were noted in sectors largely affected by lockdowns and economic crises induced by the COVID-19 pandemic. Biggest decline continued to be reported in exports of product categories such as **wine** (- $\in$ 188 m, -17%), **infant food** (- $\in$ 142 m, -20%), **preparations of vegetables and fruit** (- $\in$ 89 m, -15%), chocolate and confectionary (- $\in$ 79 m, -12%), fresh and chilled vegetables (- $\in$ 64 m, -11%), spirits and liqueurs (- $\in$ 63 m, -11%).

The top EU agri-food export products in January 2021 included wine, pig meat, pasta and bakery products, chocolate and confectionary, and infant food. These products accounted for more than 26% of EU27 total agri-food exports.

## EU27 IMPORTS: SHARP FALL IN EU IMPORTS FROM THE UNITED KINGDOM

The value of January 2021 EU27 agri-food imports compared to January 2020 increased most from **Malaysia** (+€25 m, +15%), **India** (+€21 m, +11%), **Brazil** (+€14 m, +2%), Nigeria (+€13 m, +31%) and Pakistan (+€12 m, +34%).



On the other hand, the EU27 import values decreased most to the **United Kingdom** (-€874 m, -67%). This relates to the end of the transition period on 31 December 2020 following the UK departure from the EU. All agri-food product categories reported decreasing imports from the UK.

Other countries, for which EU27 imports fell most in value terms, included **Argentina** (- $\in$ 126 m, -37%); and **the United States** (- $\in$ 88 m, -8%). Significant falls in agri-food imports remained also to be reported for Indonesia (- $\in$ 83 m, -20%); and China (- $\in$ 64 m, -12%).

The top origins for EU agri-food imports in January 2021 included the USA, Brazil, Ukraine, China and the United Kingdom. These countries accounted for almost 35% of EU27 agri-food imports in value terms.

## **EU27** IMPORTS: FALLING IMPORTS OF COARSE GRAINS, OILCAKES AND SPIRITS

Looking at product categories imported in January 2021 compared to January 2020, the highest increases in import values were reported for **soya** beans (+€139 m, +33%), **rapeseed and sun flower oils** (+€36 m, +15%), **oilcakes** (+€35 m, +7%), eggs and honey (+€8 m, +15%), and olive oil (+€6 m, +28%).

On the other hand, imports of **tropical fruit** (-€270 m, -21%), **palm and palm kernel oil** (-€129 m, -26%), **spirits and liqueurs** (-€102 m, -45%), bovine meat (-€96 m, -49%), and coarse grains (-€90 m, -24%) have continued to decrease most in value terms.

The top EU agri-food import products in January 2021 included fruit (tropical and other than citrus), oilcakes, unroasted coffee and tea, palm and palm kernel oil. These products accounted for nearly 31% of EU27 agri-food imports.

#### **EXPANDING SURPLUS IN EU27 AGRI-FOOD TRADE**

With exports and imports both decreasing, but with stronger falls on the import side, the agri-food trade surplus in January 2021 stood at €4.4 billion, an increase of 3.6% compared to January 2020.
