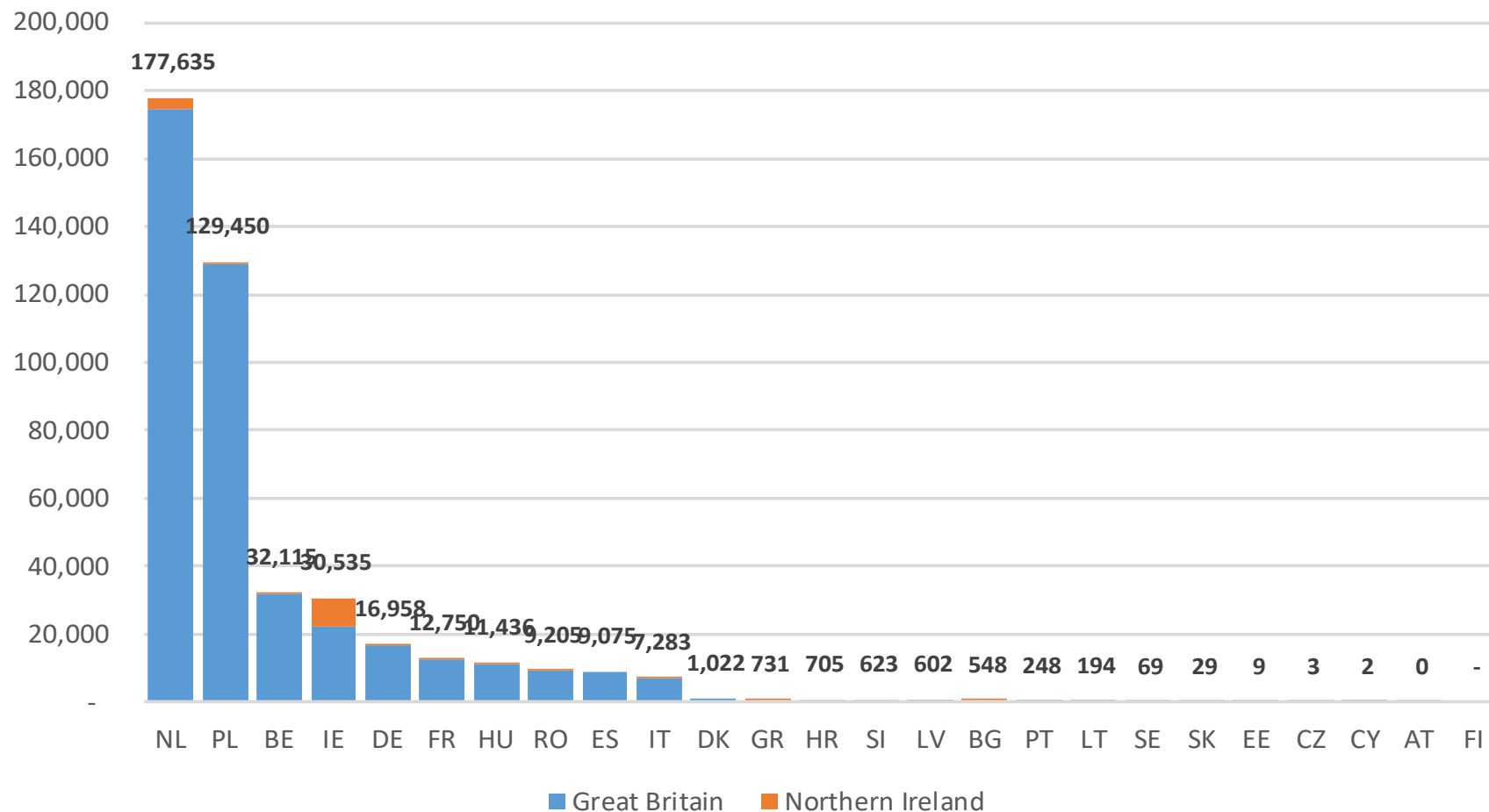

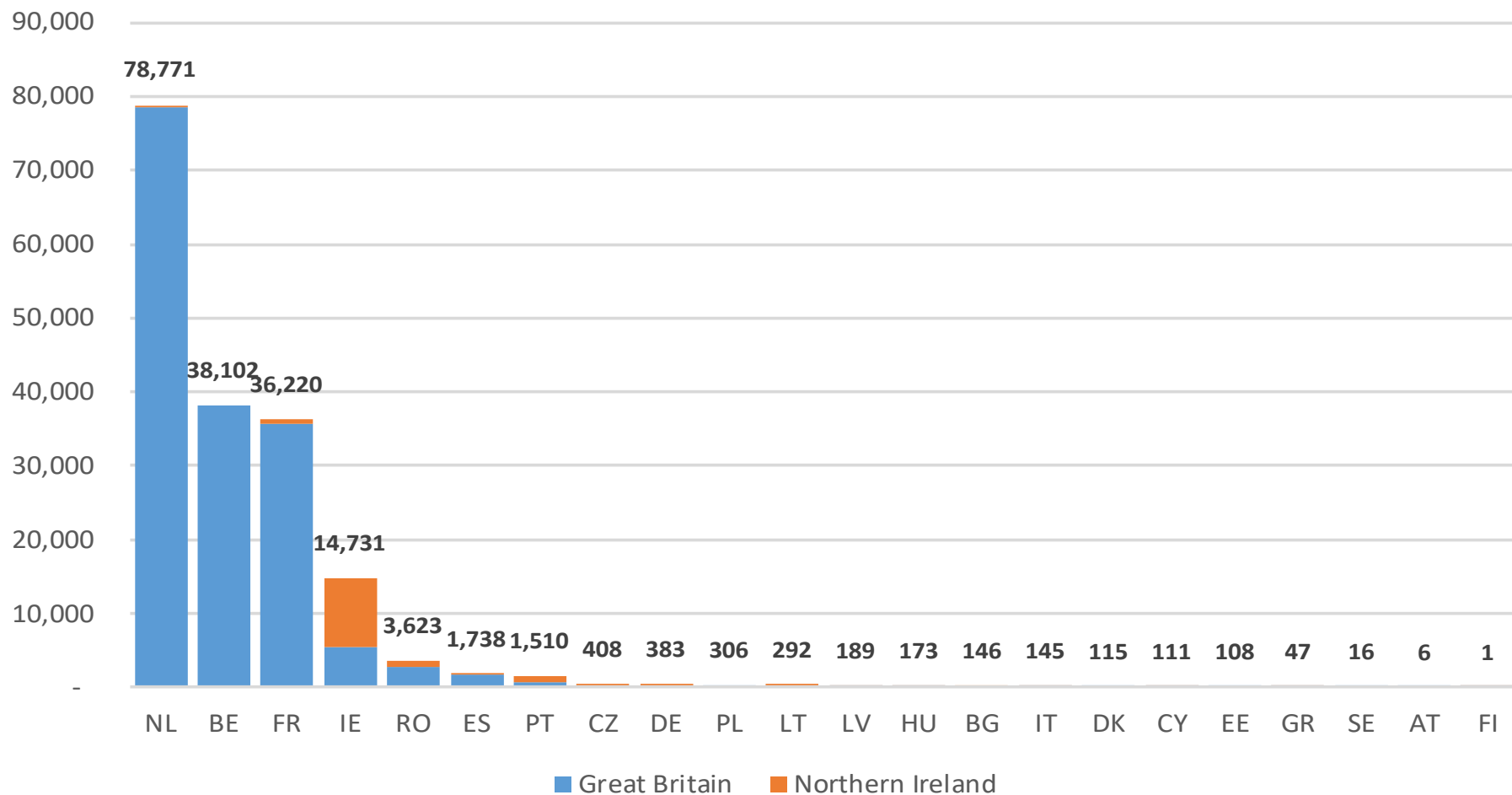

BREXIT apportionment

- EU WTO Schedule includes quantitative commitments
- Apportionment of EU WTO TRQ on the basis of a joint approach with UK to split the volumes according to trade data during a representative period (2013-2015)
- Methodology: $\text{EU28 volume} = \text{new volume EU27} + \text{new volume UK}$
- Unilaterally, EU implemented the new volumes implemented as of 1 January 2021 by Implementing Commission Regulation (EU) 2019/386 (*Regulation (EU) 2019/216 of the European Parliament and of the Council*)
- In parallel, Commission conducted and is conducting with WTO partners negotiation process under Article XXVIII of GATT 1994.
- 22 countries with negotiation or consultation rights were identified.
