# Acts reviewed in relation to **eggs**

- 1 Delegated Act amending Point III of Part VI of Annex VII to the CMO **Regulation (EU) n°1308/2008**
- 2 acts replacing Commission **Regulation (EC) n° 589/2008**
  - 1 Delegated act
  - 1 Implementing act

# Process for Implementing and Delegated acts

- Discussions during 1 year
- Feedback mechanism “have your say” from 21 April to 19 May 2023
  - No feedback received for the Implementing Act
  - 54 feedback for the Delegated Act, 43% were from EU citizens, 31% from business associations, 15% from companies, 7% from NGOs, 2% from public authorities and 2% from other stakeholders
- Proofreading in June
- Unanimous favourable vote for the Implementing act in July
- Under Council and Parliament scrutiny since 21 August 2023 (2 months period)
- Publication Official Journal foreseen end of October
- Entry into force 20 days after publication

## Point III of Part VI of Annex VII to Regulation (EU) n°1308/2013

- **Marking of eggs on production site** becomes the rule; MS can allow marking at packing centre

## Delegated and Implementing Act repealing Regulation (CE) n° 589/2008

- Implementing has provisions that were already in Regulation (CE) n° 589/2008 (e.g. records, checks)
- Main changes in Delegated act:
  - **Date of minimum durability of eggs** moved from marketing standards (589/2008) to hygiene rules (853/2004 – SANTE)
  - **Solar panels** can be authorised in open air runs for free range hens
  - Allowing **aromatised eggs as fresh eggs**
  - **Eggs from free range hens under veterinary housing order** can be marketed as 'free range' without restriction to 16 weeks
