What is the November 2017 Communication for?

- To provide policy orientations and guidance on the future CAP
- Without pre-empting the next proposals on the Multiannual Financial Framework (expected May 2018)



The objectives of the Communication at a glance

Strengthen the environmental and climate ambition...

- *... because it is urgent*

Better target support ...

- *... because it is fairer*

Rely more of knowledge and innovation ...

- *... because it is modern*

Rebalance the responsibilities between EU, MS and the farmer...

- *... because it could be simpler*



Stepping up Environmental and Climate action

Farming is affected by climate change and environmental degradation



Farming impacts on the environment and can help achieving COP21 goals and SDGs

Principles for future CAP

- *Increased ambition, more targeting*
- *Improved green architecture*
- *Closer integration of EU Climate and Environment Policies*





Stepping up Environmental and Climate action

- *Implications/ideas for the future CAP*
 - *Current **green architecture to be replaced***
 - *Environmental and climate objectives set at **EU** level, adequate targets in CAP strategic plans*
 - **Member States**
 - *Devise a mixture of mandatory and voluntary measures in Pillar I and Pillar II*
 - *Further define conditionality*
 - *Explore introduction of **nutrient management plan***
 - *Explore incentives for **precision agriculture***

DISTRIBUTION OF EU DIRECT SUPPORT TO FARMERS





A fair income support

*Perceived unfairness of direct payments
20% of farms receive 80% of payments*

- *Implications/ideas for the future CAP*
 - *Distribution concerns => need for better targeting
- Capping, degressivity and redistribution*
 - *Reduced inequalities between Member States*

Using research and innovation

Patchy access and uptake of new knowledge and technology

Role for CAP to speed up innovation (e.g. EIP-AGRI)

- *Implications/ideas for the future CAP*
 - *Sharing knowledge– **robust farm advisory services** a condition for approval of the CAP strategic plan*
 - *Linking advice to the implementation of CAP support*
 - *Enhancing synergies with Research & Innovation Policy*

Growth and jobs in rural areas...

- ... to address structural weaknesses and promote bio-economy

Attracting new farmers ...

- ... to address the generational renewal challenge

Improve risk management tools ...

- ... to better address price, income and production-related risks





An example of a climate objective (cut in CGH emissions)



1. EU Specific objectives

- Climate change mitigation & adaptation

2. EU Impact indicators (e.g.)

- Reduce GHG emissions from agriculture / Indicator: GHG emissions from agriculture
- Current CMEF: Impact indicator I.07, context indicator C.45
- Data sources: European Environment Agency

3. Climate objectives from EU legislation

- Reduction of greenhouse gas (GHG) emissions by 30 % by 2030 in the non-ETS (emission trading system) sectors, including agriculture, pursuant to the 2030 Climate and Energy Framework

4. Identification of needs in MS's CAP plan

- The ex-ante assessment helps to identify specific needs in relation to reducing GHG emissions
- The CAP plan highlights the link to the existing climate legislation (2030 Climate and Energy Framework,...)

5. Contribution of MS's CAP plan to EU objectives

- The CAP plan shows how it will contribute to reaching the reduction of GHG of 30 % in non-ETS sectors by 2030
- Setting of result targets (e.g.): share of UAA receiving income support and subject to conditionality; share of livestock units concerned by support to reduce GHG emissions; share of farmers receiving advice related to env/climate performance
- Selection and definition of interventions (e.g.): maintenance of permanent grassland; feed-related Pillar II measures; training

6. CAP and MS's plan performance


- Evaluation of policy performance based on impact indicators
- Progress monitoring towards set targets based on result indicators



The CAP budget in perspective (in current prices)




