

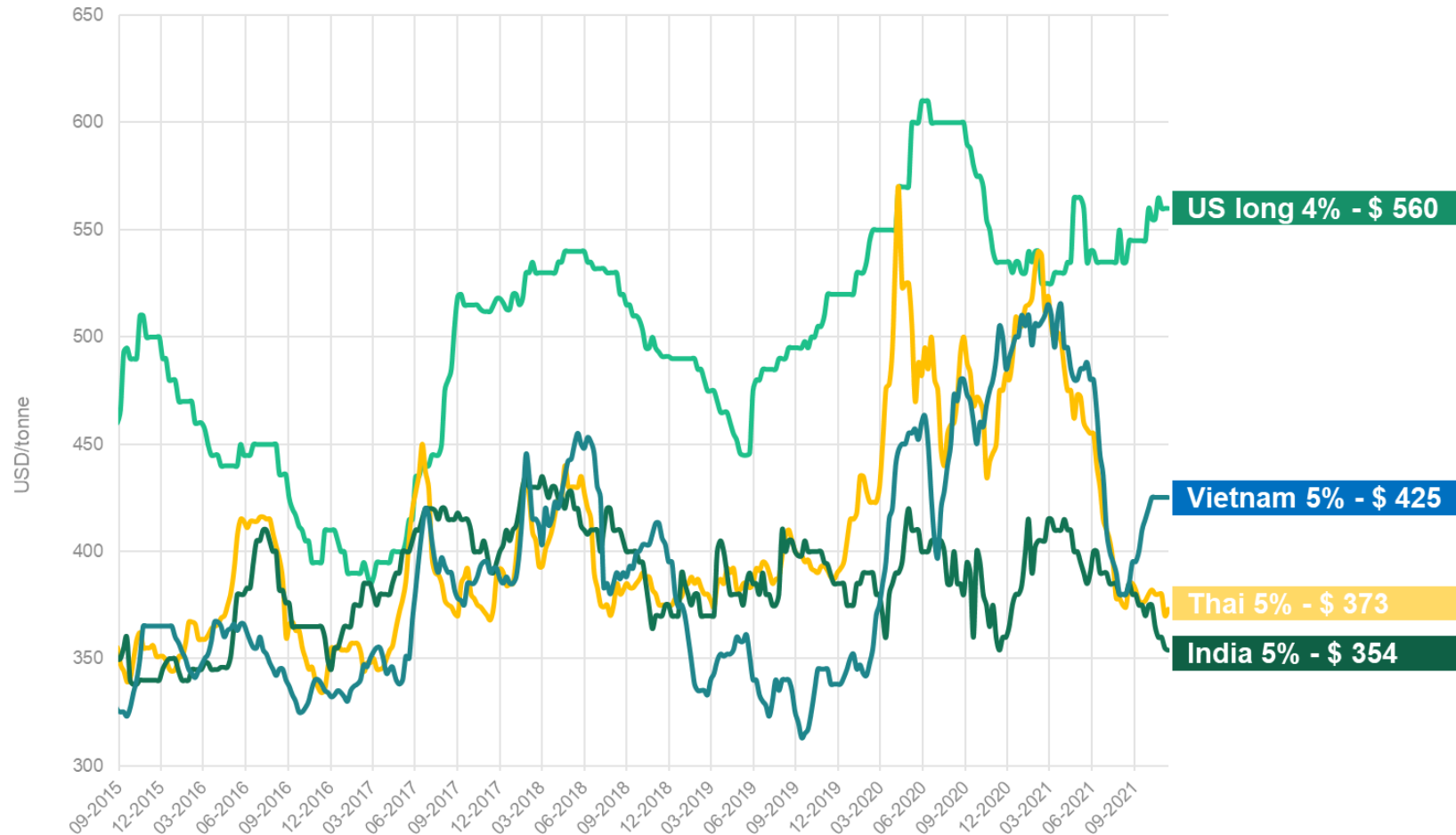

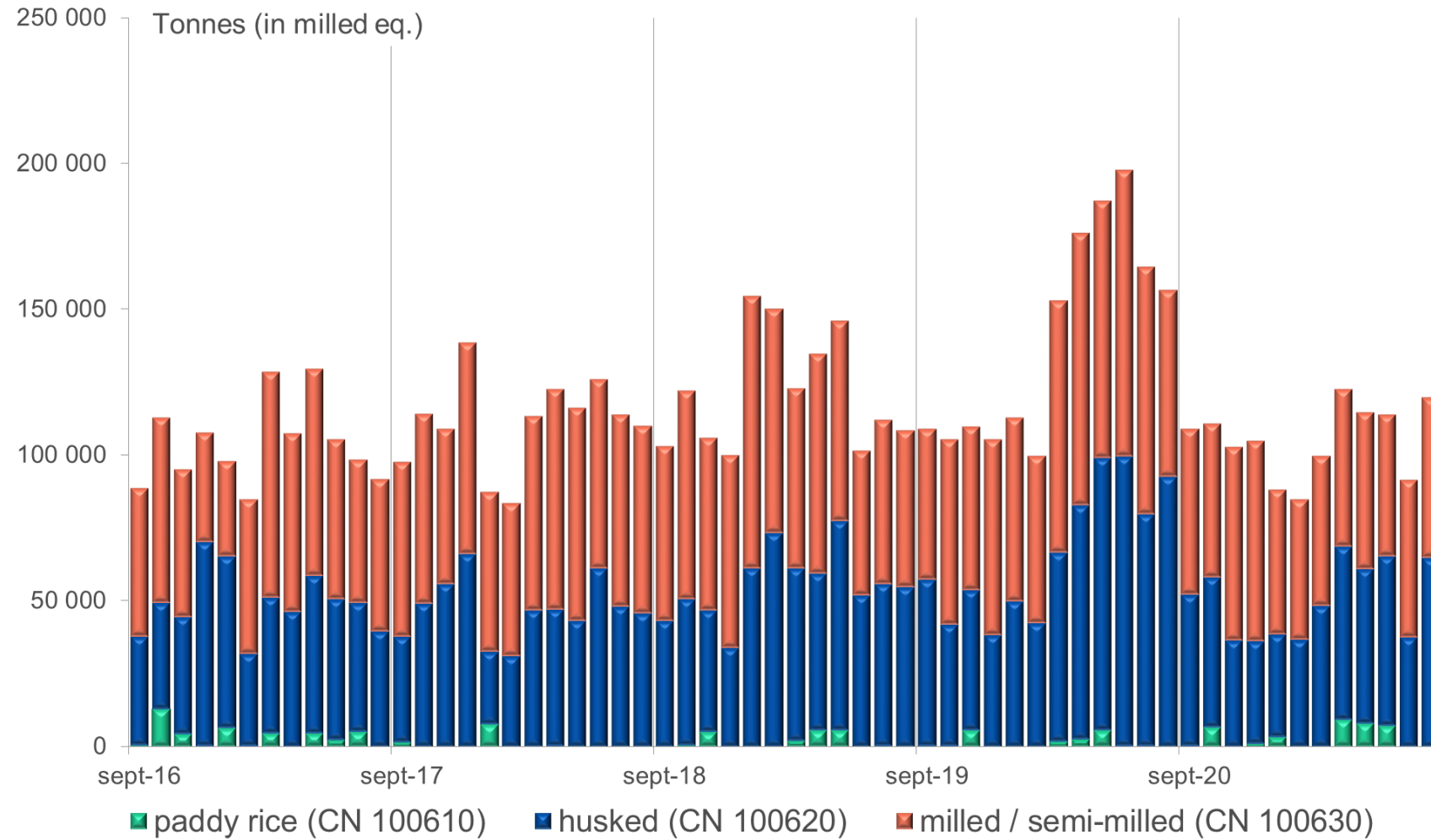

# International Rice Prices in USD/tonne



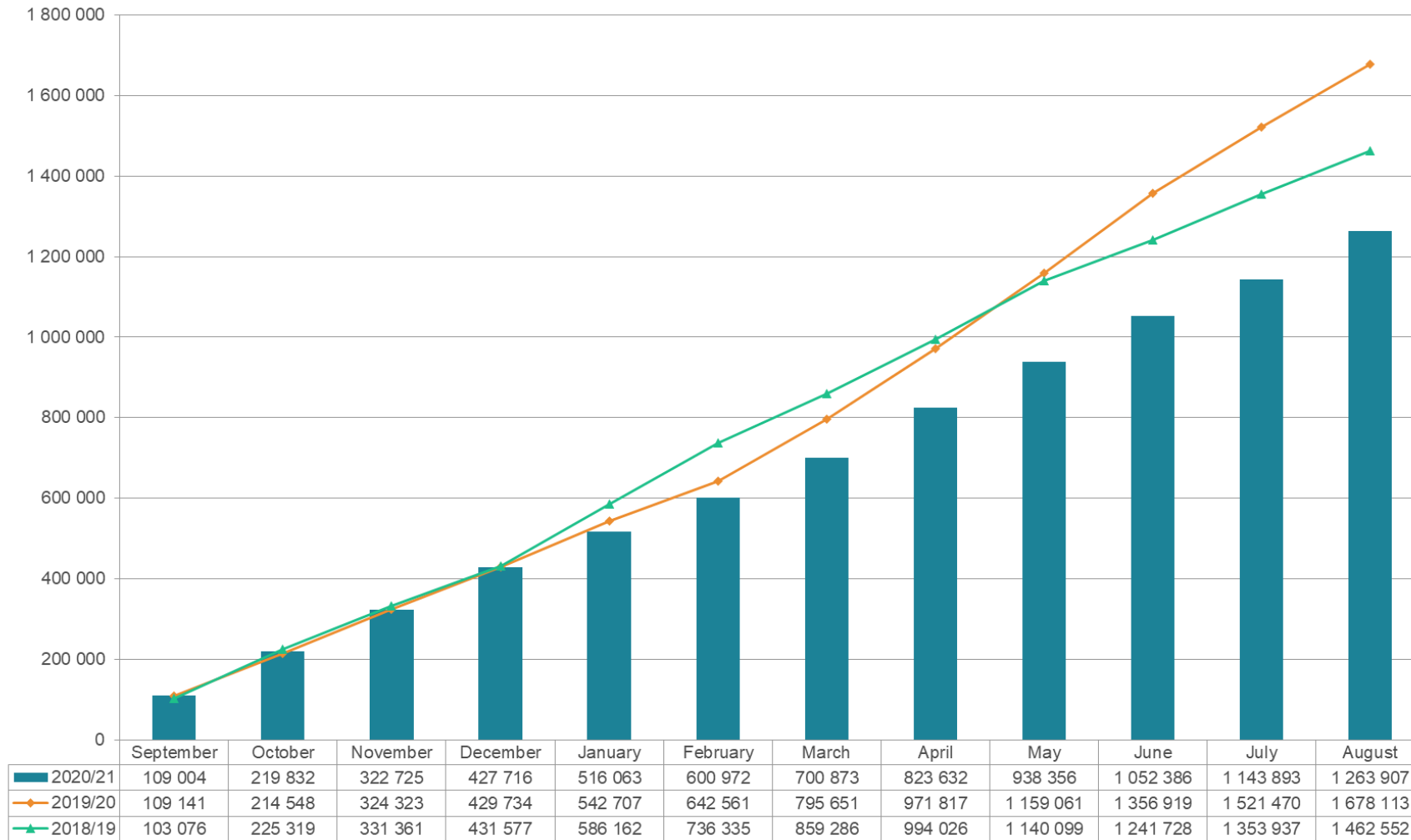

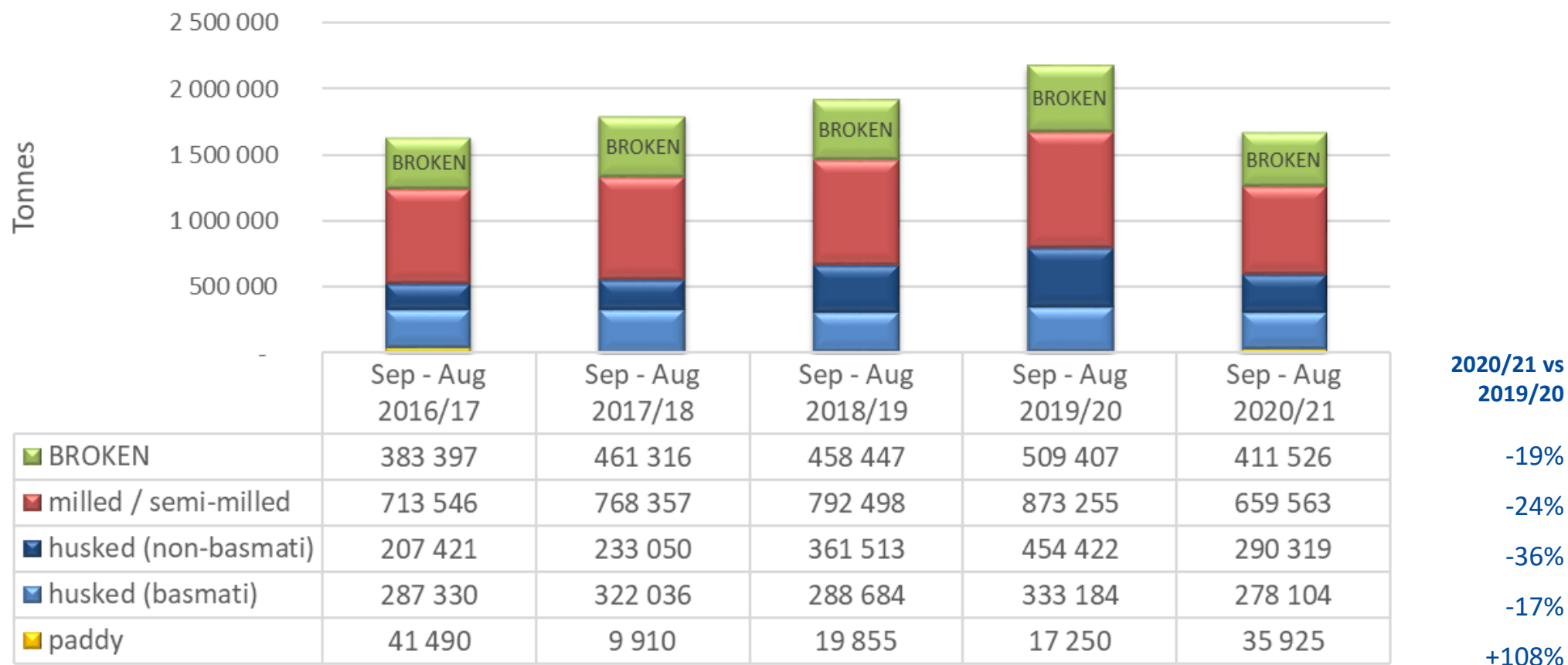

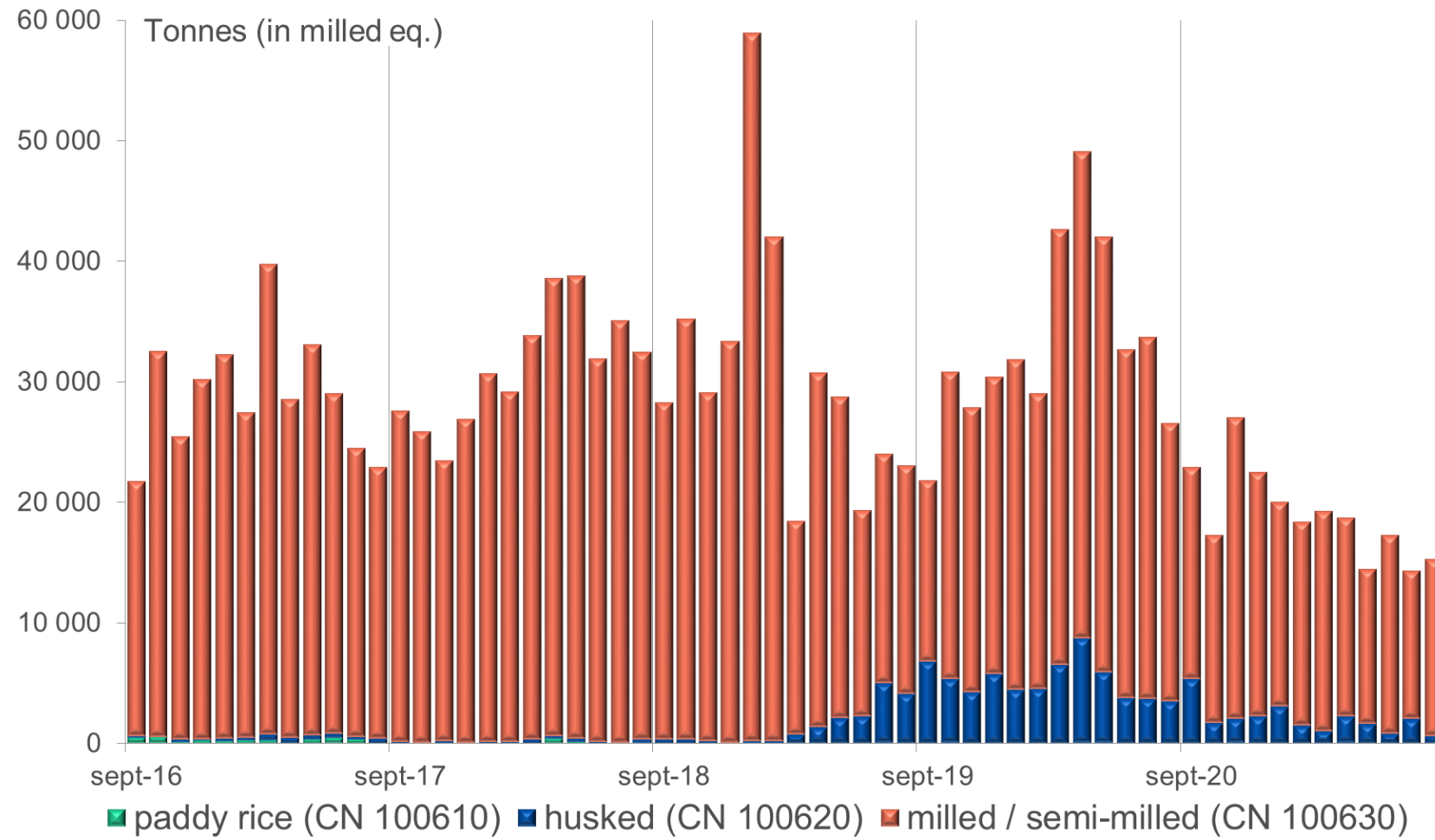

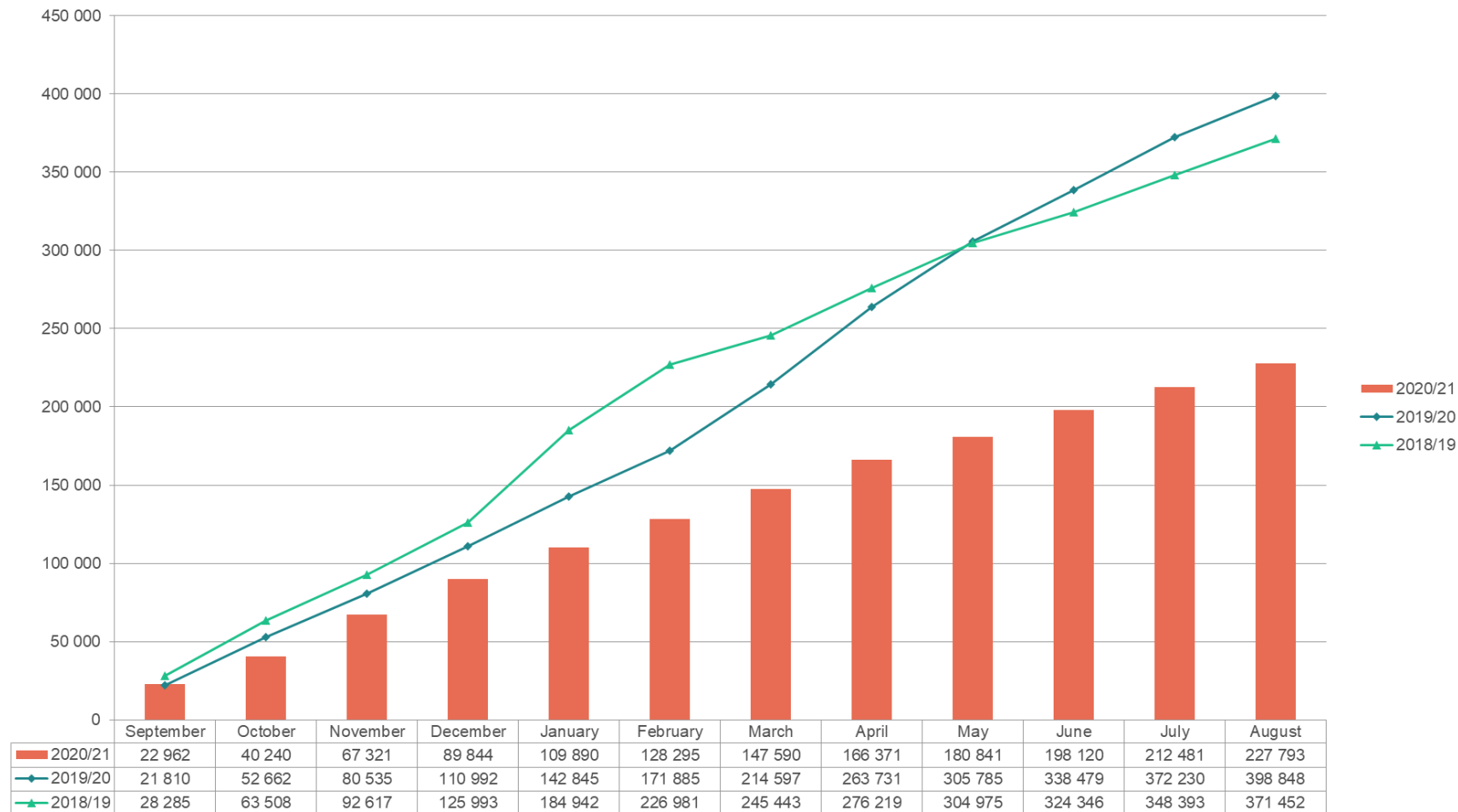

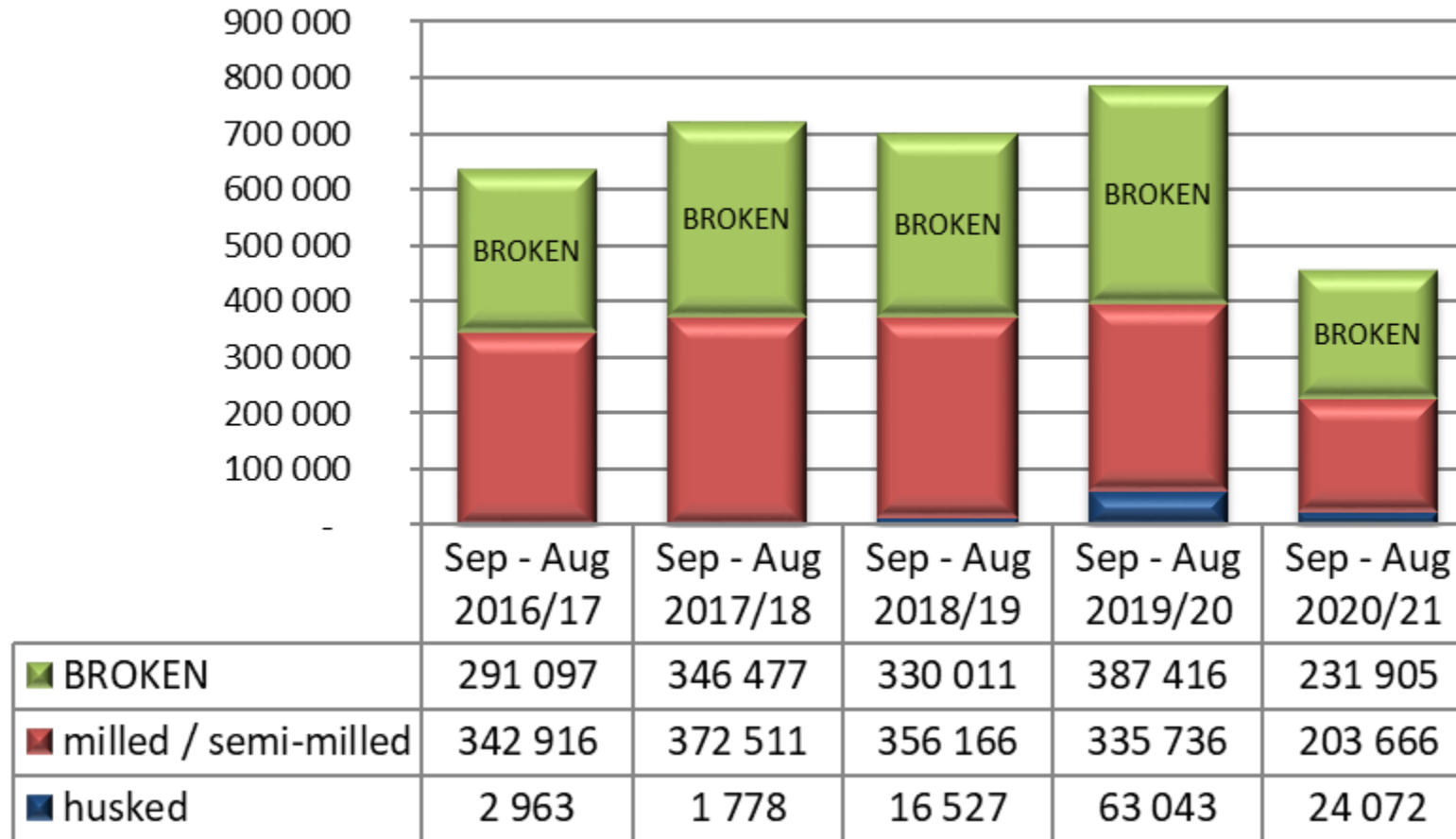

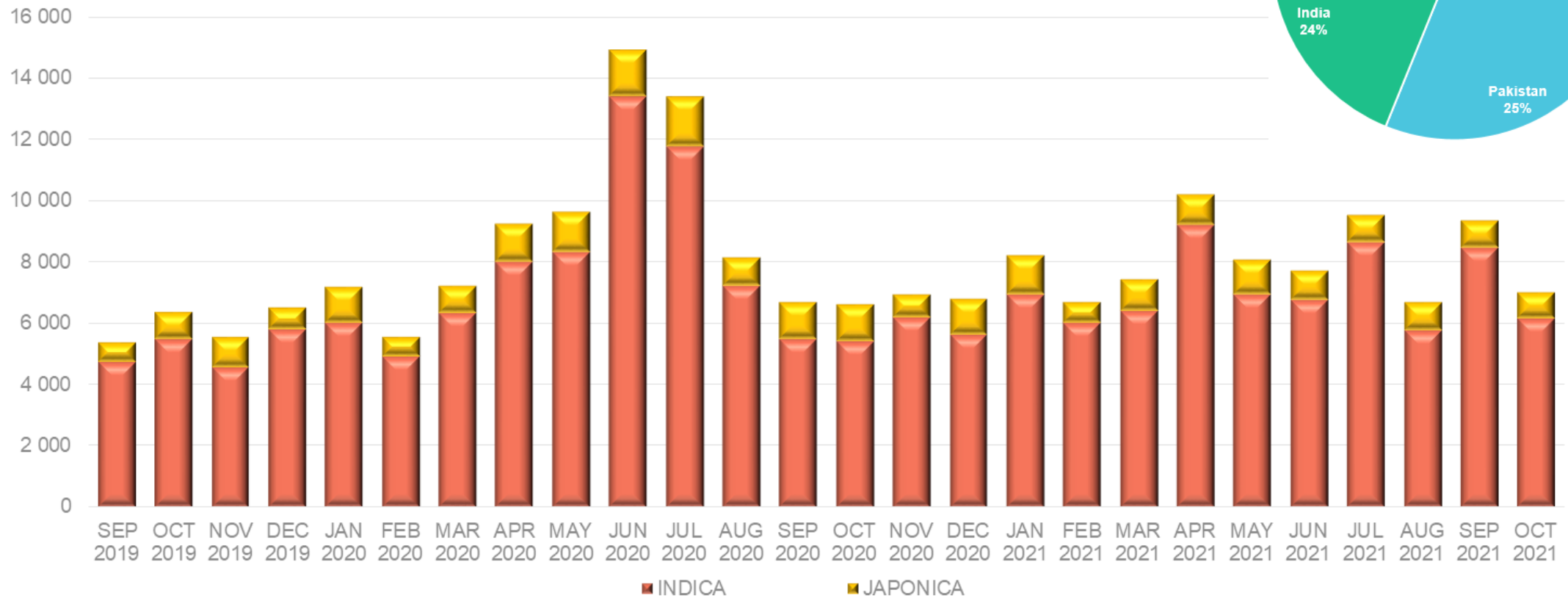

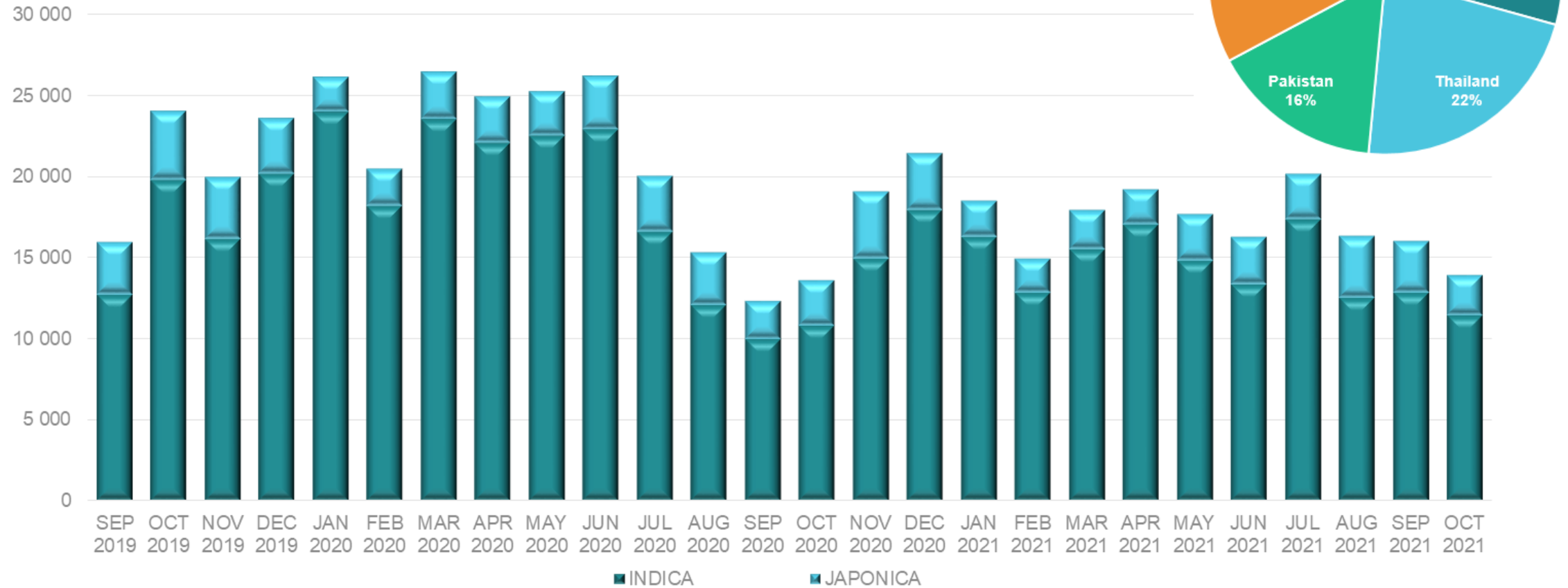
## EU 27: Imports of rice in small packages 0-5 Kg

(Marketing year 2020/21: 91 903 t (in milled eq.): DOWN 8% vs 2019/20 )

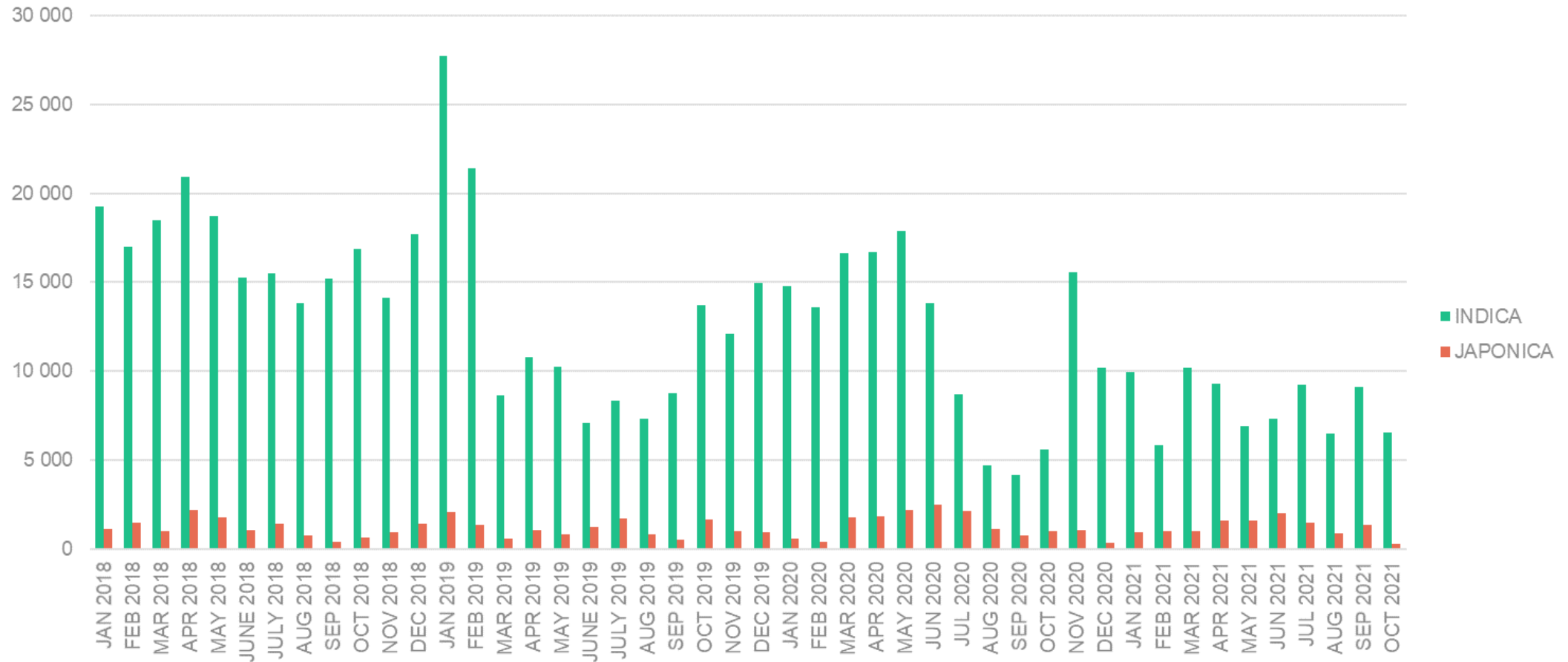


## EU 27: Imports of rice in small packages 5-20 Kg

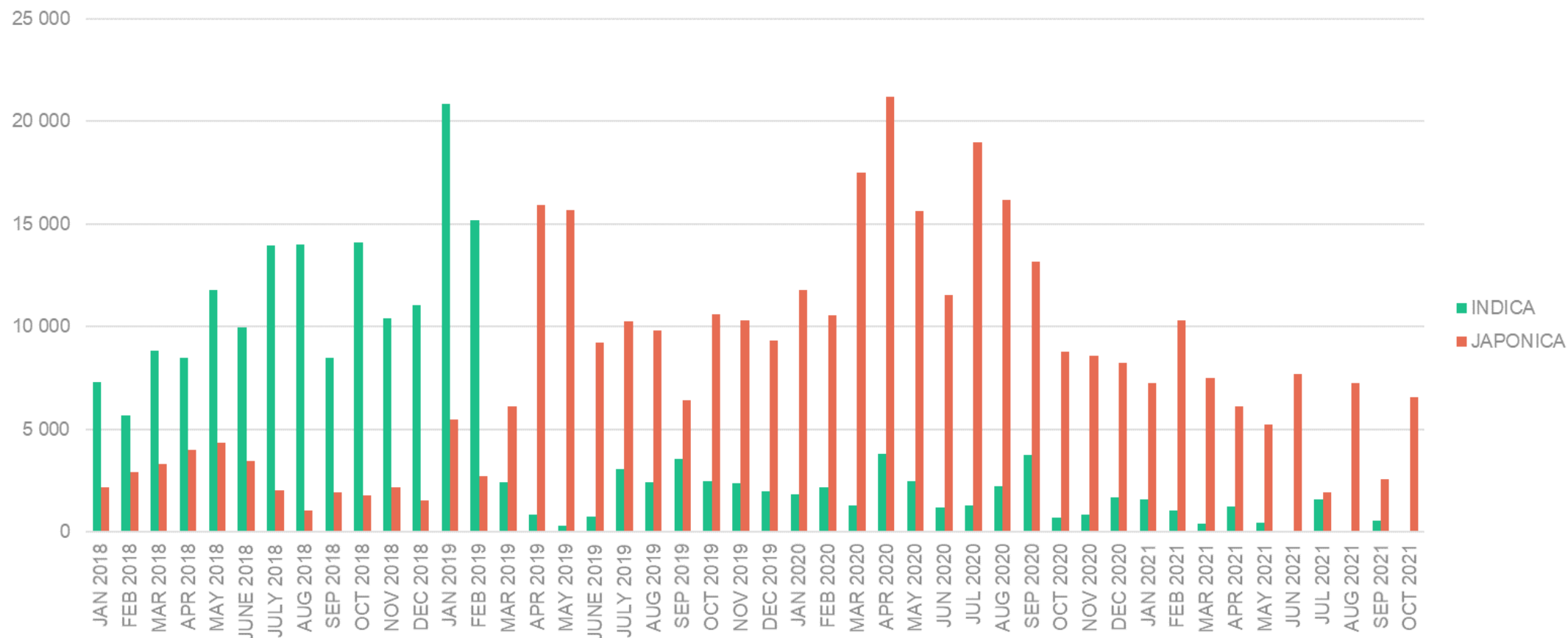

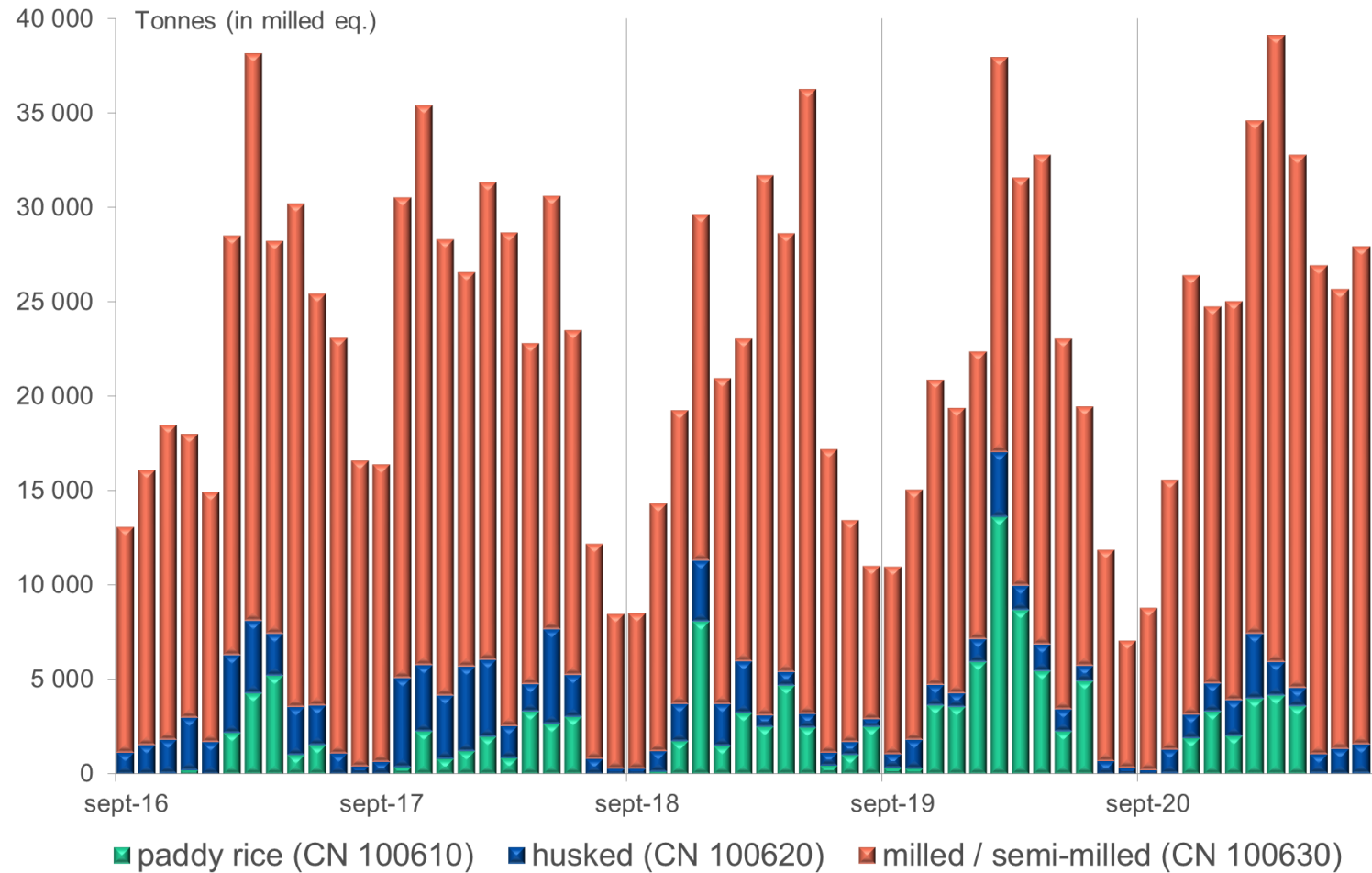

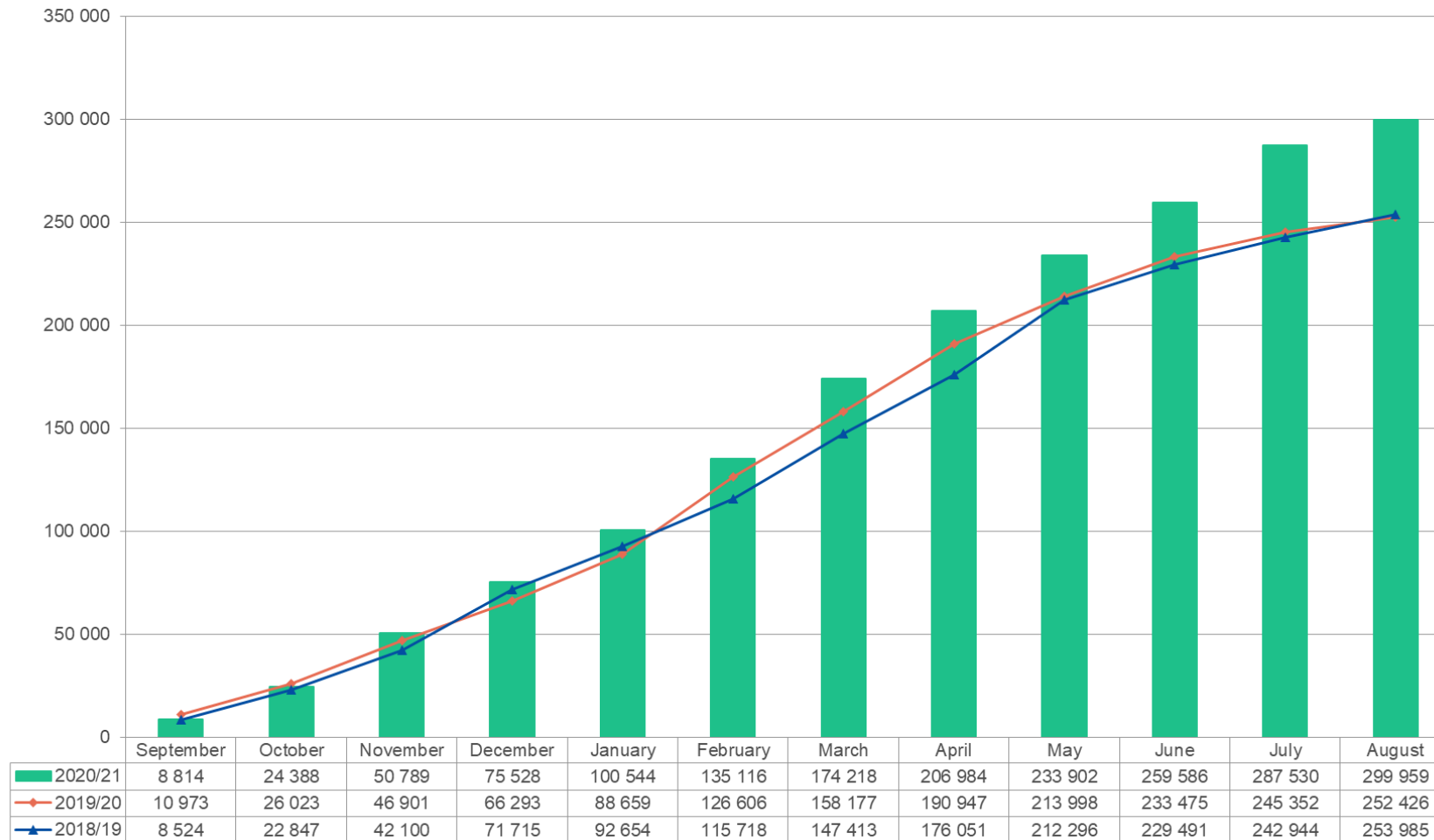


## EU\*: Total Rice Exports 2020/21: UP 19% vs 2019/20

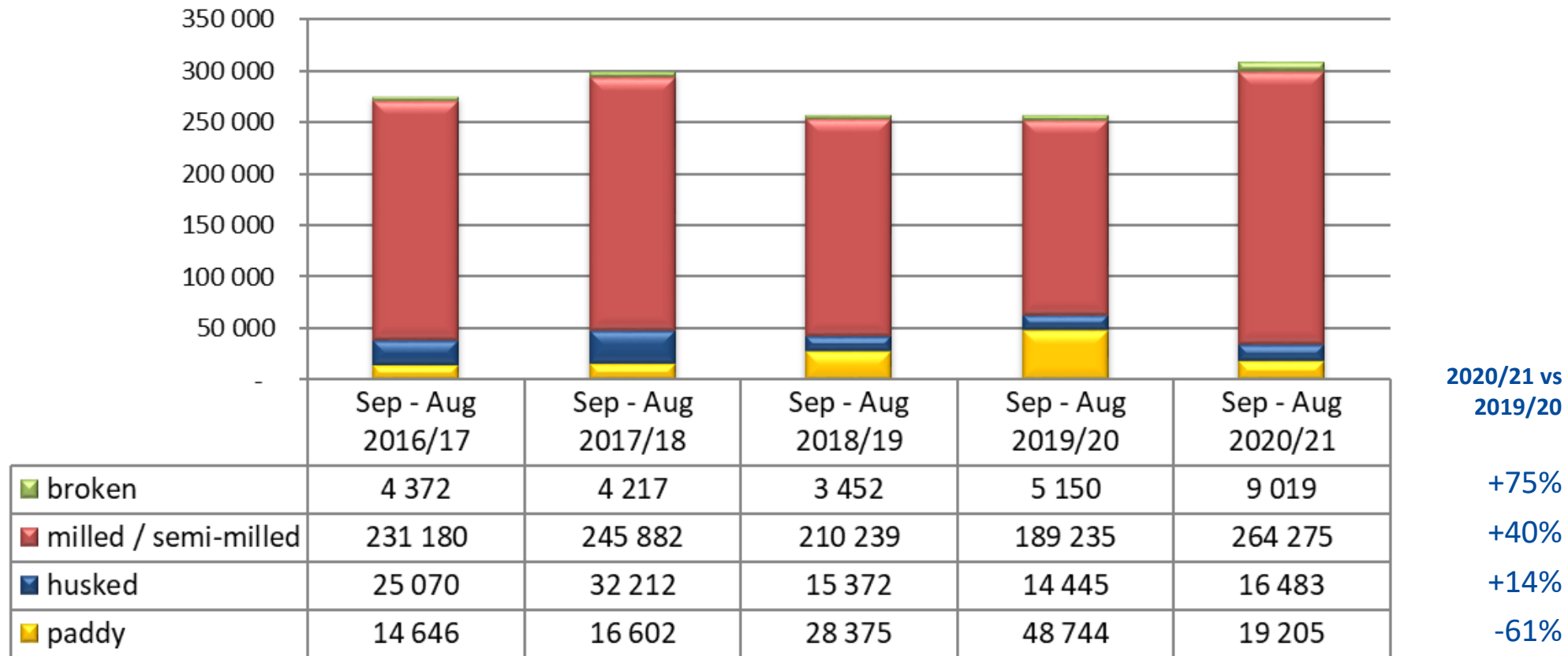

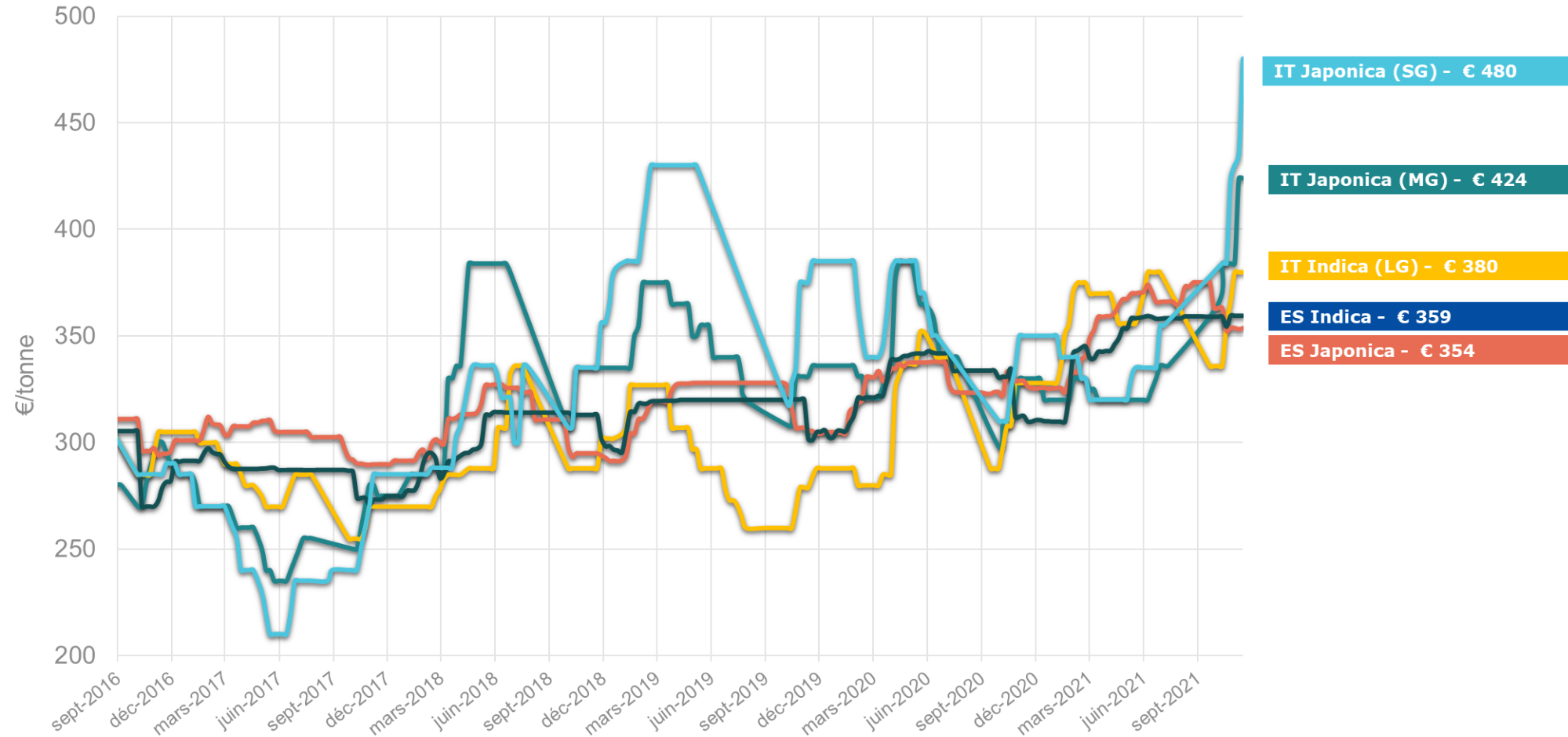
# Total EU\* Rice Exports: UP 19% in 2020/21
