Note to the reader

The latest available consolidated trade data at EU level cover market developments in March 2024. Monthly figures can be compared with the previous month. Year-on-year change compares the cumulative trade since the beginning of the year with the same period in the previous year.

The trade figures are expressed in values, except when specifically mentioned. The unit value is the average price of products traded in the period concerned (trade value at the border divided by quantity registered).

HIGHLIGHTS: EU agri-food trade surplus continued to increase in March 2024

EU agri-food trade surplus reached EUR 6.7 billion in March 2024. This is an increase of 8% compared to the previous month and 3% higher than in March 2023.

EU exports continued to increase since the January 2024 with a monthly increase of 4%, reaching EUR 20.1 billion in March 2024. This is however 6% lower than in March 2023. Export values increased significantly for olives and olive oil due to increased prices, but they decreased for vegetables oils.

EU imports are stable since the beginning of the year (+2% in March compared to February) and reach EUR 13.5 billion in March 2024. They remain however 10% lower than in March 2023. Imports of cocoa products, fruit and nuts and olives and olive oil increased, while those of oilseeds and cereals decreased.

EU AGRI-FOOD EXPORTS

EU EXPORTS INCREASED IN MARCH, BUT ARE BELOW THEIR 2023 LEVEL

EU agri-food exports reached EUR 20.1 billion

in March 2024, an increase of 4% month-on-month. However, they remained 6% lower than in March 2023. Cumulative exports in the first quarter of 2024 reached EUR 57.9 billion, a similar level as in 2023 (-1%, -EUR 320 million).

UK remained the first destination of EU exports, accounting for 22% of EU export value in the first quarter of 2024. Cumulative exports to the UK increased by EUR 214 million (+2%) compared to 2023, mostly due to increases in beer, cider and other beverages, olives and olive oil, pig meat and preparations of fruit and nuts.

The **US** was the second destination of EU exports in the first quarter (12% of EU exports) and had the largest increase of EU exports (+EUR 372 million, +6%). This is explained to a large extent by an increase in prices of olives and olive oil's exports.

China remained the third destination of EU exports (6% of EU exports), despite being the destination with the largest reduction in value in the first quarter (-EUR 477 million, -12%). This is mainly explained by reduced export volumes and prices for the two first EU exports to China: cereal preparations (-EUR 402 million, -40%) and pigmeat (-EUR 278 million, -36%).

Among other significant evolutions, EU exports increased to **Iraq** (+61%, +EUR 118 million, mainly


sunflower seeds, eggs and food preparations) and **Lebanon** (+60%, +EUR 87 million, in particular in live cattle).

On the other hand, EU exports to **Russia** decreased by EUR 454 million (-22%) compared to 2023, due to reduced exported volumes across most categories. EU exports to **Egypt** also decreased by EUR 155 million (-29%), mainly in cereals, dairy products and vegetable oils.

EU exports of **olives and olive oil** increased the most compared to 2023 (+EUR 615 million, +51%). However, this is explained by increased prices, while volumes exported slightly declined. Exports in the **coffee, tea, cocoa and spices** category also increased by EUR 211 million (+10%), mainly explained by higher prices of cocoa products. Among other significant increases, exports of **sugar and isoglucose** remained at a high level (+EUR 187 million, +123%), due to increased volumes.

EU cereals exports increased in volumes (+30%, mainly in wheat), but they decreased in value (-EUR 160 million, -4%), due to reduced prices.

On the other hand, exports of **vegetable oils** decreased by EUR 429 million (-39%), due to both reduced prices and volumes. EU exports of **dairy products** also decreased by EUR 388 million (-8%), mainly due to lower prices. **Cereal preparations** exports decreased by EUR 312 million (-5%, due to lower prices).



EU AGRI-FOOD IMPORTS

EU IMPORTS CONTINUED TO BE STABLE IN MARCH, BUT BELOW 2023

The value of EU agri-food imports reached EUR 13.5 billion in March. It is a 2% increase compared to the previous month but 10% lower than in March 2023, mainly due to reduced volumes imported. Cumulative imports from January to March reached EUR 40 billion, 6% lower than on this period in 2023 (-EUR 2.5 billion).

Brazil, the **UK** and **Ukraine** were tied as the first sources of EU agri-food imports in the first quarter of 2024, with 9% of EU import value each. Imports from Brazil decreased by EUR 466 million (-11%) compared to 2023. Those from the UK declined by EUR 232 million (-6%) and those from Ukraine decreased by EUR 414 million (-11%). These reductions are mainly explained by reduced imports volumes and prices of cereals.

Imports from **Côte d'Ivoire** continued at a hight level, with an increase of EUR 398 million (+40%) compared to 2023. This is mainly explained by higher prices of cocoa products.

Other significant increases were observed from **Tunisia** (+EUR 210 million, +108%, mainly explained by an increase of olive oil imports), **Egypt** (+EUR 164 million, +34%, mainly in olives and olive oil, vegetables and fruit and nuts) and

Cameroon (+EUR 144 million, +69%, mainly explained by higher prices of cocoa).

On the other hand, a steep reduction in imports could be observed from **Australia** (-EUR 824 million, -71%), due to a reduction in rapeseed imported volumes. Imports reduction include **Indonesia** (-EUR 475 million, -30%, mainly due to reduced palm oil imports).

Imports in the category **coffee, tea, cocoa and spices** had the largest increase (+EUR 849 million, +16%). This is mainly explained by increased prices of cocoa products.

Imports of **fruit and nuts** also grew by EUR 421 million (+8%). Cumulative imports of **olives and olive oil** continued at a high level, with an increase of EUR 324 million (+160%) compared to 2023, due to both increased volumes and increased prices.

Imports of **oilseeds and protein crops** decreased by EUR 1.5 billion (-22%), mainly due to reduced prices. Imports of **cereals** also declined by EUR 1.4 billion (-36%), due to reduction in imported volumes and prices.

Imports of **sugar and isoglucose** decreased by 41% in volume compared to 2023, a reduction of EUR 193 million (-36%) in value.


