## The legal basis

Article 52 of Regulation (EU)  
No 1305/2013

Specific support should be  
provided for the evaluation of  
Rural Development  
Programmes (RDPs)

As part of the tasks of the  
European Network for Rural  
Development (ENRD)

**The European Evaluation  
Helpdesk for Rural  
Development:**

**Is one of the two support units  
of the ENRD (besides Contact  
Point)**

**Assumes “evaluation function”  
Provides technical support for  
carrying out evaluation-related  
tasks**

**Works under the guidance of  
Unit E.4 in DG AGRI**
