

## Nigeria

➔ Issue: Restriction on the importation of milk and other dairy products



## Indonesia

- ➔ Issue: The Minister announced that if the EU will go ahead with the planned countervailing duties on biodiesel, Indonesia will announce an increase for the duties on dairy up to 25% (currently is 5%).
- ➔ Status: Mixed messages - Permanent threat



## USA

- ➔ Issue(s): EU-US WTO Civil Aircraft Disputes & butter exports.
- ➔ Status: Level of possible countermeasures (WTO report).  
Butter exports to the US can become subject to additional duties if trigger levels for safeguard measures are reached



## Tunisia

- ➔ Issue: Import restrictive measures taken by Tunisia on 28 November 2018
- ➔ Status: Resolved
