General Information on Apiculture Interventions in CAP Strategic Plans (CSP's)

- Data and graphs in this presentation refer to approved CSP's, with data extracted in May 2024.
- Most MS continue with a national co-financing rate of 50%, except for 3 MS (BG-60%, IT-70% & LU-63.8%) resulting in an overall co-financing rate of 46.8% EU / 53.2% MS.
- The planned total Public expenditure (EU+MS) for apiculture sector in the 28 CSP's for 2023-2027 amount to EUR 610.1 million during 2023-2027 of which EUR 285.6 million correspond to the EU financial contribution.
- From an EU allocation of EUR 60 million for FY 2023, 19MS used EUR 6.25million for payment of NAPs measures implemented during extension period 1/08 – 31/12/2022 for the last NAP 2020-2022.

Types of apiculture interventions in the CSPs*

- (a) Knowledge exchange, advisory, training, technical assistance
- (b) Investments, and other actions, including for:
 - *(i) combatting beehive diseases & invaders*
 - *(ii) preventing climate damage and adaptation to climate change*
 - *(iii) Restocking of beehives, bee breeding*
 - *(iv) Rationalisation of transhumance*
- (c) Analyses of apiculture products, bee losses, substances toxic to bees
- (d) Preserving and increasing the number of beehives
- (e) Cooperation for research in beekeeping & products
- (f) Promotion, communication, marketing & market monitoring
- (g) Enhancing product quality

Types of interventions chosen by MS in their CSP

(d) Preserving and increasing the number of beehives	11
(e) Research programmes	24
(f) Promotion, communication, marketing	19

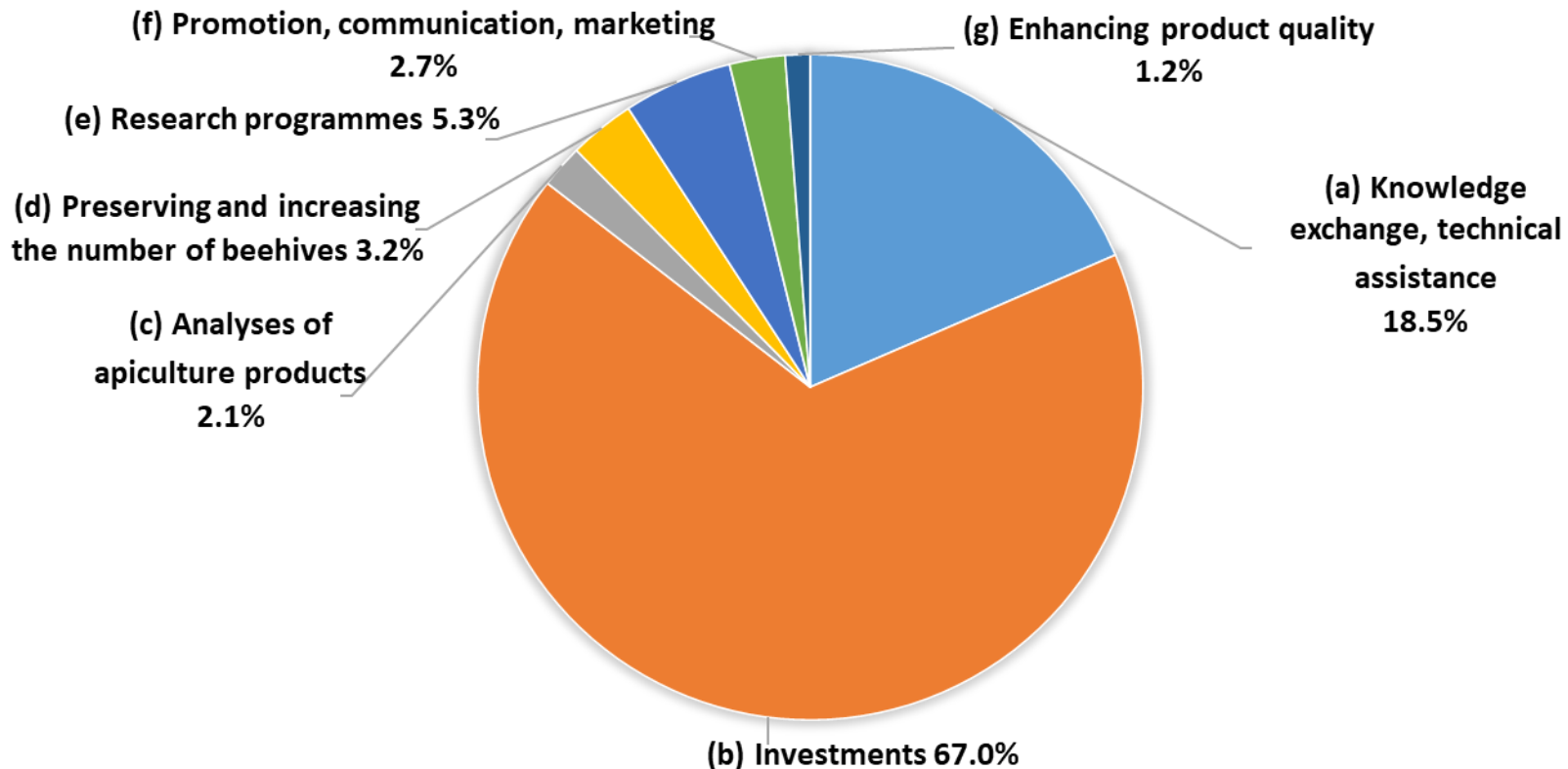

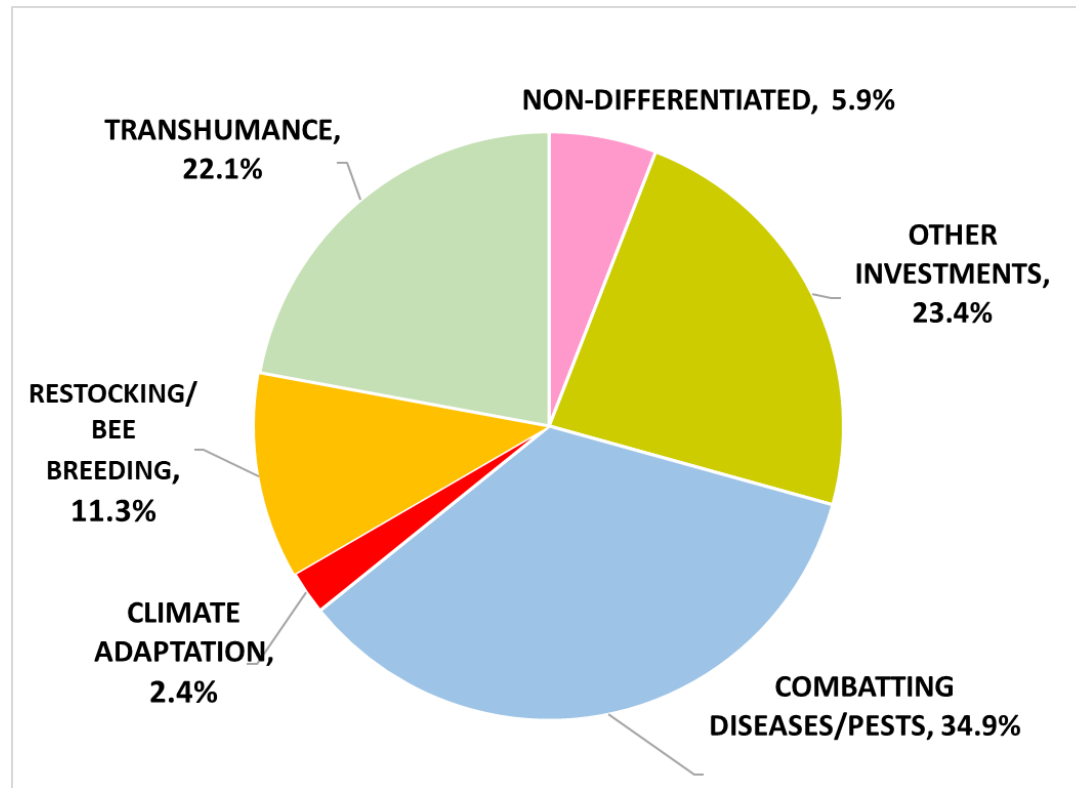

Other types of intervention benefitting apiculture

- Targeted 'environmental, climate-related and other management commitments (AECM)' Rural Development interventions supporting beekeeping – (as in BG, EE, ES, FR, HU, IT, LT, LV, MT, PT) (e.g. BG II.A.12 Promoting natural pollination; IT ACA18 Commitments for Beekeeping ; LV LA10.4 Beekeeping units for pollination needs; FR 70.29 Improving pollinator potential of bees; ES 650.14 Beekeeping for biodiversity)
- Other AECM – creation/maintaining biodiversity cover, planting of melliferous plants/Organic farming/Integrated pest management/pesticide bans etc.
- Other RD interventions – e.g. Knowledge transfer, Farm and processing investments, Setting up of POs, Quality schemes, Risk Management
- Contributing eco-schemes
 - Most involve maintaining/creating **habitat for pollinator species** and/or increasing the **availability of food sources for pollinators** in agricultural landscapes (e.g. buffer strips, planting of melliferous plants, extensive grassland management, ecological focus areas)
- Contributing interventions in the fruit & vegetables sector
 - Organic or integrated practices
