Review by the Member States of their support decisions applicable as from claim year 2019

The synthesis presented in this document reflects the content of Member States' notifications available to the Commission services as they stood on 31 July 2019. It is made available without prejudice to any finding in respect of their compliance with the regulatory framework.

1. VOLUNTARY COUPLED SUPPORT IN A NUTSHELL

Member States may use up to a maximum percentage of their annual national ceiling for direct payments to finance **voluntary coupled support** (VCS) (Chapter 1 of Title IV of Regulation (EU) No 1307/2013 of the European Parliament and the Council ('the basic act' hereafter)).

According to the currently applicable rules¹, the Member States may only decide to grant VCS to a list of sectors and productions² in sectors or regions, where specific types of farming or specific agricultural sectors particularly important for economic, social or environmental reasons undergo certain difficulties. Coupled support is a production-limiting scheme that shall take the form of an annual payment based on fixed areas and yields or on a fixed number of animals and shall respect financial ceilings to be determined by Member States for each measure and notified to the Commission (Article 52(6) of the basic act).

Each Member State may only use a limited part of its national ceiling for direct payments to grant VCS. This **budgetary limit** is 8+2%, which, under certain conditions, may be increased to 13+2%. Further increase is possible only if certain specific needs require so, in which case the decision of the Member State is also subject to approval by the European Commission.

The Member States could apply VCS as from claim year 2015. They may review their support decisions on an annual basis (notification due by 1 August of the previous year).³

2. VCS REVIEW APPLICABLE FROM CLAIM YEAR 2019 - OVERVIEW

- Number of Member States: In the framework of the 'original support decisions', 27 Member States (i.e. all Member States except for DE) decided to apply VCS from claim year 2015. This has remained unchanged so far, also including this review.
- Number of support measures: 256 measures were implemented by these 27 Member States as from claim year 2015. Following the 2016 review, the number of measures increased to 264 as from claim year 2017. As result of the review as from claim year 2019, the number of measured decreased to 258 measures.
- Budget: The annual monetary allocation has been, and remained after this review, around EUR 4.2 billion per year, which represents a little above 10% of the direct payments budget (EU28).
- Support distribution per sector: The **three animal-based sectors** have always been, and also remained after this review, the largest VCS beneficiaries, receiving almost **75% of all coupled support**. The most important area-based beneficiaries are **protein crops** (11.2%), **sugar beet and fruits and vegetables** (each with 4.3% share).




As from claim year 2019. Previously, the basic act allowed a single review by 1st August 2016 with application as from claim year (CY) 2017.

Member States' overview:

- **9 Member States** (Bulgaria, France, Greece, Hungary, Italy, Malta, Slovakia, Spain, and Slovenia) decided to use this review possibility.
- 19 Member States (Austria, Belgium, Cyprus, The Czech Republic, Denmark, Estonia, Finland, Croatia, Ireland, Lithuania, Luxembourg, Latvia, The Netherlands, Poland, Portugal, Romania Sweden, the United Kingdom and Germany) left their previous support decisions unchanged. NB: Germany maintained its former decision not to grant VCS.

3. Review overview for the main sectors⁴

3.1 Beef and veal sector

VCS decisions in general⁵:

- Number of Member States: In the framework of the 'original support decisions', 24 Member States decided to grant coupled support for beef and veal as from claim year 2015. This number decreased to 23 Member States from claim year 2017, which remained unchanged in this review.
- Number of support measures (EU 28): In comparison with the former support decision, it remained unchanged, with **54 measures** as from claim year 2019.
- Budget: The review decreased the sector's monetary allocation (EU28) by some 2% from EUR 1 712 million to EUR 1 682 million in claim year 2019, and increased to EUR 1 717 million in claim year 2020.

Therefore, though the beef and veal sector has always been, and also remained after this review, the biggest VCS beneficiary, its share in total VCS budget slightly decreased (by 1%) to around 40%. This represents 4.1% of the annual national ceiling for all direct payments.

- Fixed number of heads (EU28): It remained roughly stable at around **19.3 million heads** 6 .
- Per unit amount (prior estimate): The average support rate (88 EUR/head; EU28 average) remained roughly at its previous level. This still exceeds the average support level available under the other animal based sectors (milk and milk products; sheep and goat meat).

Reviewed measures:

- **New/deleted** measures: No new measures were created, nor any existing one deleted.
- Modified measures: Three Member States (Bulgaria, Italy and Slovakia) carried out modifications, which typically affected the targeting and/or financial envelope.

3.2 Milk and milk products sector

VCS decisions in general⁷:

- Number of Member States: In the framework of the 'original support decisions', 19 Member States decided to grant coupled support for the milk and milk products sector as from claim year 2015. This decreased to 18 from claim year 2017, but grew back to 19 Member States from claim year 2019 following this review.
- Number of support measures (EU28): in comparison to the former support decision, it remained unchanged with **31 measures**, as from claim year 2019.

Comparison is made with the results of the previous review due by 01/08/2016, with application as from CY2017

Further details are available in Table 1 in the annex.

Concerning the fixed references (fixed areas or fixed number of animals), it is to be noted that in some case the Member States' notifications were incomplete. On the other hand, in some cases double-counting is not to be excluded.

Further details are available in Table 2 in the annex.

Budget: The review decreased the sector's monetary allocation (EU28) by less than 1% from EUR 899 million to EUR 885 million EUR in claim year 2019 and from EUR 888 million to EUR 882 million in claim year 2020.

The milk and milk products sector has always been, and also remained after this review, the 2nd biggest VCS beneficiary (after the beef and veal sector). Its share from VCS remained **somewhat below 21%** (EU28). This represents around **2.1%** of the annual national ceiling for direct payments.

- Fixed number of heads (EU28): Down by 7.4% from 12.2 to 11.3 million heads.
- Per unit amount (prior estimate): The average support rate increased from 73 EUR/head to 78 EUR/head (EU28 average).

Reviewed measures:

- New/deleted measures: in comparison with the former support decision, France deleted two measures.
- Modified measures: Five Member States (Bulgaria, France, Italy, Malta and Slovakia) carried out
 modifications of already existing measures. These changes concerned the eligibility conditions, the
 financial envelopes and/or the fixed number of heads.

3.3 Sheep and goat meat sector

VCS decisions in general8:

- Number of Member States: In the framework of the 'original support decisions', 22 Member States decided to grant coupled support for the sheep and goat meat sector as from claim year 2015. This decreased to 21 Member States from claim year 2017, and it did not change from claim year 2019 following this review.
- Number of support measures (EU28): in comparison with the former support decision, it remained unchanged with **36 measures**, as from claim year 2019.
- Budget: The amounts earmarked decreased by some 10 % from EUR 586.3 million to EUR 535.8 million in claim year 2019, and from EUR 595.5 million to EUR 550.9 million in claim year 2020.

Though the sheep and goat meat sector has always been, and also remained after this review, the 3^{rd} biggest VCS beneficiary (after the beef and veal and the milk and milk products sectors), its share in VCS remained **below 13%**. This represents around **1.3%** of the annual national ceiling for all direct payments.

- Fixed number of heads (EU28): Remained unchanged at around 41.3 million heads.
- Per unit amount (prior estimate): The average unit amount of support slightly increased, from 12 EUR/head to **13 EUR/head** (EU28 average).

Reviewed measures:

- **New/deleted** measures: in comparison with the former support decision, France removed one support measure.
- **Modified** measures: Five Member States (Bulgaria, Greece, Hungary, France and Slovakia) carried out modifications of already existing measures. These changes concerned the eligibility conditions (Bulgaria, Hungary), the financial envelopes (Greece, France, Slovakia) and unit rates (France).

3.4 **Protein crops sector**

To recall, the Member States may increase their annual national ceiling for VCS by up to 2% if they decide to use at least 2% of their annual national ceiling set out in Annex II of the basic act to support the production of protein crops (Article 53(3) of the basic act).

VCS decisions in general⁹:

- Number of Member States: In the framework of the 'original support decisions', 16 Member States decided to grant such coupled support from claim year 2015. This decreased to 15 from claim year 2017, and it increased back to **16 Member States** from claim year 2019 following this review.
- Number of support measures (EU28): in comparison with the former support decision, it remained unchanged with 28 measures as from claim year 2019.
- Budget: The amounts earmarked increased by some 1% from EUR 469 million to EUR 474.3 million in claim year 2019 and from EUR 473.2 million to EUR 481.1 million in claim year 2020.

The protein crops sector has always been, and also remained after this review, the 4th biggest VCS beneficiary (after the animal-based sectors) and also the biggest area-based VCS beneficiary. Its share from VCS remained around 11%, which represents some 1.1% of the annual national ceiling for all direct payments.

- Fixed area (EU28): Decreased from 4.7 to 4.1 million ha.
- Per unit amount (prior estimate): Increased from the previous 99 EUR/ha to 116.5 EUR/ha (EU28 average).

Reviewed measures:

- New/deleted measures: Slovakia decided to create a new protein crops measure (with additional financing from the 2% top up possibility).
- Modified measures:
 - France modified three measures (financial envelopes, fixed area, unit amount, eligibility conditions, etc.).
 - o Spain modified the eligibility conditions of one measure.

3.5 Fruit and vegetables sector

VCS decisions in general¹⁰:

- Number of Member States: In the framework of the 'original support decisions', 19 Member States decided to grant such coupled support from claim year 2015. This remained unchanged under the following reviews up until this one.
- Number of support measures (EU28): in comparison with the former support decisions, it remained unchanged with **54 measures** as from claim year 2019.

Further details are available in Table 4 in the annex.

 Budget: The amounts earmarked decreased by some 4% from EUR 190 million to EUR 181.5 million in claim year 2019 and from EUR 187.4 million to EUR 179.9 million in claim year 2020.

The fruit and vegetables sector has always been, and also remained after this review, the 5th biggest VCS beneficiary and also the 2nd most important area-based beneficiary (after the protein crops sector). Its share from VCS decreased from 5% to **4.2%**, which represents some **0.4%** of the annual national ceiling for all direct payments.

- Fixed area (EU28): Decreased from 728 656 ha to 718 328 ha.
- Per unit amount (prior estimate): Decreased from the previous 259 EUR/ha to 251.5 EUR/ha (EU28 average).

Reviewed measures:

- New/deleted measures: Bulgaria created 2 measures and Slovakia 1 measure.
- Modified measures: Five Member States (Bulgaria, Greece, Hungary, Slovenia and Slovakia) carried out modifications of already existing measures. These changes concerned the measure name (Bulgaria), the eligibility conditions (Bulgaria, Greece, Hungary and Slovenia), the financial envelopes (Bulgaria, Greece and Slovakia), the unit rates (Bulgaria) and the fixed areas (Bulgaria).

3.6 Sugar beet sector

VCS decisions in general¹¹:

- Number of Member States: In the framework of the 'original support decisions', 10 Member States decided to grant such coupled support from claim year 2015. This increased to 11 Member States from claim year 2017, and remained unchanged from claim year 2019 following this review.
- Number of support measures (EU28): in comparison with the former support decision, it remained unchanged with **12 measures** as from claim year 2019.
- Budget: The amounts earmarked increased by some 3% from EUR 177 million to EUR 182.5 million in claim year 2019 and from EUR 170,8 million to EUR 173.4 million in claim year 2020.

The sugar beet sector has always been, and also remained after this review, the 6^{th} biggest VCS beneficiary and also the 3^{rd} most important area-based beneficiary. Its share from VCS decreased from 4.3% to **4%**, which represents some **0.4%** of the annual national ceiling for all direct payments.

- Fixed area (EU28): Decreased from 516 422 ha to **508 869 ha.**
- Per unit amount (prior estimate): Increased from the previous 343 EUR/ha to 350 EUR/ha (EU28 average).

Reviewed measures:

New/deleted measures: No new measures were created, nor any existing ones deleted.

• **Modified** measures: The changes concerned the financial envelopes (Greece, Italy, and Slovakia) and the fixed areas (Greece).

4 REVIEW OVERVIEW FOR THE REMAINING SECTORS¹²

Whereas the 6 biggest VCS sectors represent some 93% of all VCS allocations (EU28 average), the remaining 15 sectors represent only some 7%, i.e. 0.7% of the annual national ceiling for all direct payments.

In the framework of their 'original support decisions' as from claim year 2015, **13 Member States** decided to grant VCS for the benefit of one or more of the following sectors: cereals, oilseeds, grain legumes, flax, hemp, rice, nuts, starch potato, seeds, olive oil, silkworms and hops. No Member State decided to support the following sectors: short rotation coppice, dried fodder and cane & chicory.

This did **not change** from claim year 2019 following this review.

The changes concerned only the financial envelopes (Italy - olive oil, rice; Slovakia - hops) and the fixed areas (Greece - seeds, Italy - olive oil).

The share of annual direct payments amounts dedicated to these sectors also remains unchanged for claim years 2019 and 2020 following this review.
