#### **Foreword**

Dear Participant,

It is my pleasure to welcome you to the 3rd edition of the EU AgriResearch Conference. Your active participation is key to shape the future research agenda that will provide farmers, foresters and rural communities with the right knowledge, innovation and skills for sustainable horizons.

The event takes place in a changing context for agriculture, forestry and rural communities. They must become more productive, competitive, resilient and sustainable than ever before. Research and innovation (R&I) are key to drive that change. That is why the Common Agricultural Policy (CAP) and all major European Green Deal strategies, like the Farm to Fork and Biodiversity Strategies, the Forestry Strategy, the Soil Strategy and the Long-term Vision for Rural Areas all acknowledge the importance of R&I to achieve the ambitious EU policy targets and objectives.

The first edition of the EU AgriResearch Conference held in 2016 was instrumental to design our long-term strategic approach to EU agricultural research and innovation. Since then, the voices heard at the conference and its second edition have inspired and guided R&I programming in agriculture, forestry and rural areas at EU and Member States level. I am proud of what we have achieved together by mobilising the strengths of two flagship EU policies – the Horizon programmes and the Common Agriculture Policy. We have done this in particular by putting the end users right at the centre of R&I activities, co-creating solutions and exchanging knowledge with them, where they live and work, on farm, in forest and in rural villages. We have also pooled our forces in R&I partnerships with EU and associated countries, the private sector, foundations and other stakeholders to accelerate farming systems transformation. We focus on agroecology, on improvement of animal health and welfare, and on enhancing the potential of data and digital solutions in agriculture. We also have innovated the way we programme R&I by launching the Mission 'A Soil Deal for Europe' two years ago, with the ambition to establish 100 living labs with and lighthouses with more than thousand local experimentation and testing sites all over Europe to lead the transition towards healthy soils by 2030.

We took comprehensive action on R&I over the last decade and now we see the results on the ground: there are already plenty of innovative solutions and new knowledge ready to use in practice. Yet, the changing context continues to be a challenge, but also offers many opportunities to our farmers, foresters and rural communities. The stakes are high and we need to keep on delivering.

Today, we are halfway when it comes to the implementation of Horizon Europe – the most ambitious R&I programme in the history of the EU with unprecedented funding dedicated to agriculture, forestry and rural areas. We are also about to start discussions on the next EU R&I programme and the future CAP after 2027. It is, therefore, timely to showcase promising R&I solutions and resume the dialogue with you on the R&I priorities for the remaining years of Horizon Europe and beyond.

During the first day of this conference, we will look at the key challenges and opportunities for farmers, foresters and rural communities. We will concentrate on what R&I actions are needed to achieve the ambitions of the EU policies and the 2030 Agenda for Sustainable Development, and how to implement them to strengthen impact on the ground in the EU and globally. On that basis, we will discuss how we can pursue our goals in the next years, how we can further structure and organise our work to deliver more for society. This should be done in partnership with public authorities, international partners, primary producers and other businesses, local communities and all those active in the innovation ecosystems.

The second day will be dedicated to recap what we have achieved in the R&I policy for agriculture, forestry and rural areas so far. Building on that, we will reflect on concrete sectorial challenges with a systems perspective and co-create the priority R&I needs to address the environmental, social and economic sustainability challenges. We will certainly make the most of the opportunities that the innovation trends bring. Notably, we will co-design the paths to: sustainable management of natural resources, in particular through our Mission 'Soil Deal for Europe'; agrobiodiversity for healthy cropping systems; healthy and sustainable livestock systems; and multifunctional forests. Beyond this, we will look at the variety of skills, catalysers and tools that we can use to bridge the gap between science and practice and that can make a real difference on the ground. Attention will be given to digital and data technologies as well as social sciences. To ensure that no one is left behind, we will also delve into opportunities for rural communities to become stronger, connected, resilient and prosperous.

For the third day of the conference, we have organised field trips to visit six local innovation projects, so called EIP-AGRI operational groups, which we supported under the CAP. It will be a unique opportunity for you to experience how research and agricultural practice are working hand in hand for new innovative solutions and exchange directly with practitioners.

I am confident that these three stimulating days will be full of truly co-creative discussions and will generate new ideas on how EU R&I can accelerate the sustainability transitions in agriculture, forestry and rural areas. The conference is not the end, but rather a beginning for planning strategically the last years of Horizon Europe and paving way to the next EU R&I programme and CAP.

I am delighted that you have joined us. I look forward to welcoming you personally to the event and to your input to the discussions.
