




MONITORING EU AGRI-FOOD TRADE: DEVELOPMENTS JANUARY-AUGUST 2020



JANUARY - AUGUST 2020: EU27 AGRI-FOOD TRADE GROWTH SLOWS DOWN

During the first eight months of 2020, EU27 agri-food trade (exports plus imports) reached a value of **EUR 200.7 billion**; i.e. 1% more than in January-August 2019. EU27 exports increased by 1.2% compared to the corresponding period in 2019, reaching **EUR 119 billion**. EU27 imports attained **EUR 81.6 billion**, nearly 1% higher than the same eight months period in 2019. In regard to the developments from the previous month, in August the monthly values of EU27 exports fell by 12% after being on the rise since May (+7% in July and +3% in June), whereas the monthly value of EU imports also reported a major decrease (-10%) following a downward trend since April (-2% in July and -1% in June).

EU27 EXPORTS: FALLING EXPORTS TO THE UK AND THE US MITIGATED BY HIGHER SALES TO CHINA AND SOME NEIGHBOURHOOD COUNTRIES

On a year over year basis, the highest increases in export values (January-August 2020 compared to January-August 2019) continued to be recorded in trade with China (EUR +2 767 million, +33%). This has been driven by sustained tripled increase in EU27 export value of pig meat (This report does not yet account for developments in September when a first case of African Swine Fever was detected in Germany and from when on signs of decreasing exports have been emerging). Other products with highest gains in export values continued to be wheat (+ EUR 334 million representing 23% of the EU27 overall increase of its exports), offal meat (+21%), infant food (+13%), and barley (+70%). On the other hand, important decreases affecting the EU overall exports of these products were reported in sales of wine (-35%), spirits (-33%), cotton (-44%), and raw hides and skins (-49%).

Saudi Arabia (+537, +24%) came second with EU exports going back to its high level in 2018, boosted by increased trade particularly in barley, certain dairy products, cigars and cigarettes, and live animals.

Other top destinations, for which the value of EU27 agri-food exports have increased most since January 2020 (EUR million), remained to be reported for **Morocco** (+383, +34%) and **Algeria** (+345, +21%) - in both cases driven by increased exports of cereals (principally wheat) and, to some extent, of some dairy products (Algeria –milk and cream, Morocco- cheese and curd, butter and other fats). EU27 exports continued to increase significantly as well to Switzerland (+416, +7% - wide range of agri-food products).

For the first eight months of 2020, EU27 continued to record major export gains to Ukraine (+299, +20%), Nigeria (+225, +38%- wheat) and Norway (+209, +7%).



On the other hand, for the period January-August 2020, the EU27 export values continued to fall most to the **United States** (-692, -5%) compared to the same period in 2019, with sales falling most in August (-21%) since the beginning of 2020. The overall reduction was primarily driven by a significant fall in EU27 exports of spirits (-19%), and wine (-14%); each representing over 30% in the EU27 overall decrease in their exports.

Similarly, for the period January-August 2020, the EU27 export values to **the United Kingdom** (-329, -1%) continued to decline in comparison to January-August 2019, with a monthly decline of 8% in August compared to the previous month. Decreasing exports have been primarily driven by important drops in sales of wine (-10%), poultry meat (-13%), and butter (-37%). On the other hand, increased exports of product categories such as pasta and pastry (+7%), oilcakes (+55%), and wheat (+90%) partially compensated for these falls.

Other destinations, for which the value of EU27 agri-food exports have decreased most since January 2020 compared to the same period last year, remained to be Hong Kong (-326, -17%) and **Singapore** (-315, -24%) - in both cases, this was driven by reduced sales of wine and spirits. EU agri-food exports continued to fall significantly to Lebanon (-281, -43%), but as well to Japan (-150, -3%), India (-145, -28%), -54%) Indonesia (-145,and Thailand (-135, -17%).

The most important EU27 export destinations in the first eight months of 2020 were the UK, the USA, China, Switzerland and Japan. More than 52% of EU agri-food exports went to these five countries.

CONTINUED STRONG GROWTH OF EU27 EXPORTS OF CEREALS AND PIGMEAT UNTIL AUGUST 2020

Looking at product categories, the increase in export values (January-August 2020 compared to January-August 2019, EUR million) was driven by continued exceptionally high exports of **pig meat** (+1975, +45% - principally to China); **wheat** (+1449, +41%) and **coarse grains** (+390, +27%) following increased availability and strengthened international demand from the neighbourhood countries, but also to Africa and China. Other product categories that displayed solid growth rates include pet food (+353, +11%), pasta and pastry (+335, +6%), cigars and cigarettes (+322, +12%), rapeseed and sunflower oils (+320, +18%), and infant food (+266, +5%).


On the other hand, significant reductions in EU exports in value terms are to be noted in sectors most affected by decreasing trade with the US and the UK as well as by the economic crisis induced by the COVID-19 pandemic. Biggest losses continued to be reported in sales of **spirits and liqueurs** (-1295, -24%), **wine** (-1271, -13%), **raw hides and skins** (-640, -66%), cotton (-311, -36%), chocolate and confectionary (-268, -5%).

The top EU agri-food export products in the period January-August 2020 included wine, pig meat, infant food, pasta and pastry, as well as chocolate and confectionary. These products accounted for more than 26% of EU27 total agri-food exports.

STRONG INCREASE OF IMPORTS FROM INDONESIA AND MALAYSIA

During the first eight months of 2020, the value of EU27 agri-food imports has increased by nearly 1% (compared to January-August 2019). Over 60% rise of soya beans imports in value contributed to make Brazil (+623, +8%) the leading origin with the biggest increase in absolute terms. Canada (+590, +59%) came second with particularly high imports of rapeseeds (+205%) and wheat (+58%). Continued strong increase of palm oil further boosted imports from Indonesia (+592, +23%) and Malaysia (+387, +33%). Other origins for which the value of EU27 agri-food imports increased most included Turkey (+446, +17% nuts and citrus fruit, preparations of vegetables and fruit), Cote d'Ivoire (+241, +11% - cocoa beans), South Africa (+168, +13% -citrus fruit and fruit), Russian Federation (+162, +17%- sunflower seeds, oilcakes), and Morocco (+152, +9%- fruit and tropical fruit).

For the period January-August 2020, the value of monthly imports from the United Kingdom continued to fall most (-1033, -10%) compared to the same period in 2019. While decreasing imports from the UK have affected the majority of agri-food products, the highest loss in value was reported for spirits and liqueurs (-23%), accounting for 75% of the decrease in extra-EU imports of spirits and liqueurs. Other countries, for which EU27 imports decreased most in value terms, included Ukraine (-711, -16%; decline largely driven by falling imports of wheat, but imports of sunflower oil and oilseeds on rise); and the United States (-606, -9% - mainly driven by reductions in soya beans and oilcake imports). Decreasing imports continued to be also reported for India (-258, -14% - other feed and feed ingredients, oilcakes); Australia (-181, -17%; oilseeds, wool); Singapore (-119, -41% - malt extract; Nigeria (-106, -25% - cocoa beans) and Mexico (-96, -13% - beer, spirits, fruit).



The top EU agri-food origins in the eight months period include the UK, Brazil, USA, Ukraine and China. These countries have accounted for almost 38% of EU27 agri-food imports.

EU27 IMPORT INCREASE DRIVEN BY FRUIT, PALM OIL AND OILSEEDS

Looking at product categories, since the beginning of 2020, the highest increases in import values were reported for **fresh and dried tropical fruit** (+707, +8%), **palm and palm kernel oil** (+564, +17%), **fatty acids and waxes** (+504, +31%), fruit fresh and dried (+411, +10%), and oilseeds other than soya beans- mainly rapeseed and sunflower seeds (+366, +14%).

On the other hand, imports of **coarse grains** (-922, -30%), **oilcakes** (-464, -10%), **spirits and liqueurs** (-409, -19%), bovine meat (-265, -19%), wool and silk (-232, -36%) have continued to decrease most in value terms. Furthermore, EU27 import values of raw tobacco (-12%), meat preparations (-17%), and infant food (-14%) have remained on a downward trend.

The top EU agri-food import products in the first eight months of 2020 included fruit (tropical and other than citrus), unroasted coffee and tea, oilcakes, palm and palm kernel oil. These products accounted for nearly 32% of EU27 agri-food imports.

EXPANDING SURPLUS IN EU27 AGRI-FOOD TRADE

As a result, the agri-food trade surplus during the period January-August 2020 stood at EUR **37.4 billion**, an increase by 2% compared to the corresponding period in 2019, despite the Covid-19 crisis. This net trade balance remained boosted by continued strong exports of **pig meat**, **wheat** and **coarse grains**. It also mitigated the negative impact of decreasing exports of important product categories such as **wine**, **spirits**, **raw hides and skins**.
