Since 2001, he has been the general delegate of Freshfel Europe, the European association that represents the interests of the fresh fruit and vegetables sector. Freshfel has more than 200 members, consisting of associations and companies, throughout the fresh produce supply chain from production to retail. Besides Freshfel, he also has other responsibilities, such as secretary-general of the World Apple and Pear Association. This association brings together 18 leading apple and pear production countries around the world from the northern and southern hemispheres. Since 2019, he is also secretary-general of the World Citrus Organisation.

Jose Manuel Bisetto Pons comes from a small rural village called Benidoleig in the province of Alicante in Spain. In 2007, he decided to make a change in his professional and personal life and to follow the footsteps of his grandfather. Now he works in the agricultural sector, tending vegetable fields and making the transformation from conventional to organic farming. In this way, he wants to continue the work of his ancestors as farmers, with the aim to produce food - locally and respectfully, while ensuring its freshness and taste. He is therefore an advocate and reference in the territory for promoting a circular economy. In addition, he is teaching organic farming. He wants to pass this on to his daughter and other schoolchildren through the "EcoEscoles" project. This is a network of more than 140 schools that learn about organic farming

and sustainable food every day.

She is also an assistant professor at the Faculty of Health Sciences. From 2003 to 2010, she was head of the Health Promotion centre at the National Institute of Public Health in Slovenia. Since 2000, she was World Health Organisation (WHO)'s national counterpart for nutrition and she has been actively involved in subsequent years around WHO's work on obesity, physical activity, nutrition and inequality. She is also very active at EU level. She has participated in the work of HLG on nutrition and physical activity and was appointed as national representative in

the Steering group for the Evaluation of the EU Platform on Nutrition, Physical activity and Obesity in 2009/10, and as a member of the Steering group for the Evaluation of the EU White paper on nutrition 2007-13.

Sophie Hélaine is Head of Unit for Policy Performance in the Directorate General for Agriculture and Rural Developmen (Directorate General Agriculture and Rural Development) of the European Commission. For several years, she carried out the sanitary checks prior to the import of all kinds of food products from third countries, as well as the inspection of border control facilities. In 2016, she started working for the General Directorate for the Food Industry of the Spanish Ministry of Agriculture, Fisheries and Food (MAPA). Her work at MAPA relates to food consumption and trends, as well as food waste. She is currently in charge for managing the in-home and out-of-home food consumption and food waste panels, other studies on food uses and consumer trends, and the climate confidence

barometer of the agri-food sector. Moreover, she also helps to coordinate the School Fruit, Vegetables and Milk Scheme, and to promote food from Spain.

In the European Parliament, he is a member of the Committee on Agriculture and Rural Development and Committee on the Internal Market and Consumer Protection. He

is also co-chair of the European Parliament's Sports Group.

Sofie Verhoeven joined the City of Ghent's Environment and Climate department in 2014. As a participation expert, she facilitated and supported bottom-up initiatives for all climate-related themes (food, energy-efficient living, renewable energy, circular economy, etc.). Commissioner for Agriculture since 2019. He grew up on a farm in Rawa Mazowiecka, a rural community in central Poland. He holds a Master's degree in law, having graduated from the University of Łódź Department of Law and Administration. His professional career as a judge spanned different levels up to membership of the Supreme Court of Poland. From 1995 to 2001 he held the important post of President of the Polish Supreme Audit Office. From 2001 to 2004, he represented the Łódzkie constituency as a Member and also Vice-Marshal of the Parliament of the Republic of Poland – the Sejm. From June 2004 until May 2016, he served three terms as a Member of the European Parliament. He sat as a Member of the European Parliament's Intergroup on the Welfare and Conservation of Animals from his first term and from 2014 to 2016

he was President of the Intergroup. From May 2016 to November 2019, he was a Member of the European Court of Auditors. Commissioner Wojciechowski has been the author and co-author of five comments on the Polish Penal Code, as well as the author of more than 100 articles and publications on criminal law in various Polish legal magazines. He also writes on socio-legal issues.
