

The fruits are distributed on the 5 weekdays.	Supply: The schools are supplied at least once per week. Distribution: The distribution frequency to kids depends on the internal organisation of each school. (For 2022-2023 the participating schools had self-reported that 35.29% would distribute milk/milk products on 1 day/week: 4.71% on 2 days/week: 16.47% on 3 days/week: 1.18% on 4 days/week: and 42.35% on 5 days/week (a school week is equal to 5 days /week))

	School gardens	55 000	The project "Léieren am Gaart" designed to support schools setting up school gardens is supported by the ministries of agriculture, of education and of environment. In 22/23 this project covered 32 existing gardens in 32 schools (primary and secondary schools) across Luxembourg.  Beside this project, a large number of schools have their own garden or are maintaining fruit trees. This kind of educational gardening has been part of the normal curriculum for years. The exact number of existing school gardens is not known.					
	Visits to farms, dairies, famers' markets and similar activities	1 000	Schoolfruit 22/23: Visits to farms have been organized for 249 children, without financial aid from the program.  Additionally to these visits, many schools organized visits to farms by themselves. Exact numbers of participating children not known.					
Type of measure	Tasting classes, cooking workshops, other	39 500	Such activities take place in most of the preschools and in a larger number of primary schools without financial aid from the program. In the "Maisons relais" (drop-in centers) linked to primary education, pupils frequently have such activities outside the formal school hours. Exact numbers of children participating not known.
