International Rice Market:

No major developments as many traders await fresh harvests and demand has dropped since a few months. Vietnamese, Thai, Cambodian and Myanmar prices are high as supplies are tight and high domestic demand: low exports. Thai prices also high as lower harvest expected.

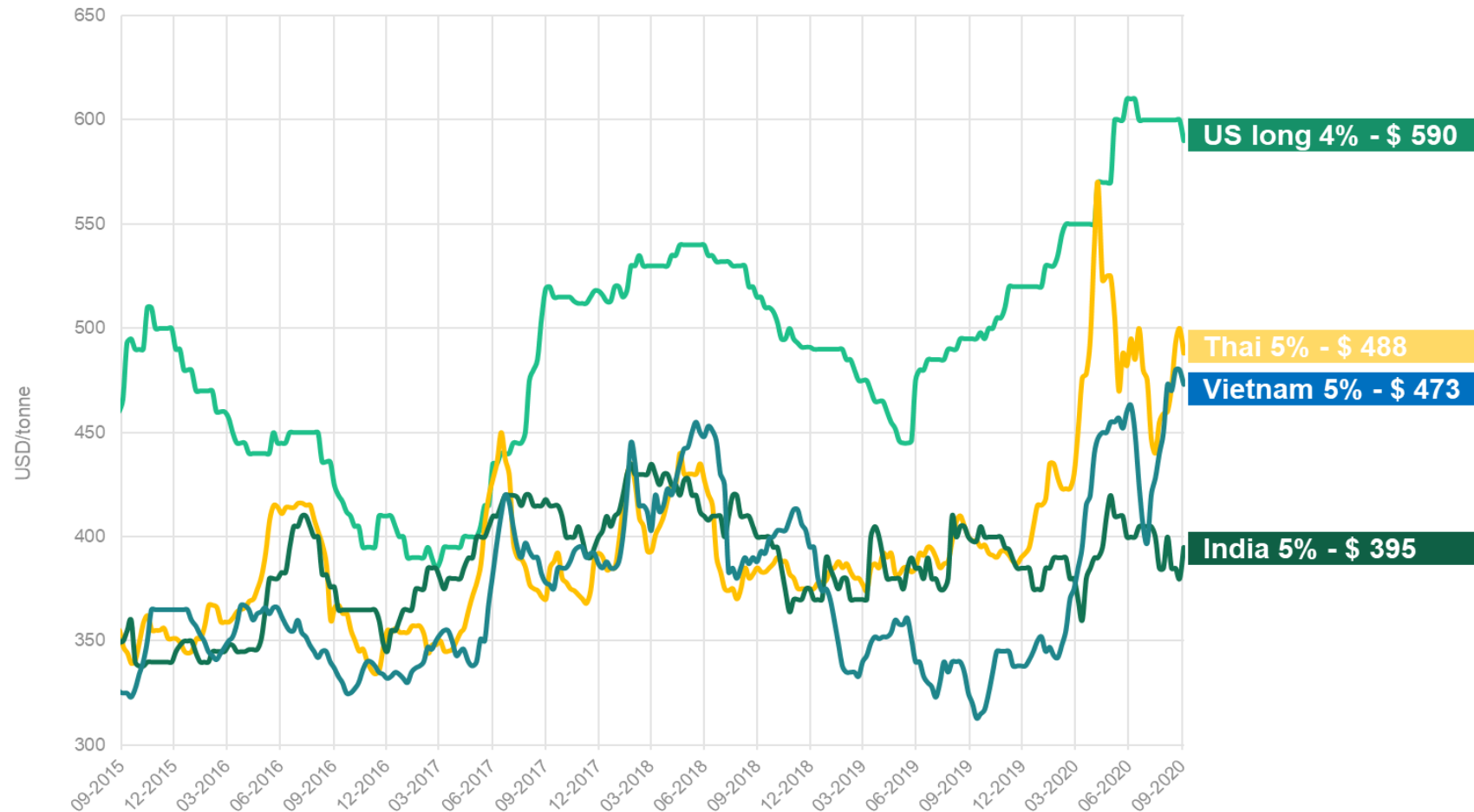

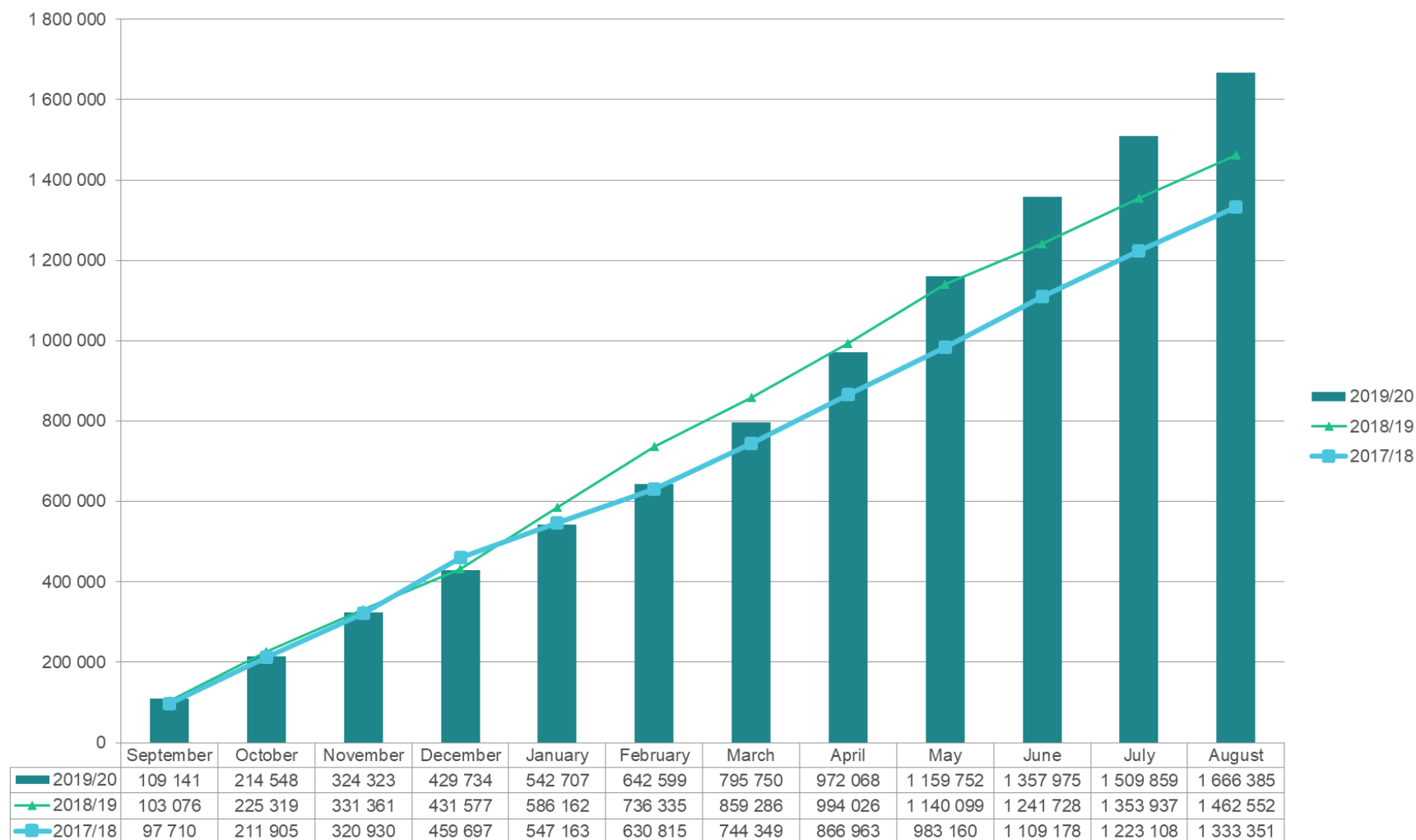
EU Rice trade:

August was another very strong month for imports as EU stocks are at low levels and EU mills were . Otherwise the activity on EU markets is seasonally low.

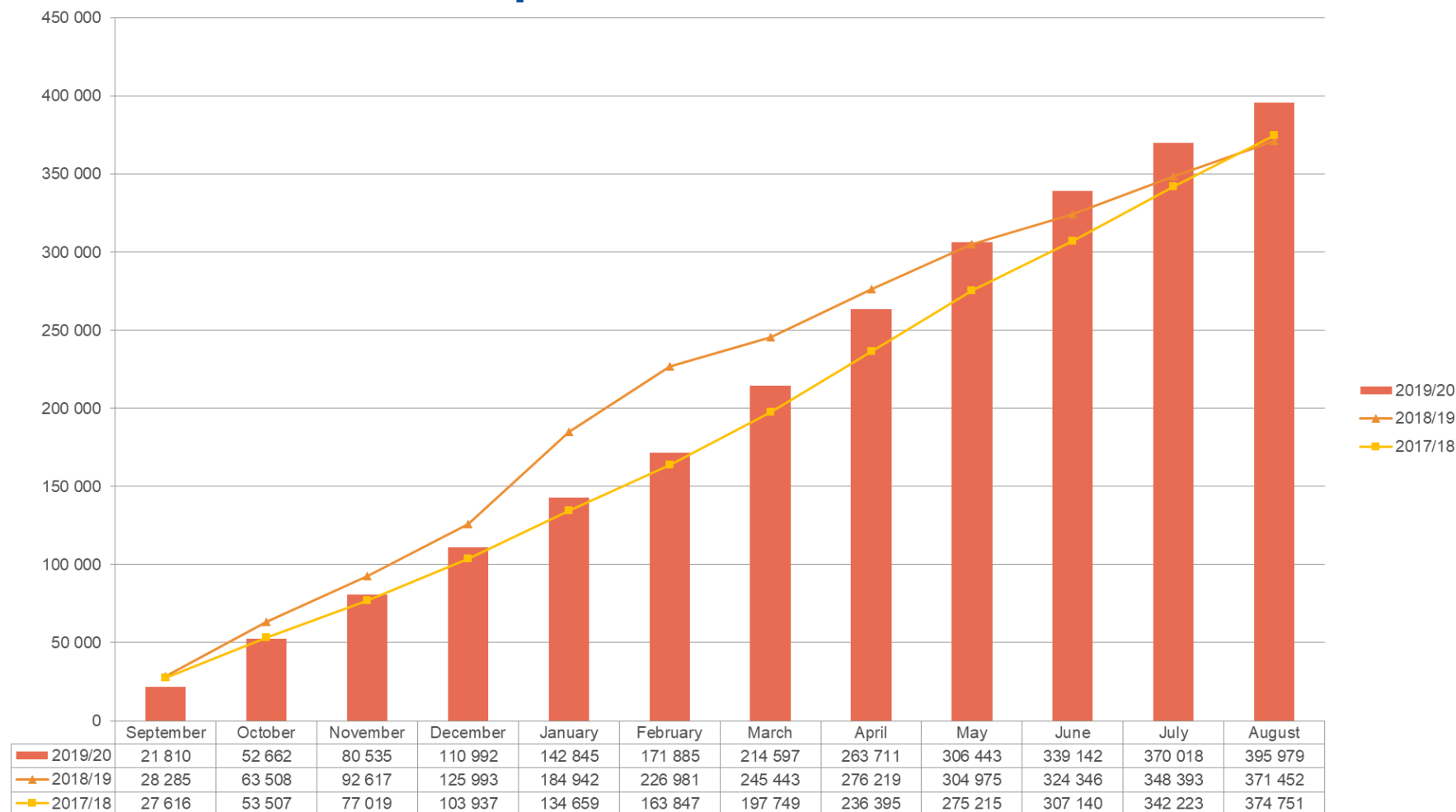

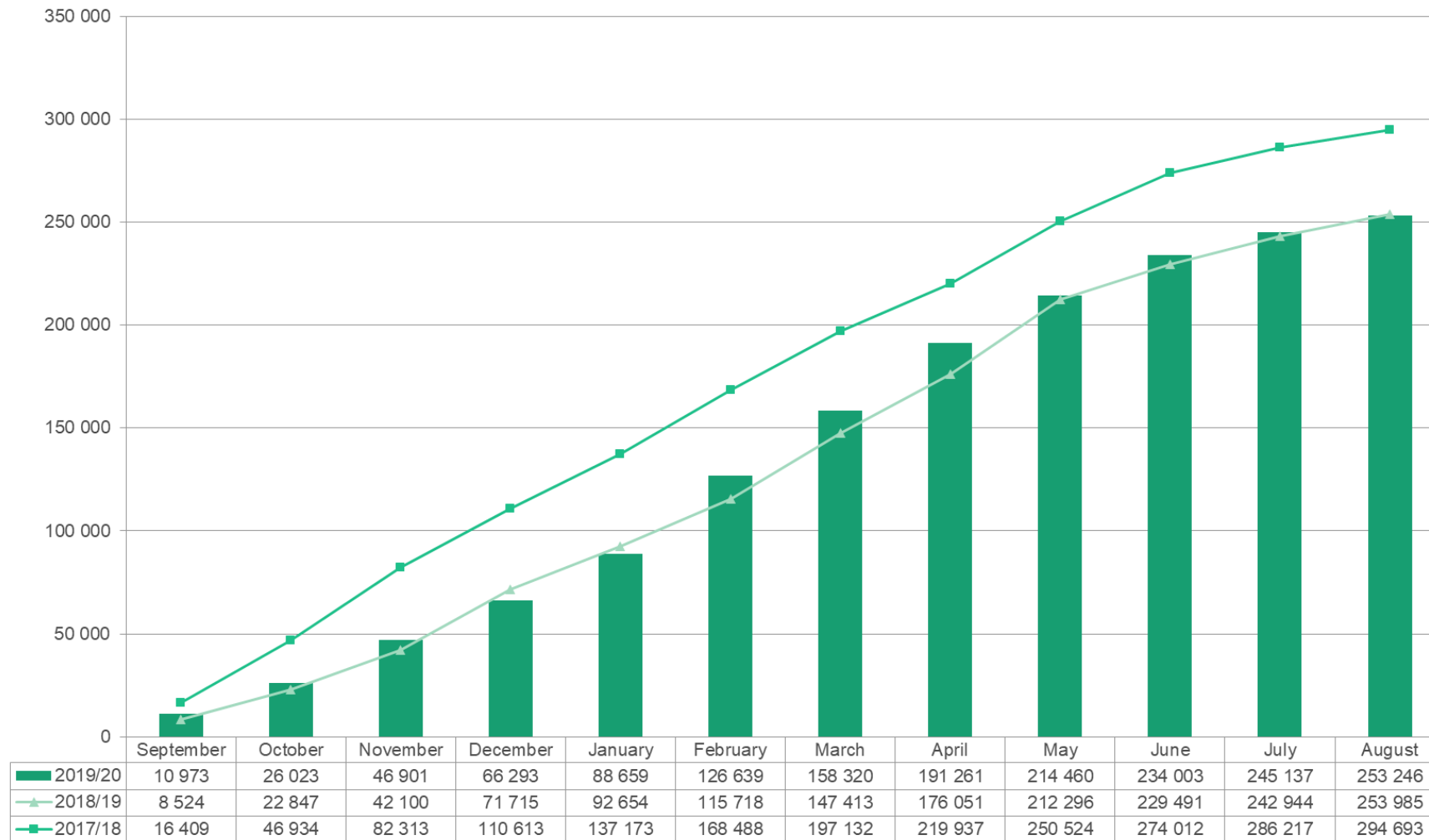
Total Rice Imports 2019/20: UP 14% vs 2018/19

Japonica and Indica Imports: Cambodia vs Myanmar

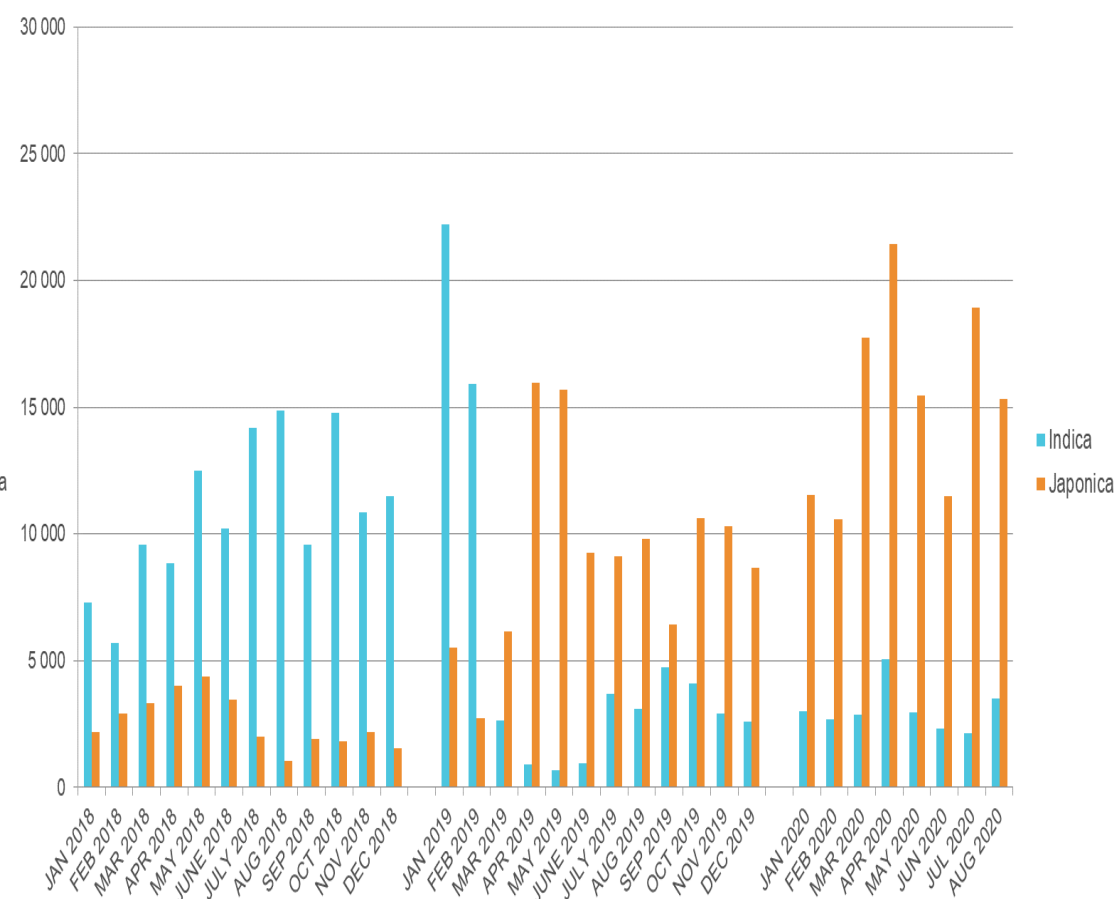
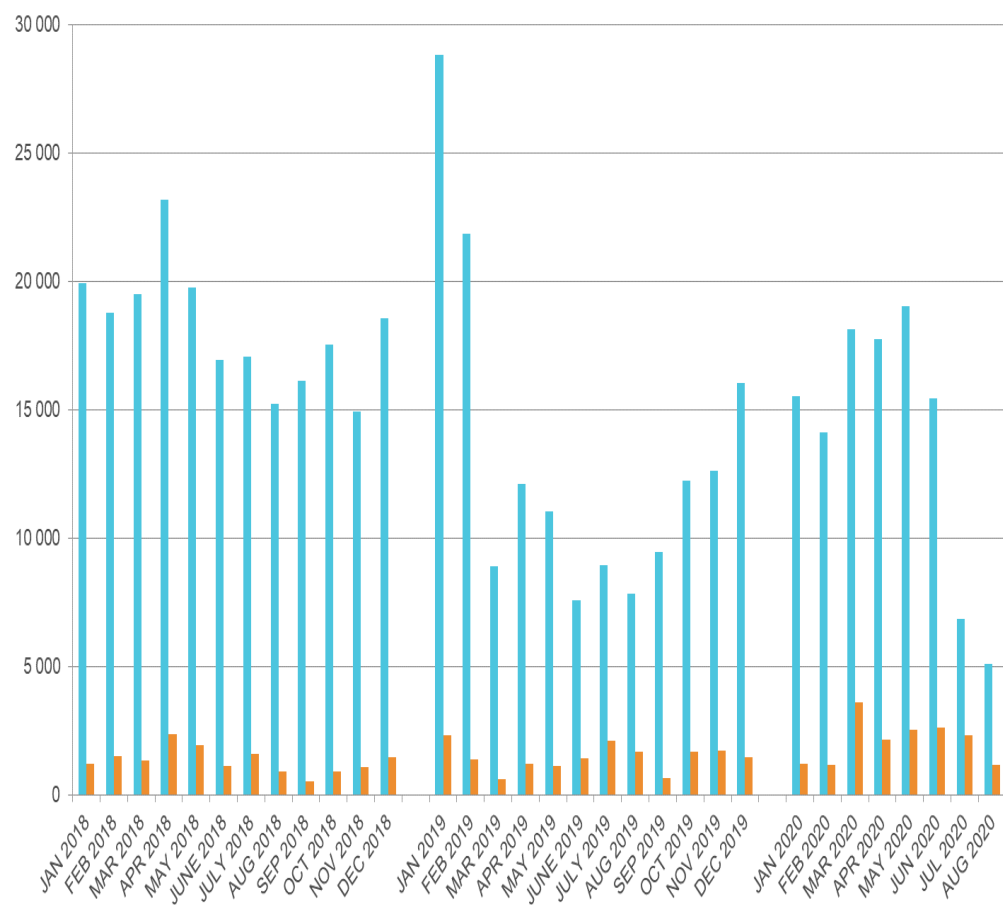

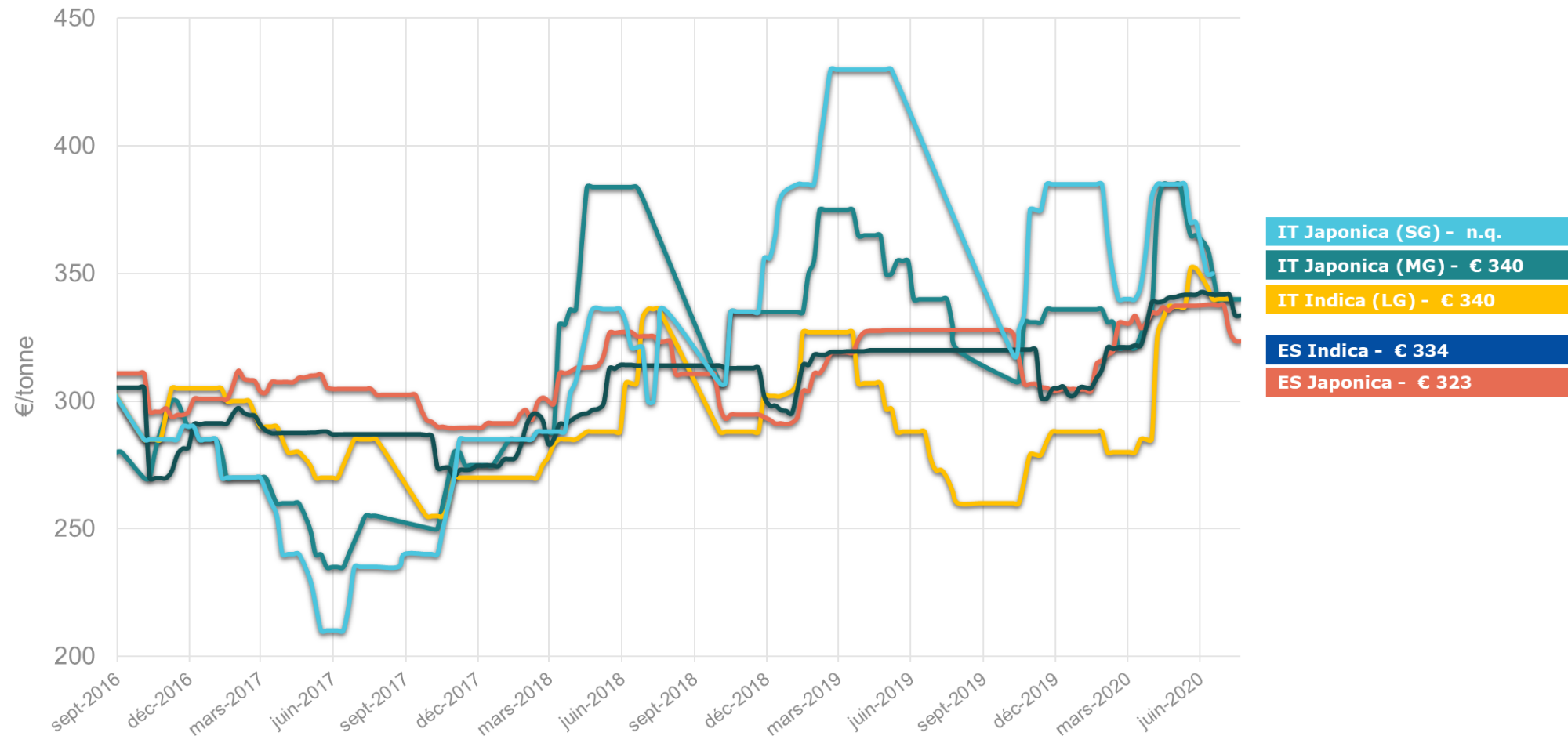

EU Rice Market:

Low activity as Italian market effectively closed in August. Imports supplying the EU market. Harvest to begin mid-September.

Husked Rice Import Duties – end of the MY review (CN 1006 20, excluding Basmati)

The import duties for husked rice has been changed to 65 EUR/tonne since 9 September 2020 (see Regulation (EU) No 2020/1259)

Rule: if the level of imports for the entire marketing year (1/9 – 31/8):

- is below 382 226 tonnes, the duty should be fixed at 30 EUR/tonne;
- exceeds 382 226 tonnes but is not higher than 517 130 tonnes, the duty should be fixed at 42,50 EUR/tonne;
- exceeds 517 130 tonnes, the duty should be fixed at 65 EUR/tonne.

From 01/09/2019 to 31/08/2020, import licences issued for husked rice (CN 1006 20, excluding Basmati) reached 650 037 tonnes for EU27 + UK.
