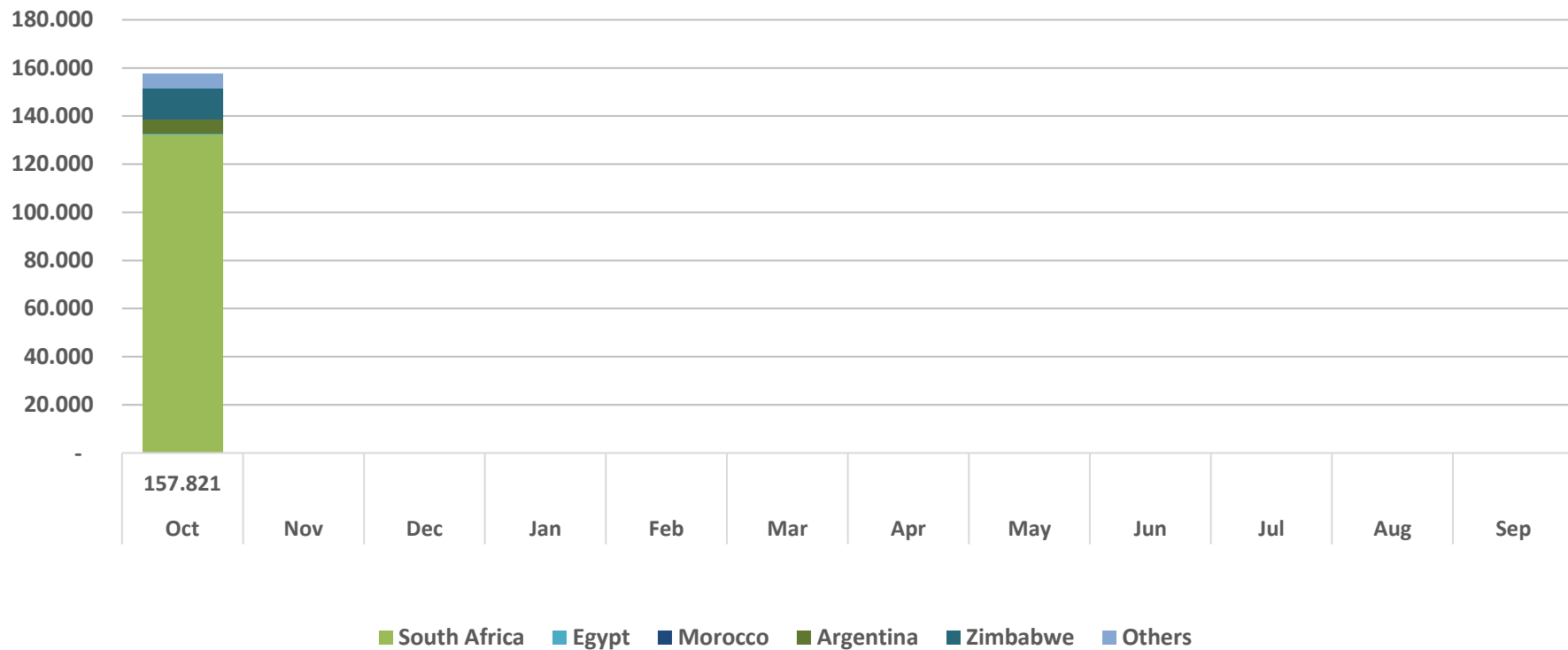


2022/23 EU monthly orange imports [tonnes]

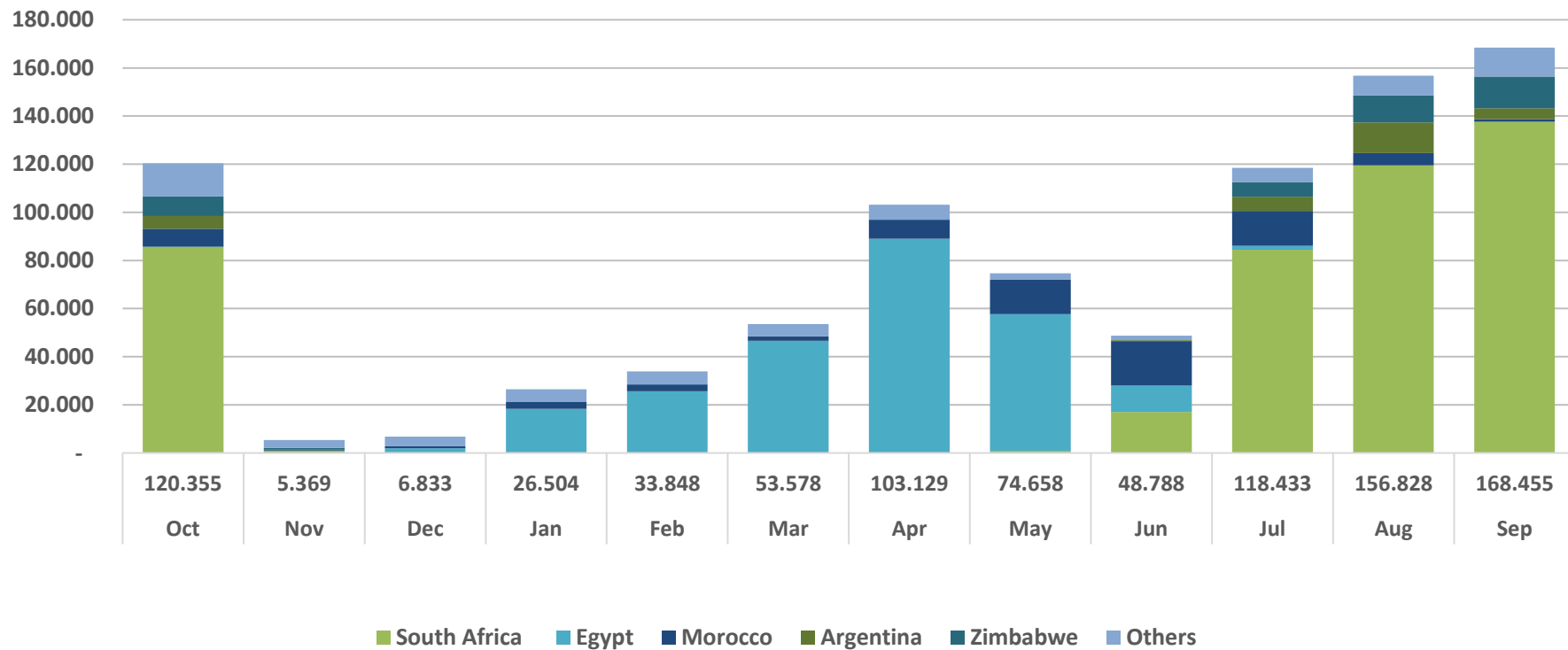

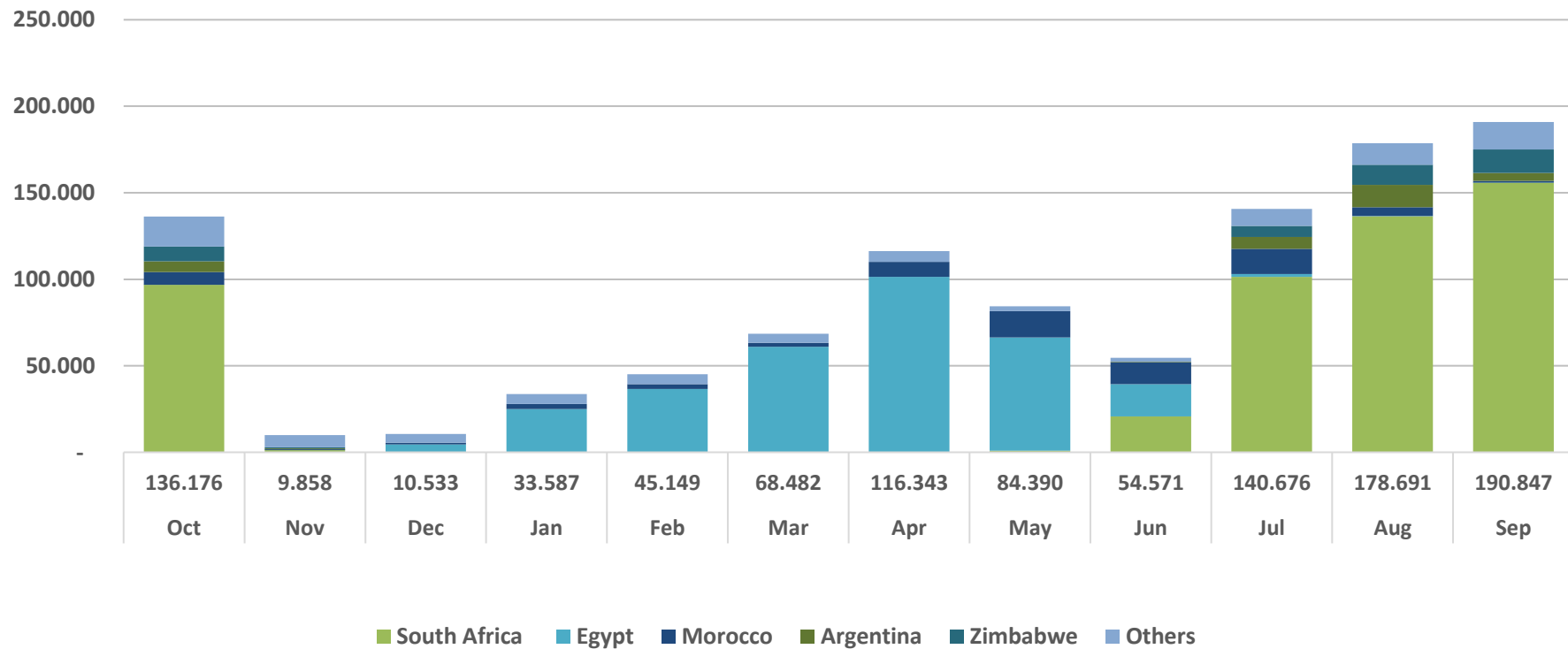
